These patients can receive all vaccines at their FQHC	<ul style="list-style-type: none"> Under-insured (FQHC) FQHC patient (under-insured) 	V05: VFC eligible – under-insured at FQHC/RHC All of the following are true: <ul style="list-style-type: none"> Client has insurance but insurance does not cover vaccines, limits the vaccines covered or caps vaccine coverage at a certain amount Client is receiving care at an FQHC, or RHC Client is < 19 years old The type of vaccine administered is eligible for VFC funding 	VXC50: Public Blended CVP

These vaccines are only available for patients in categories A, B, C, D, E, & F.	VXC50: Public Blended CVP PHC70: Private Privately purchased vaccine
