

## CT WiZ Onboarding Readiness Checklist

**In order to enter the HL7 Onboarding Registration Queue, you must meet all of the requirements below:**

Our organization/facility administers immunizations, and we have CVP pin numbers for all facilities that will be reporting through the interface.

If your office does not administer immunizations, you do not need to report any data to CT WiZ. If you need information about Meaningful Use (MU)/Promoting Interoperability (PI). Click on the link below to see details:
