AMENDED STATEMENT OF CHARGES

Pursuant to Connecticut General Statutes of §§19a-10, §19a-11 and 19a-14, the Department of Public Health ("Department") brings the following charges against Robban Sica, M.D.:

- 1. Robban Sica ("respondent") is, and has been at all times referenced in this Statement of Charges, the holder of Connecticut physician and surgeon license number 026453.
- 2. Respondent provided care to Patient 1 at various times from approximately 2002 through 2021.
- 3. On or about April 6, 2021, respondent issued a letter exempting Patient 1 from the "COVID vaccine or influenza vaccine" without clinical and/or medical justification.
- 4. On or about September 30, 2021, Patient 1 called respondent and left a message with respondent's office stating she had COVID-19. Respondent thereafter prescribed Ivermectin for Patient 1. Respondent's care for Patient 1 failed to meet the standard of care in one or more of the following ways, in that she:
 - a. failed to properly communicate with, interact, examine and/or assess Patient 1 prior to prescribing Ivermectin:
 - b. failed to properly treat Patient 1;
 - c. failed to obtain patient consent and/or properly inform the patient of the risks of using Ivermectin for treating COVID-19;
 - d. failed to refer her to an appropriate healthcare practitioner; and/or,
 - e. inappropriately prescribed Ivermectin and/or failed to prescribe appropriate medication.
- 5. On or more occasions while treating Patient 1, respondent maintained inappropriate and/or fraudulent medical records.
- 6. The above-described facts constitute grounds for disciplinary action pursuant to Connecticut General Statutes §20-13c, including but not limited to §20-13c(4).

WHEREFORE, the Department prays that:

The Connecticut Medical Examining Board, as authorized in §§19a-17 and 20-13c, revoke or order other disciplinary action against Robban Sica's physician and surgeon license as it deems appropriate and consistent with law.
