BOEN meeting 03/17/2021

Goodwin University:

As of May 1, 2021 Janice Watts will be retiring from her position as the Program Director and Associate Dean of Nursing and Health Professions at Goodwin University. Goodwin University is requesting approval of the appointment of **Mr. Bruce Hoffman, RN, MSN** as the Program Director and Associate Dean of Nursing and Health Professions at Goodwin University. Mr. Hoffman earned an Associate of Science in Nursing from Springfield Technical Community College in 06/2006, a Bachelor of Science in Nursing from Goodwin College (now Goodwin University) in 12/2013 and a Master of Science in Nursing Education from Western Governors University in 02/2016. His nursing clinical experiences include staff nurse, clinical educator, flight nurse at various acute care hospitals in Connecticut, Massachusetts, and Maryland from 2006 to present and nurse consultant for a charter school located in Massachusetts. His nursing educational experiences include instructor at Capital Community College, adjunct faculty at Stone Academy for the Medical Assistant program, on-line instructor for West Coast University, instructor for a Kaplan NCLEX test preparation course, on-line critical care educator, didactic, lab and clinical instructor at Springfield Technical Community College and Assistant Professor at Goodwin University. Mr. Hoffman has been in the role of Program Director and Associate Dean of Nursing and Health Professions at Goodwin University and has been receiving an orientation by Ms. Watts to this role.

Fairfield University:

The Department made a visit to Fairfield University on 03/03/2021 prior to the start of their Master's Entry to Practice Nursing (MEPN) pre-licensure program which was approved by the BOEN on 07/15/2020. The tour was led by the Dean, Dr. Meredith Wallace Kazer and Erica Wuchiski. During the tour it was identified that the pertinent Nursing Education Programs and Licensure Requirements, General (20-90-45 to 20-90-50) were met including: maintenance of a system of administrative records, physical facilities: a library with a dedicated librarian for the nursing programs, office spaces, conference rooms, an auditorium, a cafeteria, lounges, classrooms and nursing laboratories sufficient to meet the needs of the program, adequate clerical staff support and safeguarding student records/information. All of the facilities were equipped with advanced technology and a wide range of resources including the two nursing laboratories, simulation "suites" including two behavioral health "counseling suites", two "Operating Rooms", a "Labor & Delivery suite" a "pediatric suite" and clinical simulation areas to represent the health care continuum- a patient "home", 2 primary care provider offices and acute care health care "system" including a medication/supply room, debriefing rooms and patient care rooms where a variety of "patient simulators" were awaiting care and services.





I am pleased to offer you employment as a **Program Director** with the rank of **Assistant Professor** for the *Associates in Nursing* programs for the remainder of the three-semester academic year that began September 2020 and ends August 2021. This letter of agreement is provided to you along with access to the **Information Handbook for Faculty of Goodwin University**, which lists benefits, holidays, and other policies and procedures for faculty. The Handbook can be found on the Human Resources page of the Goodwin University Website, and at <https://goodwin.smartcatalogiq.com/2019-2020/Faculty-Handbook>. As explained in the Handbook, your employment with the University is considered at-will and may be terminated during your appointment in accordance with the terms described below in this letter.

As a Program Director, you will be expected to teach **3-6** credit/contact hours per semester as needed; however, you may be granted a reduction in load at the discretion of your Department Dean and with approval of the Provost; for example, for curriculum development. While you are not required to be on campus each day, you must be accessible Monday through Friday between 8:00 a.m. to 4:00 p.m., and available for scheduled meetings and other University events as needed during that time. You will be informed of your teaching assignments prior to the commencement of each semester. The Department Dean with approval of the Provost, may alter such assignments as the needs of the University may change.

The University values and rewards teaching excellence, service to the University and community, and participation in scholarly activities and professional growth. Instructional and other duties are outlined in the Handbook. These duties include, but are not limited to:

- Providing leadership in the University community;
- Participating in the accreditation processes as appropriate;
- Participating in the ongoing development and assessment of the curriculum;
- Overseeing the hiring and supervising of full-time and adjunct faculty;
- Assuring that all full-time faculty participate in governance and professional development activities;
- Keeping accurate department records;
- Posting and maintaining scheduled office hours which are a minimum of 6 office hours that consist of a campus presence two hours a day, three days a week, and additional hours by appointment.
- Providing academic advisement as appropriate;
- Participating in the report writing and approval processes;
- Participating in faculty and professional development programs;
- Assisting with extra-curricular activities;
- Attending graduation ceremonies;
- Collaborating with educational leaders from the community as well as other Universities and

- educational programs;
- Engaging in additional service and scholarship activities appropriate to the expectations related to your academic rank.

In accepting this appointment, the faculty member agrees to abide by and accept the University's employment policies, faculty policies, and rules and regulations of the University as are outlined in the ***Information Handbook for Faculty of Goodwin University***. Your compensation will be **\$91,000** less applicable state and federal tax deductions, shall be paid b-weekly in accordance with the University's regular payday practices. Should a payday fall on a weekend or holiday, you will be paid on the preceding weekday. Overload assignments beyond the standard course load, when deemed necessary by the University, will be paid above the agreed-upon yearly salary at the appropriate adjunct faculty rate.

This agreement may be terminated by either party at any time and for any reason by providing thirty (30) calendar days written notice to the other party. Should faculty resign, we ask that they give the supervisor as much notice as possible and include the effective date and the reasons for separation on the written resignation statement. Whenever possible, the departure should coincide with the conclusion of a University semester. Failure to comply with the resignation policy results in significant problems for students. Should Goodwin University provide such notice, it shall have the option of requiring the faculty member to continue to provide services during this thirty (30) day period or of terminating the faculty member's services immediately and paying his/her bi-weekly salary during this thirty (30) day period. Goodwin University may immediately terminate this Agreement during its term for poor performance, neglect of duties, or misconduct.



‘Simulation’ Criteria Guidelines Subcommittee Notes

Review NCSBN’s *Simulation Guidelines* Discussion

The subcommittee wanted it to be clear that what is being discussed is virtual clinical learning and not necessarily simulation a specific pedagogy that requires extensive lab resources and faculty expertise. In addition, these virtual learning experiences ‘rules’ are only permitted for the “...duration of the public health and civil preparedness emergency”[during the Covid pandemic].

Definitions:

SIMULATION: An activity or event replicating clinical practice using scenarios, high-fidelity manikins, medium- fidelity manikins, standardized patients, role playing, skills stations, and computer-based critical thinking simulations (Hayden, Jeffries, Kardong-Edgren, & Spector, 2009).

VIRTUAL CLINICAL LEARNING: (simulation) is a sophisticated computer based self-directed learning method In which the student relies on a two dimensional focused clinical experience to problem solve and apply clinical reasoning skills to lifelike clinical situations remotely through the use of video, media, and branching logic.

NOTE: Both simulation and virtual clinical learning require well planned activities by faculty members who are competent in these alternative and supportive methods.

PROGRAM: Any institution that includes a nursing ‘unit’ where there is a published nursing curriculum plan. The institution is responsible for providing the information needed for *Criterion one, three, four, and five*. However, for *Criterion two*, program refers to ‘sites’ as specified by their unique NCLEX designation.

As permitted in Commissioner Gifford's order dated August 14, 2020, Connecticut LPN programs may utilize up to 25% of their required clinical hours with virtual learning as outlined in the *NCSBN Simulation Guidelines for Pre-licensure Nursing Education Programs*.

Those criteria are discussed below.

#1: Overall number of clinical hours required by the program:

The Board will consider the documented required clinical learning for each program and designate the number of hours in each program allowed for virtual learning.

#2: NCLEX –PN Pass rates of students:

There will be no virtual clinical learning experiences allowed for any program that fails to meet the 80% NCLEX-PN pass rate or on Conditional Status.

#3: Availability of Clinical sites:

The Board will require a document that provides a comprehensive list of all facilities contacted and provide the explanation given for denial of securing clinical learning hours. This document will need to be submitted concurrently with documentation of clinical hours.

#4: Turnover of faculty/program director:

As recommended by NCSBN, a program that has had more than three directors/chairs/deans within the last 5 years (2016-2021) will have to submit documentation on why. In addition, the program administrator is required to submit an analysis and plan that addresses the turnover of leadership.

#5: Complaints from students:

The Board will review and assess the seriousness of any complaints made by students within the last five years (2015-2020) to either the Board, the Connecticut Department of Health, or the institution's accrediting organization.

#6: Retention rates:

The subcommittee determined retention rates will not be evaluated at this time.

MEMORANDUM OF DECISION

Procedural Background

On December 12, 2019, the Department of Public Health ("Department") filed a Statement of Charges ("Charges") with the Board of Examiners for Nursing ("Board"). Board ("Bd.") Exhibit ("Ex.") 1. The Charges allege violations of Chapter 378 of the Connecticut General Statutes of Connecticut ("Conn. Gen. Stat.") by Nicole Holiday ("Respondent") which would subject Respondent's advanced practice registered nurse ("A.P.R.N.") license number 005964 and registered nurse ("R.N.") license number 105959 to disciplinary action pursuant to Conn. Gen. Stat. §§ 19a-17 and 20-99(b)(6).

On February 24, 2020, the Charges and a Notice of Hearing were sent to Respondent by certified and first-class mail. Bd. Ex. 2.

On March 13, 2020, the Department sent Respondent a Revised Notice of the Hearing by first class mail and email, notifying Respondent of a new hearing location. Bd. Ex. 3.

On March 16, 2020, the Department filed a motion for a Request for Continuance. Bd. Ex. 4. The Board granted the motion. *Id.*

On June 8, 2020, the Department sent Respondent a Revised Notice of Hearing by email, notifying Respondent of a new hearing date set for June 17, 2020. Bd. Ex. 5. The Revised Notice of Hearing informed Respondent that the hearing would be held via video conference call. *Id.*

The hearing was held on June 17, 2020 via video conference. Respondent appeared at the hearing and was self-represented. Respondent orally answered the Charges on the record during the hearing. Transcript ("Tr.") pp. 5-7. Attorney Brittany Allan represented the Department. The record was closed at the end of the hearing. Tr. p. 16.

Each member of the Board involved in this decision attests that he/she was present at the hearing or has reviewed the record and that this decision is based entirely on the record, the law, and the Board's specialized professional knowledge in evaluating the evidence. *Pet v. Department of Health Services*, 228 Conn. 651 (1994).

Allegations

1. In paragraph 1 of the Charges, the Department alleges that Respondent of Woodstock Connecticut, is, and has been at all times referenced in the Charges, the holder of Connecticut registered nursing license number 105959 and advanced practice registered nursing license number 005964.
2. In paragraph 2 of the Charges, the Department alleges that Respondent suffers from opioid use disorder.
3. In paragraph 3 of the Charges, the Department alleges that in or around June 2017, Respondent fraudulently used the name and Drug Enforcement Administration (“DEA”) registration number of another nurse to call in prescriptions for her herself and/or for her husband.
4. In paragraph 4 of the Charges, the Department alleges that on or about July 18, 2017, as a result of an investigation by the Drug Control Division of the Department of Consumer Protection (hereinafter “Drug Control”), Respondent voluntarily surrendered her controlled substance registration, Controlled Substances Permit (“CSP”) .58835 and DEA registration MD3349520.
5. In paragraph 5 of the Charges, the Department alleges that Respondent’s abuse and/or excessive use of opioids does, and/or may, affect her ability to practice nursing.
6. In paragraph 6 of the Charges, the Department alleges that the above facts constitute grounds for disciplinary action pursuant to the General Statutes of Connecticut, §§ 20-99(b), including, but not limited to §§ 20-99(b)(2), 20-99(b)(5), and/or 20-99(b)(6).

Findings of Fact

1. Respondent, of Woodstock, Connecticut, is, and has been at all times referenced in the Charges, the holder of Connecticut R.N. license number 105959 and A.P.R.N. license number 005964. Bd. Ex. 1, p.3; Department ("Dept.") Ex. 1, p. 2; Dept. Ex. 2, p. 38; Tr. pp. 3-5.
2. Respondent suffers from an opioid use disorder. Dept. Ex. 1, p. 3; Dept. Ex. 1, p. 2; Tr. pp. 3-5.
3. On June 8, 2017, Respondent used A.P.R.N. April Davis’s name and DEA number to call in a prescription for Percocet for herself. Dept. Ex. 2, pp. 8-10.
4. On June 20, 2017, Respondent called Walmart Pharmacy in Rocky Hill, CT and used the name “April Davis, APRN” and Davis’s CSP to call in fraudulent prescriptions for Klonopin and Seroquel for Respondent and Ativan for Respondent’s husband. April Davis informed the pharmacist that she had not authorized the prescriptions for Respondent or the prescription for

Respondent's husband. Bd. Ex. 1, p. 3; Dept. Ex. 1, p. 2; Dept. Ex. 2, pp. 8-10; Dept. Ex. 4, pp. 152-160.

5. Klonopin is classified as a schedule 4 benzodiazepine-controlled substance which may be used for the treatment of anxiety or depression. Dept. Ex. 2, p. 8.
6. Seroquel is classified as a prescription antipsychotic medication which may be used for the treatment of schizophrenia or depressive episodes associated with bipolar disorder. Dept. Ex. 2, p. 9.
7. Ativan is classified as a schedule 4 benzodiazepine-controlled substance which may be used for the treatment of anxiety or depression. Dept. Ex. 2, p. 9.
8. On July 11, 2017, Respondent voluntarily surrendered her CSP registration and DEA registration. Dept. Ex. 2, pp. 39-40; Tr. p. 7.
9. Respondent's abuse and excessive use of opioids does, and/or may, affect her ability to practice nursing. Bd. Ex. 1; Dept. Ex. 2, p. 10.
10. On June 22, 2017, Respondent was suspended from employment pending investigation from the Drug Control Unit. Bd. Ex. 1, p. 3; Dept. Ex. 2, pp. 8-10; Dept. Ex. 4, pp. 154.

Discussion and Conclusions of Law

The Department bears the burden of proof by a preponderance of the evidence in this matter.

Jones v. Connecticut Medical Examining Board, 309 Conn. 727, 739-740 (2013). The Department sustained its burden of proof with regard to the allegations contained in the Charges. Findings of Fact (“FF”) 1-11.

Conn. Gen. Stat. § 20-99 provides, in pertinent part, that:

- (a) The Board . . . shall have jurisdiction to hear all charges of conduct which fails to conform to the accepted standards of the nursing profession brought against persons licensed to practice nursing. After holding a hearing . . . said board, if it finds such person to be guilty, may revoke or suspend his or her license or take any of the actions set forth in section 19a-17. . . .
- (b) Conduct which fails to conform to the accepted standards of the nursing profession includes, but is not limited to, the following: . . . (2) illegal conduct, incompetence or negligence in carrying out usual nursing functions; . . . (5) abuse or excessive use of drugs, including alcohol, narcotics or chemicals; (6) fraud or material deception in the course of professional services or activities; . . .

The Department submitted an investigative report dated June 5, 2019. Dept. Ex. 1. In addition, the Department submitted a Drug Control Report (“Drug Report”) dated July 27, 2017, detailing Drug Control Agent Scott L. Stoppa’s investigation of Respondent’s fraudulent use of the name “April

Davis, APRN" and Ms. Davis's CSP and DEA number to call in prescriptions for herself and/or her husband. Dept. Ex. 2. The Drug Report also included all of the following: copies of two prescriptions that a pharmacist had taken over the phone for Respondent, a brief write-up by the pharmacist as to what had occurred, Davis's statement that she had prepared and sent to Walmart Pharmacy, the surveillance video of Respondent at the prescription counter speaking with the pharmacist on June 20, 2017, and a copy of a report obtained from the Connecticut Prescription Monitoring Reporting System ("CTPMRS") listing prescriptions that had been processed for Respondent. Dept. Ex. 2. In addition, the Department submitted treatment records (Dept. Ex. 3) (under seal), the Rocky Hill Police Department's arrest warrants (Dept. Ex. 4), and the Judicial Website Case Detail Information. Dept. Ex. 5. The Board finds this evidence reliable and credible.

Respondent testified on her own behalf. Respondent admits that she is the holder of Connecticut R.N. license no. 105959 and A.P.R.N. license no. 005964. Tr. p. 5. Thus, the Department sustained its burden of proof with respect to this allegation in paragraph 1 of the Charges. FF 1.

With respect to the allegations contained in paragraph 2, Respondent admits that she suffers from opioid use disorder. Tr. p. 6. The Respondent's treatment records from the Intensive Outpatient Program she attended indicate that Respondent was diagnosed with opioid use disorder, moderate, generalized anxiety disorder, panic disorder and unspecified depressive disorder. Dept. Ex. 1, p. 2. (under seal). Thus, the Department sustained its burden of proof with respect to the allegation in paragraph 2 of the Charges. FF 2.

Although Respondent denied the allegations contained in paragraph 3 of the Charges (Tr. p. 6.), the Department met its burden of proof by a preponderance of the evidence with respect to these allegations. There is sufficient and credible evidence in the record that demonstrates that Respondent engaged in fraud or material deception in the course of professional services or activities. FF 3-7. According to Agent Scott L. Stoppa's investigative report, dated July 27, 2017 (Dept. Ex. 2), Respondent was the subject of a previous Drug Investigation. On June 8, 2017, Respondent used A.P.R.N. April Davis's name and DEA number to call in a prescription for Percocet for herself. Dept. Ex. 2, pp. 8-10. April Davis did not authorize this prescription. *Id.*

On June 20, 2017, Respondent called Walmart Pharmacy in Rocky Hill, CT and used the name "April Davis, APRN" and Davis's CSP to call in fraudulent prescriptions for Klonopin and Seroquel for herself and Ativan for her husband. Dept. Ex. 4, pp. 152-154. Shortly after the Respondent called the pharmacy, the pharmacist called April Davis asking her to verify that she had phoned in prescriptions for Respondent and Respondent's husband. *Id.* Davis informed the pharmacist that she had not authorized any prescriptions for Respondent or Respondent's husband. *Id.* Davis faxed a

hand- written statement to the Walmart Pharmacy stating that another APRN used her name and DEA number to prescribe medications. *Id.*

On the same day, surveillance video shows Respondent entering the Walmart Pharmacy and speaking with the pharmacist at the prescription counter. Dept. Ex. 2, pp. 17-19. According to Agent Stoppa's report, the pharmacist stated that he recognized Respondent's voice as the APRN who had called him earlier that day for prescriptions for Respondent and Respondent's husband, claiming to be April Davis. Dept. Ex. 4, p. 159. Respondent's history of issuing fraudulent prescriptions, and April Davis's written statement are entirely consistent with the Department's evidence establishing that Respondent used April Davis's name and DEA number to call in fraudulent prescriptions for herself and her husband. FF 4. The evidence clearly and conclusively established the allegations in paragraph 3 of the Charges. Thus, the Department satisfied its burden of proof with respect to the allegations in paragraph 3 of the Charges.

With respect to the allegations contained in paragraph 4 of the Charges, Respondent admits that she voluntarily surrendered her controlled substance registration, CSP .598835 and DEA registration MD3349520. Tr. p. 7. Thus, the Department sustained its burden of proof with respect to the allegation in paragraph 4 of the Charges. FF 8.

With respect to the allegations contained in paragraph 5 of the Charges, there is significant credible evidence in the record demonstrating that Respondent's abuse and/or excessive use of opioid does, and/or may, affect her ability to practice nursing. Dept. Ex. 2, pp. 8-10. Respondent was the subject of a previous Drug Control investigation. *Id.* On June 8, 2017, Respondent used April Davis's name and DEA number to call in a prescription for Percocet for herself. *Id.* A few weeks later, on June 20, 2017, Respondent called Walmart Pharmacy in Rocky Hill, CT and used the name "April Davis, APRN" and Ms. Davis's CSP to call in fraudulent prescriptions for Klonopin and Seroquel for herself and Ativan for her husband. Davis informed the pharmacist that she had not authorized the prescriptions for Respondent or the prescription for Respondent's husband. *Id.* Respondent has prescribed controlled substances for herself using another APRN's name and CSP number on at least two known occasions.

Klonopin is classified as a schedule 4 benzodiazepine-controlled substance which may be used for the treatment of anxiety or depression. Dept. Ex. 2, p. 8; FF 5. Seroquel is classified as a prescription antipsychotic medication which may be used for the treatment of schizophrenia or depressive episodes associated with bipolar disorder. Dept. Ex. 2, p. 9; FF 6. Ativan is classified as a schedule 4 benzodiazepine-controlled substance which may be used for the treatment of anxiety or depression. Dept. Ex. 2, p. 9; FF 7. Respondent was not authorized to prescribe these prescriptions.

According to the pharmacist, these three controlled substances produce a dangerous drug combination. Dept. Ex. 5, p. 159.

On June 22, 2017, Respondent's employer, the Connecticut Mental Health Specialists, decided to suspend Respondent from her employment pending further investigation. Dept. Ex. 2, p. 9. Shortly after Respondent was suspended from work, she voluntarily surrendered her CT CSP registration and DEA registration. Dept. Ex. 2, p. 9; Tr. p. 7; FF 4. Based upon Agent Stoppa's investigative report (Dept. Ex. 2) and the suspension of Respondent's employment (Dept. Ex. 2, p. 9; Tr. p. 7; FF 4), the Department sustained its burden of proof with respect to the allegation in paragraph 5 which asserts that Respondent's abuse and/or excessive use of opioid does, and/or may, affect her ability to practice nursing.

Reports from the Intensive Outpatient Program, part of the HAVEN program, demonstrate that Respondent has complied with her treatment plan and drug tests. Dept. Ex. 3 (under seal). Additionally, the Department believes that Respondent can return to work under monitoring terms. Tr. p. 15.

The Board concludes that Respondent's conduct, as alleged in the Charges, is proven by a preponderance of the evidence and that such violation constitutes grounds for disciplinary action pursuant to Conn. Gen. Stat. §§ 20-99(b)(2), 20-99(b)(5), and/or 20-99(b)(6). The Board finds that Respondent may resume her practice with reasonable skill and safety, under the terms of the following Order.

Order

Based on the record in this case, the above findings of fact and conclusions of law, the Board hereby orders, with respect to R.N. license no. 105959 and A.P.R.N. license no. 005964, held by Nicole Holiday, as follows:

1. Respondent's R.N. license No. 105959 and A.P.R.N. license No. 005964 shall be placed on probation for a period of four years under the following terms and conditions. The probation period may be extended for an additional two years, if the two years of practice monitoring are not completed concurrently with the four-year period of probation for Respondent's R.N. license and A.P.R.N. license as described in paragraph 2 below. If any of the conditions of probation are not met, Respondent's R.N. license and A.P.R.N. license may be subject to disciplinary action pursuant to Conn. Gen. Stat. § 19a-17.

2. In addition to Respondent's successful completion of four years of probation, following the reinstatement of Respondent's CSP or DEA license, Respondent shall obtain at her own expense, the services of an A.P.R.N. or M.D., pre-approved by the Department. Such A.P.R.N. or M.D. shall serve as a practice monitor ("practice monitor") for two years of probation. The practice monitor shall review up to 20% of Respondent's patient charts, on a quarterly basis, for the entire two-year probationary period. The practice monitor shall also submit such monitoring reports on a quarterly basis directly to the Department at the address cited in Paragraph N below. Respondent can satisfy the two-year practice monitor probationary period concurrent with the four-year probationary period of her RN license. If Respondent does not complete the two-year practice monitor probationary period during the four year probationary period of her R.N. and A.P.R.N.licenses, Respondent's probationary period shall continue for two additional years or until such time as her two year practice monitor probationary period is completed. If Respondent's practice monitor probationary period extends beyond the four year probationary period of her R.N. and A.P.R.N. licenses, none of the probationary terms other than those pertaining to the practice monitoring probationary period shall apply unless Respondent has not successfully satisfied those conditions during the four-year period of probation for her R.N and A.P.R.N. licenses.
 - A. During the period of probation, the Department shall pre-approve Respondent's employment and/or any change of employment within the nursing profession.
 - B. Respondent shall provide a copy of this Decision to any and all employers if employed as a nurse during the probationary period. The Department shall be notified in writing by any employer(s), within 30 days of the commencement of employment as to receipt of a copy of this Decision.
 - C. If employed as a R.N or as an A.P.R.N., Respondent shall cause employer reports to be submitted to the Department, by her immediate supervisor during the entire probationary period. Employer reports shall be submitted commencing with the report due on the first business day of the month following employment as a nurse. Employer reports shall be submitted monthly throughout the first and fourth year of the probationary period. Employer reports shall be submitted quarterly throughout the second and third year of the probationary period.
 - D. The employer reports cited in Paragraph C above shall include documentation regarding whether Respondent is able to practice nursing safely and competently. Employer

reports shall be submitted directly to the Department at the address cited in Paragraph N below.

- E. Should Respondent's employment as a nurse be involuntarily terminated or suspended, Respondent and her employer shall notify the Department within 72 hours of such termination or suspension.
- F. If Respondent pursues further training in any subject area that is regulated by the Department, Respondent shall provide a copy of this Memorandum of Decision to the educational institution or, if not an institution, to Respondent's instructor. Such institution or instructor shall notify the Department in writing as to receipt of a copy of this Decision within 15 days of receipt. Said notification shall be submitted directly to the Department at the address cited in Paragraph N below.
- G. Respondent shall provide a copy of this Decision to her therapist. The Department shall be notified in writing by her therapist, within 30 days of the effective date of this Decision, as to receipt of a copy of this Decision.
- H. Respondent shall cause evaluation reports to be submitted to the Department by her therapists during the entire probationary period. Therapist reports shall be submitted monthly for the first and fourth years of probation and quarterly during the second and third years of probation.
- I. Therapist reports cited in paragraph H above shall include documentation of dates of treatment and an evaluation of Respondent's progress, including alcohol and drug free status and Respondent's ability to safely and competently practice nursing. Therapist reports shall be submitted directly to the Department at the address cited in Paragraph N below.
- J. Observed random urine screens are subject to the following terms and conditions:
 - 1. At her expense, Respondent shall be responsible for submitting to observed, random, chain of custody screens for alcohol and drugs for the entire probationary period at a testing facility approved by the Department. Random alcohol/drug screens shall be legally defensible in that specimen donor and chain of custody can be identified throughout the screening process.
 - 2. Respondent shall be responsible for notifying the laboratory, her therapist, the Department, and prescribing practitioner of any drug(s) she is taking. For any prescription of a controlled substance(s) for more than two consecutive weeks, Respondent shall cause the provider prescribing the controlled substance(s) to

submit quarterly reports to the Department until such time as the controlled substance(s) is no longer prescribed. The reports shall include the following:

- a. A list of controlled substances prescribed by this provider for Respondent;
- b. A list of controlled substances(s) prescribed by other providers;
- c. An evaluation of Respondent's need for the controlled substances;
- d. An assessment of Respondent's continued need for the controlled substances.

3. There must be at least one random alcohol/drug screen weekly during the first and fourth years of the probationary period and at least two such random alcohol/drug screens per month during the second and third years of the probationary period.
4. Random/alcohol/drug screens shall be negative for the presence of alcohol and drugs. All urine screens for alcohol will be tested for Ethyl Glucuronide (EtG) and Ethyl Sulfate (EtS) metabolites. All positive screen results shall be confirmed by the Gas Chromatograph Mass Spectrometer (GC/MS) testing method. Chain of custody documentation must accompany all laboratory reports and/or the laboratory reports must indicate that chain of custody procedures have been followed.

5. Random alcohol/drug screens must include testing for the following substances:

Amphetamines	Methadone
Barbiturates	Methaqualone
Benzodiazepines	Opiates (Metabolites)
Cannabinoids (THC Metabolites)	Phencyclidine (PCP)
Cocaine	Propoxyphene
Meperidine (Demerol)	Ethanol (alcohol)
Fentanyl	Tramadol
Stadol	
6. Laboratory reports of random alcohol and drug screens shall be submitted directly to the Department, at the address cited in Paragraph N below, by Respondent's therapist, personal physician, or the testing laboratory.

K. Respondent shall not obtain for personal use and/or use alcohol or any drug that [§17] has not been prescribed for her for a legitimate purpose, by a licensed health care practitioner authorized to prescribe medications. Respondent shall not abuse and/or excessively use any drugs that are prescribed for a legitimate medical purpose.

- L. Respondent is hereby advised that the ingestion of poppy seeds may produce a positive drug screen result indicating the presence of opiates/morphine. The ingestion of mouthwash, over the counter cough suppressants, and cold/flu remedies may produce a positive result indicating the presence of alcohol. For that reason, any food substance containing poppy seeds, mouthwash, and over the counter cough suppressants and cold/flu remedies should be avoided during the probationary period. In the event that a drug/alcohol screen is positive for opiates/morphine and/or alcohol, the ingestion of poppy seeds, mouthwash, over the counter cough suppressants, and/or cold/flu remedies shall not constitute a defense to such positive screen.
- M. The Department must be informed in writing to any such change of address.
- N. All communications, payments if required, correspondence, and reports are to be addressed to:

- 3. Any deviation from the terms of probation, without prior written approval by the Board, shall constitute a violation of probation which will be cause for an immediate hearing on charges of violating this Order. Any finding that Respondent has violated this Order will subject Respondent to sanctions under Conn. Gen. Stat. § 19a-17(a) and (c), including but not limited to, the revocation of her R.N. license. Any extension of time or grace period for reporting granted by the Board shall not be a waiver or preclude the Board's right to take subsequent action. The Board shall not be required to grant future extensions of time or grace periods. Notice of revocation or other disciplinary action shall be sent to Respondent's address of record which is deemed to be the most current address reported to the Practitioner Licensing and Investigations Section of the Healthcare Quality and Safety Branch of the Department by the Respondent.
- 4. This document has no bearing on any criminal liability without written consent of the Director of the Medicaid Fraud Control Unit or the Bureau Chief of the Division of Criminal Justice's Statewide Prosecution Bureau.

This Order is effective on the date it is signed by the Board. The Board hereby informs Respondent, Nicole Holiday, and the Department of this decision.

MEMORANDUM OF DECISION

I

Procedural Background

On June 15, 2020, the Department of Public Health ("Department") filed a Statement of Charges ("Charges") with the Board of Examiners for Nursing ("Board"). Board ("Bd.") Exhibit ("Ex.") 1. The Charges allege that Laura Kisatsky ("Respondent") violated Chapter 378 of the Connecticut General Statutes ("Conn. Gen. Stat."). Such alleged violations would subject Respondent's registered nurse ("R.N.") license number E57105 to disciplinary action pursuant to Conn. Gen. Stat. §§ 19a-17 and 20-99(b)(5).

On June 15, 2020, the Department filed a Motion for Summary Suspension with the Board. Bd. Ex. 2. On June 17, 2020, the Board granted the Department's Motion for Summary Suspension. Bd. Ex. 3.

Based on the allegations in the Charges, the Board found that Respondent's continued nursing practice presented a clear and immediate danger to public health and safety. Accordingly, on June 17, 2020, pursuant to Conn. Gen. Stat. §§ 4-182(c) and 19a-17(c), the Board ordered that Respondent's R.N. license be summarily suspended pending a final determination by the Board of the allegations contained in the Charges ("Summary Suspension Order"). *Id.*

On June 19, 2020, Respondent was sent the Summary Suspension Order, Charges, and Notice of Hearing ("Notice") via Respondent's email address of record at laurakissky@yahoo.com. Bd. Ex. 4, 5.

On July 15, 2020, the hearing was convened. Tr. p. 2. Respondent failed to appear for the hearing and was not represented by an attorney. Tr. pp. 2-3. Attorney Joelle Newton represented the Department. Tr. p. 3. At the hearing, the Board concluded that the Department had made sufficient attempts to provide Respondent notice of the hearing. Tr. p. 4.

Respondent did not file an Answer to the Charges. *Id.* During the hearing, the Department orally moved to deem the allegations admitted (“Motion”), which the Board granted unanimously. Tr. p. 4.

II

Allegations

In paragraphs 1 and 6 of the Charges, the Department alleges that Respondent, of Cornwall, Connecticut is, and has been at all times, as referenced in the Charges, the holder of Connecticut R.N. license number E57105.

Count One

2. In paragraph 2 of the Charges, the Department alleges that on March 6, 2019, the Board ordered a Memorandum of Decision in Petition No. 2018-691 (“First Order”) based upon Respondent’s morphine abuse. The Order placed Respondent’s license on probation and required her (a) to submit to random urine screens, all of which must be negative; and, (b) prohibited her from obtaining and/or using controlled substances.
3. In paragraph 3 of the Charges, the Department alleges that on or about April 14, 2020, Respondent abused and/or utilized fentanyl and/or norfentanyl to excess while the terms and conditions of the First Order remained in full force and effect.
4. In paragraph 4 of the Charges, the Department alleges that Respondent’s abuse and/or utilization of fentanyl and/or norfentanyl to excess does, and/or may, affect her practice of nursing.
5. In paragraph 5 of the Charges, the Department alleges that the above facts constitute grounds for disciplinary action pursuant to Conn. Gen. Stat. § 20-99(b), including but not limited to § 20-99(b)(5).

Count Two

7. In paragraph 7 of the Charges, the Department alleges that on or about April 14, 2020, Respondent’s urine screen tested positive for fentanyl and/or norfentanyl while the terms and conditions of the First Order remained in full force and effect.
8. In paragraph 8 of the Charges, the Department alleges that on April 15, 2020, the Board ordered a Memorandum of Decision in Petition No. 2018-1416 (“Second Order”) based upon Respondent’s alcohol abuse. The Order, in part, required Respondent to submit to random urine drug screens.

9. In paragraph 9 of the Charges, the Department alleges that on May 7, 2020, May 12, 2020, May 22, 2020, and/or May 28, 2020, Respondent failed to submit to random urine drug screens while the terms and conditions of the Second Order remained in full force and effect.
10. In paragraph 10 of the Charges, the Department alleges that on or about April 14, 2020, Respondent's urine tested positive for fentanyl and/or norfentanyl.
11. In paragraph 11 of the Charges, the Department alleges Respondent's conduct as described above constitutes a violation of the First and Second Orders' probationary terms and subjects Respondent's license to revocation or other disciplinary action authorized by Conn. Gen. Stat. §§ 19a-17 and 20-99(b).

III

Findings of Fact

1. On June 19, 2020, the Department sent Respondent the Summary Suspension Order, Charges, and Notice of Hearing ("Notice") via Respondent's email address of record. Bd. Ex. 4, 5.
2. The correspondence that Department emailed to Respondent's email address of record at laurakissky@yahoo.com (Bd. Ex. 5) provided her sufficient notice of the hearing. Tr. p. 4.
3. On July 15, 2020, Respondent failed to appear at the hearing and had not requested a continuance. Tr. pp. 3-4.
4. Respondent did not file an Answer to the Charges. *Id.* During the hearing, the Department orally moved to deem the allegations admitted ("Motion"), which the Board granted unanimously. Tr. pp. 4-5.
5. The factual allegations contained in paragraphs 1 through 4 and 6 through 10 of the Charges are deemed admitted and true. Tr. pp. 4-5.

V

Discussion and Conclusions of Law

The Department bears the burden of proof by a preponderance of the evidence in this matter. *Jones v. Connecticut Medical Examining Board*, 309 Conn. 727, 739-740 (2013). The Department sustained its burden of proof regarding all of the allegations contained in the Charges.

Conn. Gen. Stat. § 20-99 provides, in pertinent part, that:

- (a) The Board . . . shall have jurisdiction to hear all charges of conduct which fails to conform to the accepted standards of the nursing profession brought against persons licensed to practice nursing. After holding a hearing . . . said board, if it finds such person to be guilty, may revoke or suspend his or her license or take any of the actions set forth in section 19a-17. . . .
- (b) Conduct which fails to conform to the accepted standards of the nursing profession includes, but is not limited to, the following . . . (5) abuse or excessive use of drugs, including alcohol, narcotics or chemicals; . . .

Pursuant to Conn. Gen. Stat. § 20-99(b) (5), a licensee whose conduct fails to conform to the accepted standards of the nursing profession including, but not limited to, abuse or excessive use of drugs, including alcohol, narcotics, or chemicals may, after a hearing, have his or her license revoked or suspended.

Since Respondent did not file an Answer to the Charges, the allegations are deemed admitted and true. *See*, Conn. State Agencies Regs § 19a-9-20.

The record establishes that on March 6, 2019, the Board issued a Memorandum of Decision in Petition No. 2018-691 (“First Order”) based upon Respondent’s morphine abuse. The First Order placed Respondent’s license on probation and required her to submit to random urine screens, the results of which were all required to be negative. The First Order also prohibited Respondent from obtaining and/or using controlled substances. The record also establishes that on April 14, 2020, Respondent abused and/or utilized fentanyl and/or norfentanyl to excess while the terms and conditions of the First Order remained in full force and effect.

The record further establishes that on April 15, 2020, the Board issued a Memorandum of Decision in Petition No. 2018-1416 (“Second Order”) based upon Respondent’s alcohol abuse. The Second Order required, among other probationary terms, that Respondent submit to random urine drug screens.

In an email dated April 24, 2020 sent by Respondent to the Department, Respondent denied that she used fentanyl¹ and stated that she had “decided against fighting the charge of a positive toxicology screen.” Department (“Dept.”) Ex. 1, pp. 1, 56-57 (under seal). She also stated that she could not go through the stress of a hearing. Dept. Ex. 1, p. 56 (under seal). The

¹ On May 21, 2020, toxicology reports establish that norfentanyl is a metabolite of fentanyl and a positive screening of norfentanyl is indicative of fentanyl use. Dept. Ex. 1, pp. 2, 49-50.

record establishes that on April 27, 2020, Respondent informed her testing monitor that she “was no longer going to do screening.” Dept. Ex. 1 pp. 1, 58.

Furthermore, the record establishes that on May 7, 2020, May 12, 2020, May 22, 2020, and/or May 28, 2020, Respondent failed to submit to random urine drug screens while the terms and conditions of the Second Order remained in full force and effect.

Therefore, based on the totality of the evidence in Respondent’s records of prior abuse of controlled substances and alcohol abuse, the Department has established by a preponderance of the evidence that Respondent’s controlled substance abuse and alcohol abuse does, and/or may, affect her practice as a nurse.

The above-described conduct fails to conform to the standards of the nursing profession outlined in Conn. Gen. Stat. § 20-99(b) (5). Thus, the Board concludes that Respondent’s above-described conduct, as deemed to be admitted and true, constitutes grounds for disciplinary action pursuant to Conn. Gen. Stat. §§ 20-99(b) (5) and 19a-17.² Revocation of Respondent’s license is an appropriate remedy.

V
Order

Based on the record in this case, the above findings of fact and conclusions of law, and pursuant to the authority vested in it by Conn. Gen. Stat. §§ 19a-17(a)(1), (2), and (5) and 20-99(b)(5), the Board finds that the conduct alleged and proven is severable and each Count warrants the disciplinary action imposed by this Order.

The Board orders that Laura Kisatsky’s license number E57105 to practice as a registered nurse in the State of Connecticut is hereby revoked.

This Order is effective on the date it is signed by the Board.

The Board hereby informs Respondent, Laura Kisatsky, and the Department of this Decision.

MEMORANDUM OF DECISION

I

Procedural Background

On May 7, 2020, the Department of Public Health ("Department") filed a Statement of Charges ("Charges") with the Board of Examiners for Nursing ("Board"). Board ("Bd.") Exhibit ("Ex.") 1. The Charges allege violations of Chapter 378 of the General Statutes of Connecticut ("Conn. Gen. Stat.") by Kimberly Lemire ("Respondent"), which would subject Respondent's registered nurse ("R.N.") license no. 155761 to disciplinary action pursuant to Conn. Gen. Stat. § 19a-17 and §§ 20-99(b)(2), 20-99(b)(6) and/or 20-99(b)(7).

On May 20, 2020, the Department filed a Motion for Summary Suspension Order ("Motion") regarding Respondent's practice and the active status of her R.N. license. Bd. Ex. 2. Based on the allegations in the Charges and the affidavits and reports accompanying the Motion, the Board found that Respondent's continued nursing practice presented a clear and immediate danger to public health and safety and on the same date, ordered pursuant to Conn. Gen. Stat. § 4-182(c) and § 19a-17(c), that Respondent's license be summarily suspended pending a final determination by the Board of the allegations contained in the Charges ("Summary Suspension Order"). Bd. Ex. 2.

On May 22, 2020, the Charges, Notice of Hearing ("Notice") and Summary Suspension Order were mailed to Respondent, by certified and first-class mail to her address of record on file with the Department—46 Reservoir Road, Pascoag, RI 02859. Bd. Ex. 3. On June 1, 2020, the United States Postal Service's tracking records document that a delivery attempt of the certified mail was unsuccessful and was returned to the Pascoag post office for redelivery or pickup. Bd. Ex. 40. Also, on May 22, 2020, the Charges, Notice, and Summary Suspension Order were transmitted to Respondent via her email address at kimberly.lemire@yahoo.com.

The hearing was held on June 17, 2020. Respondent was present at the hearing but was not represented by legal counsel. Attorney Joelle Newton represented the Department.

Inasmuch as Respondent did not answer the Charges within 14 days from the date of the Notice, Attorney Newton orally moved to deem the allegations admitted. Transcript (“Tr.”) p. 5. The Board denied the Department’s motion (Tr. pp. 5-6) and Respondent orally answered the Charges on the record. Tr. pp. 6-11.

Following the close of the record, the Board conducted fact finding.

Each member of the Board involved in this decision attests that he or she was present at the hearing or has reviewed the record, and that this decision is based entirely on the record, the law, and the Board’s specialized professional knowledge in evaluating the evidence. *Pet v. Department of Health Services*, 228 Conn. 651 (1994).

II
Allegations

1. In paragraph 1 of the Charges, the Department alleges that Respondent of Pascoag, RI¹, and has been at all times, as referenced in the Charges, the holder of Connecticut R.N. license number 155761.
2. In paragraph 2 of the Charges, the Department alleges that on various occasions between October 2018 and April 2019, while practicing nursing at Mount St. Rita Health Centre, Cumberland, Rhode Island,² Respondent:
 - a. failed to document completely, properly and/or accurately medical or hospital records, including, but not limited to, documenting withdrawal of controlled substance medications without corresponding documentation of administration and/or documenting the waste of controlled substances without a witness’s co-signatures;
 - b. failed to administer and/or document properly the administration of controlled substance medications to patients;
 - c. failed to waste controlled substance medications properly; and/or
 - d. falsified, maintained and/or improperly documented one or more Controlled Substance Disposition Records (“CSDR”).

¹ The Charges erroneously listed Watertown, CT as Respondent’s address. Respondent testified that she has never lived in CT. Tr. pp. 6-7.

² There is no evidence in the record that the allegations contained in the Charges pertaining to Respondent’s licensure and employment in Rhode Island facilities were subjected to any disciplinary action by Rhode Island’s duly authorized professional disciplinary agency. As such, the Board has no jurisdiction to take disciplinary action on Respondent’s Connecticut nursing license based on the alleged conduct in Rhode Island. Therefore, the allegations concerning Respondent’s nursing practice in RI facilities are dismissed and are not considered by the Board.

3. In paragraph 3 of the Charges, the Department alleges that on various occasions in September and/or October 2019, while practicing nursing at Bayview Health Care Center, Waterford, CT, Respondent:
 - a. failed to document completely, properly and/or accurately medical or hospital records;
 - b. failed to safeguard controlled substance medications appropriately in the medication cart; and/or
 - c. falsified, maintained and/or improperly documented one or more CSDRs.
4. In paragraph 4 of the Charges, the Department alleges that on various occasions between October and December 2018, while practicing nursing at Pine Grove Healthcare Center in Pascoag, RI,³ Respondent:
 - a. denied a patient pain medication after said patient reported that he was in pain and requested pain medication;
 - b. diverted Oxycodone from hospital stock;
 - c. failed to administer and/or document administration properly of controlled substances to patients;
 - d. falsified, maintained and/or improperly documented one or more CSDRs; and/or
 - e. failed to waste controlled substances properly.
5. In paragraph 5 of the Charges, the Department alleges that on various occasions between July 2017 and October 2018, while practicing nursing at Overlook Healthcare Center, Pascoag, RI⁴ Respondent:
 - a. failed to waste controlled substances properly;
 - b. falsified, maintained and/or documented one or more CSDRs improperly;
 - c. failed to waste controlled substances properly.
6. In paragraph 6 of the Charges, the Department alleges that on various occasions between October and November 2019, while practicing nursing at Villa Maria Nursing and Rehabilitation Center, in Plainville, CT, Respondent:
 - a. failed to administer and/or document properly administration of controlled substances to patients;
 - b. falsified, maintained and/or documented improperly one or more CSDRs;
 - c. failed to waste controlled substances properly;
 - d. failed to safeguard controlled substance medications appropriately; and/or
 - e. falsified a CSDR by signing another person's name as a witness to wasting controlled substance medication ("waste") when, in fact, the person whose name was signed did not witness the waste.

7. In paragraph 7 of the Charges, the Department alleges that in January 2020, while practicing nursing at Three Rivers Healthcare, in Norwich, CT, Respondent:
 - a. failed to safeguard controlled substance medications appropriately; and/or
 - b. falsified, maintained and/or documented one or more CSDRs improperly.
8. In paragraph 8 of the Charges, the Department allege that Respondent's practice of nursing falls below the standard of care in one or more of the following ways, including, but not limited to, practicing nursing in a substandard and/or careless manner.
9. In paragraph 9 of the Charges, the Department alleges that the above facts constitute grounds for disciplinary action pursuant to Conn. Gen. Stat. §§ 20-99(b)(2), 20-99(b)(6) and/or 20-99(b)(7).

III

Findings of Fact

1. Respondent of Watertown, CT⁵, has been at all times, as referenced in the Charges, the holder of Connecticut R.N. license number 155761. Tr. pp. 6-7.
2. On various occasions in September and/or October 2019, while practicing nursing at Bayview Health Care Center, Waterford, CT, Respondent:
 - a. failed to document completely, properly and/or accurately medical or hospital records;
 - b. to safeguard controlled substance medications appropriately in the medication cart; and/or
 - c. falsified, maintained and/or improperly documented one or more CSDRs.

Dept. Ex. 1, pp. 3-4, 7-8, 61-64.

3. On various occasions between October and November 2019, while practicing nursing at Villa Maria Nursing and Rehabilitation Center, in Plainville, CT, Respondent:
 - a. failed to administer and/or document properly administration of controlled substances to patients;
 - b. falsified, maintained and/or documented improperly one or more CSDRs;
 - c. failed to waste controlled substances properly;
 - d. failed to safeguard controlled substance medications appropriately; and/or
 - e. falsified a CSDR by signing another person's name as a witness to wasting controlled substance medication ("waste") when, in fact, the person whose name was signed did not witness the waste.

Dept. Ex. 1, pp. 8-11.

4. In January 2020, while practicing nursing at Three Rivers Healthcare, in Norwich, CT, Respondent:
 - a. failed to safeguard controlled substance medications appropriately; and/or
 - b. falsified, maintained and/or documented one or more CSDRs improperly.

Dept Ex.1, pp. 12-13 32-33.

5. Respondent's practice of nursing falls below the standard of care in one or more of the following ways, including, but not limited to, practicing nursing in a substandard and/or careless manner.

IV

Discussion and Conclusions of Law

The Department bears the burden of proof by a preponderance of the evidence in this matter. *Jones v. Connecticut Medical Examining Board*, 309 Conn. 727, 739-740 (2013).

The Department sustained its burden of proof with regard to all of the allegations contained in the Charges.⁶ Findings of Fact ("FF") 1-5.

Conn. Gen. Stat. § 20-99 provides, in pertinent part, that:

- (a) The Board . . . shall have jurisdiction to hear all charges of conduct which fails to conform to the accepted standards of the nursing profession brought against persons licensed to practice nursing. After holding a hearing . . . said board, if it finds such person to be guilty, may revoke or suspend his or her license or take any of the actions set forth in section 19a-17
- (b) Conduct which fails to conform to the accepted standards of the nursing profession includes, but is not limited to, the following: . . . (2) illegal conduct, incompetence or negligence in carrying out usual nursing functions; . . . (6) fraud or material deception in the course of professional services or activities; (7) willful falsification of entries in any hospital, patient or other record pertaining to drugs, the results of which are detrimental to the health of a patient;

Respondent denied all of the allegations in the Charges. Tr. pp. 6-11. However, despite Respondent's denials, the Department established by a preponderance of the evidence that Respondent's conduct failed to conform to the accepted standards of the nursing profession in one or more ways, as discussed below.⁷

With respect to the allegations contained in paragraph 3 of the Charges, the Department sustained its burden of proof. The Department established by a preponderance of the evidence

that on various occasions between September and/or October 2019, while practicing nursing at Bayview Health Care Center in Waterford, Connecticut (“Bayview”), Respondent failed to conform to the accepted standards of the nursing profession. The record establishes that on September 18, 2019, Respondent began her employment at Bayview; and, on September 23, 2019, Respondent was given unsupervised access to controlled substances in the Niantic Bay Nursing Unit at Bayview. On October 2, 2019, three blister cards of controlled substances (hydrocodone/acetaminophen and oxycodone) along with the corresponding CSDRs were discovered missing when there was a shift change. Dept. Ex. 1, pp. 3-4, 7, 61. After Respondent’s last scheduled shift on October 2, 2019, there were no more missing blister cards. Dept. Ex. 1, p. 4.

With respect to the allegations contained in paragraph 6 of the Charges, the Department sustained its burden of proof. The Department established by a preponderance of the evidence that on various occasions between October and November 2019, while practicing nursing at Villa Maria Nursing and Rehabilitation Center, in Plainville, Connecticut (“Villa Maria”), Respondent failed to conform to the accepted standards of nursing. On October 14, 2019, the Director of Nursing hired Respondent to work at Villa Maria. On November 11, 2019, Respondent worked a double shift, starting with the third shift on November 11, 2019 and ending after the first shift on November 12, 2019. On November 26, 2019, a licensed practical nurse discovered that her name was forged as a witness to Respondent’s wasting an oxycodone pill on November 11, 2019. Dept. Ex. 1, p. 8. On November 26, 2019, the Director of Nursing placed Respondent on suspension because at least 26 tablets of an oxycodone prescription that was filled on November 24, 2019 were missing. Dept. Ex. 1, p. 9.

With respect to the allegations contained in paragraph 7 of the Charges, the Department sustained its burden of proof. The Department established by a preponderance of the evidence that from the third shift on January 21, 2020 through the first shift on January 22, 2020, Respondent worked at the Three Rivers Healthcare in Norwich, Connecticut (“Three Rivers”). Dept. Ex. 1, pp. 12-13, 33. On January 22, 2020, Respondent signed for a prescription of 30 oxycontin tablets. Dept. Ex. 1, p. 13. On January 24, 2020, a new resident was admitted for which oxycontin was prescribed. Dept. Ex. 1, pp. 13, 32. The oxycontin tablets could not be located. Dept. Ex. 1, pp. 13, 32-33. On January 27, 2020, prescriptions for oxycodone and hydrocodone were missing. Dept. Ex. 1, p. 32. On January 28, 2020, the Director of Nursing

discovered that all 30 oxycontin tablets that were received on January 22, 2020 were missing. All corresponding documentation pertaining to these prescriptions were also missing. Dept. Ex. 1, p. 13.

The Department established by a preponderance of the evidence that Respondent's practice of nursing falls below the standard of care in one or more ways, including, but not limited to practicing nursing in a substandard and/or careless manner. Thus, the Board concludes that Respondent's conduct, as alleged in the Charges and constitutes grounds for disciplinary action pursuant to Conn. Gen. Stat. §§ 20-99(b)(2), (6) and (7), and § 19a-17.

Order

Based upon the record in this case, the above findings of fact and the conclusions of law, and pursuant to the authority vested in it by Conn. Gen. Stat. §§ 19a-17 and 20-99, the Board finds that the misconduct alleged and proven in Petition No. 2019-1237 is severable and that each allegation of misconduct alleged and proven warrants the disciplinary action imposed by this order. The Board orders that Kimberly Lemire's license number 155761 to practice as a R.N. in the State of Connecticut is hereby revoked.

This Order is effective on the date it is signed by the Board.

The Board hereby informs Respondent, Kimberly Lemire, and the Department of this decision.

PREHEARING REVIEW COVER SHEET

In re: Azra Sarkinovic, R.N.

Petition No. 2019-417

1. Azra Sarkinovic of Fairfield, Connecticut (hereinafter "respondent") was issued license number 143090 to practice as a registered nurse on July 7, 2017.
2. Respondent graduated from Norwalk Community Technical College – ADN in 2017.
3. Respondent has no disciplinary history.
4. The Department's Practitioner Licensing and Investigations Section opened this petition after receiving a referral from the Department's Facility Licensing and Investigations Section involving an incident that occurred on March 17, 2018 at Ludlowe Center for Health & Rehabilitation ("the facility"), a long-term care facility.
5. The Department alleges that on March 17, 2018, respondent failed to follow the standards of practice while inserting an indwelling catheter for a resident. Subsequently, the resident was admitted to the hospital with a diagnosis of acute blood loss anemia and traumatic hematuria. Upon admission to the hospital, a CT scan revealed the Foley catheter balloon to be in the bulbar urethra, not the bladder. In an interview with FLIS investigators, respondent could not recall meeting any resistance when inserting the Foley catheter. The Director of Nurses (DON) indicated to FLIS investigators that when she spoke to respondent about the catheterization, respondent indicated she had met resistance. The DON identified that although the facility Foley catheter policy does not include information on what to do if resistance is met, the standard of practice is to stop the procedure and call the physician. The DON further identified that respondent was re-educated and completed a competency on indwelling catheter insertion on 4/18/18.

In a notarized statement dated 10/24/19, the DON indicated that respondent shared with the DON that she "had threaded the catheter may have met very slight resistance but was minor and did not warrant stopping the procedure." The DON further indicated in her notarized statement that when she spoke to respondent "at a later date she stated she did not have any resistance when inserting the catheter."

6. Respondent denies the allegations and has indicated that she used standard technique to catheterize the resident and that she did not encounter any untoward results or complications.
7. The Department and respondent respectfully request that the Board review the attached documents and provide a recommendation regarding this matter.

2. Respondent graduated from Capital Community College in 2011.
3. Respondent has no history of disciplinary actions.
4. At all relevant times, respondent was employed as a registered nurse at Whiting Forensic Hospital, located on the campus of Connecticut Valley Hospital in Middletown, Connecticut.
5. The Department alleges that at various times between approximately March 3, 2017 and March 21, 2017, respondent failed to meet the standard of care when he failed to intervene and/or report to his nursing supervisor when he observed staff members physically abusing Patient #1 and/or failing to follow the plan of care for Patient #1; and when he failed to follow the plan of care for Patient #1 which required that he and another male staff member maintain constant observation of Patient #1.
6. The proposed Consent Order requires 1) a reprimand; 2) a civil penalty of \$1500.00; 3) a two-year probation; 4) written reports from his employer monthly for the entire probationary period; 5) no solo practice during the probationary period; and 6) coursework in nursing awareness of patients with mental health issues including autism spectrum disorder and personality disorder; coursework containing a review of mandatory reporter laws, including reportable incidents and definition of abuse of patients with mental illness; coursework in ethics; and coursework in patient dignity. Respondent and the Department respectfully request that the Board of Examiners for Nursing approve and accept this Consent Order.

CONSENT ORDER

WHEREAS, Christian Todzia (hereinafter "respondent") of Berlin, Connecticut, has been issued license number 100904 to practice as a registered nurse by the Connecticut Department of Public Health (hereinafter "the Department") pursuant to Chapter 378 of the General Statutes of Connecticut, as amended; and,

WHEREAS, the Department alleges that:

1. At all relevant times, respondent was employed as a Forensic Nurse at Whiting Forensic Hospital, located on the campus of Connecticut Valley Hospital in Middletown, Connecticut.
2. At various times between approximately March 3, 2017 and March 21, 2017, respondent failed to meet the standard of care in one or more of the following ways:
 - a. he failed to intervene and/or report to his nursing supervisor when he observed staff members physically abusing Patient #1 and/or failing to follow the plan of care for Patient #1; and
 - b. he failed to follow the plan of care for Patient #1 which required that he and another male staff member maintain constant observation of Patient #1.
3. The above-described facts constitute grounds for disciplinary action pursuant to the General Statutes of Connecticut, §20-99(b), including but not limited to §20-99(b)(2).

WHEREAS, respondent, in consideration of this Consent Order, has chosen not to contest the above allegations of wrongdoing but, while admitting no guilt or wrongdoing, agrees that for purposes of this or any future proceedings before the Board of Examiners for Nursing (hereinafter "the Board") this Consent Order shall have the same effect as if ordered after a full hearing pursuant to §§19a-9, 19a-10, and 20-99(a) of the General Statutes of Connecticut.

NOW THEREFORE, pursuant to §19a-17 and §20-99(a) of the General Statutes of Connecticut, respondent hereby stipulates and agrees to the following:

1. Respondent waives respondent's right to a hearing on the merits of this matter.
2. Respondent shall comply with all federal and state statutes and regulations applicable to respondent's profession.
3. Respondent's license number 100904 to practice as a registered nurse is hereby reprimanded.
4. Respondent shall pay a civil penalty of one thousand five hundred dollars (\$1,500.00) by certified or cashier's check payable to "Treasurer, State of Connecticut." The check shall reference the Petition Number on the face of the check, and shall be payable at the time respondent submits the executed Consent Order to the Department.
5. Respondent's license number 100904 to practice as a registered nurse in the State of Connecticut is hereby placed on probation for two years, subject to the following terms and conditions:
 - A. Within the first four months of the effective date of this Consent Order, respondent shall attend and successfully complete 1) coursework in nursing awareness of patients with mental health issues including autism spectrum disorder and personality disorder; 2) coursework containing a review of mandatory reporter laws, including reportable incidents and definition of abuse of patients with mental illness; 3) coursework in ethics; and 4) coursework in patient

dignity. All coursework shall be pre-approved by the Department. Within two weeks of the completion of such coursework, respondent shall provide the Department with proof, to the Department's satisfaction, of the successful completion of such course(s).

- B. Respondent shall provide a copy of this Consent Order to all current and future employers for the duration of probation.
- C. Respondent shall not be employed as a nurse for a personnel provider service, assisted living services agency, homemaker - home health aide agency, or home health care agency, and shall not be self-employed as a nurse for the period of probation.
- D. Respondent shall be responsible for the provision of monthly written reports directly to the Department from respondent's nursing supervisor (i.e., Director of Nursing) for the entire probationary period. Respondent shall provide a copy of this Consent Order to any and all employers if employed as a nurse during the probationary period. The Department shall be notified in writing by any employer(s) within fifteen (15) days of the commencement of employment as to the receipt of a copy of this Consent Order. Employer reports shall include documentation of respondent's ability to safely and competently practice nursing, and shall be issued to the Department at the address cited in paragraph 5.I. below. A report indicating that respondent is not practicing with reasonable skill and safety shall be deemed to be a violation of this Consent Order.
- E. Respondent shall notify the Department in writing of any change of employment within fifteen (15) days of such change.
- F. Respondent shall notify the Department of any change in respondent's home or business address within fifteen (15) days of such change.
- G. If respondent pursues further training or is engaged at the time of the implementation of the

Consent Order, in an educational program in any subject area that is regulated by the Department, respondent shall provide a copy of this Consent Order to the educational institution or, if not an institution, to respondent's instructor. Such institution or instructor shall notify the Department of receipt of the Consent Order within fifteen (15) days of receipt.

H. All reports required by the terms of this Consent Order shall be due according to a schedule to be established by the Department of Public Health.

6. Any violation of the terms of this Consent Order without prior written approval by the Department shall constitute grounds for the Department to seek revocation of respondent's nursing license following notice and an opportunity to be heard. Respondent shall pay all costs necessary to comply with this Consent Order.
7. Any extension of time or grace period for reporting granted by the Department shall not be a waiver or preclude the Department's right to take action at a later time. The Department shall not be required to grant future extensions of time or grace periods.
8. Legal notice of any action shall be deemed sufficient if sent to respondent's last known address of record reported to the Practitioner Licensing and Investigations Section of the Healthcare Quality and Safety Branch of the Department.
9. This Consent Order is effective on the first day of the month immediately following the month in which this Consent Order is approved and accepted by the Board.

10. Respondent understands this Consent Order is a matter of public record.
11. Respondent understands and agrees that this Consent Order shall be deemed a public document and the Department's allegations as contained in this Consent Order shall be deemed true in any subsequent proceeding before the Board in which (1) respondent's compliance with this same Consent Order is at issue, or (2) respondent's compliance with §20-99(b) of the General Statutes of Connecticut, as amended, is at issue. Further, respondent understands that any discipline imposed by this Consent Order shall be reported to the National Practitioner Data Bank maintained by the United States Department of Health and Human Services.
12. In the event respondent violates a term of this Consent Order, respondent agrees immediately to refrain from practicing as a nurse, upon request by the Department, for a period not to exceed 45 days. During that time period, respondent further agrees to cooperate with the Department in its investigation of the violation. Respondent further agrees that failure to cooperate with the Department in its investigation during said 45-day period shall constitute grounds for the Department to seek a summary suspension of respondent's license. In any such summary action, respondent stipulates that failure to cooperate with the Department's investigation shall be considered by the Board and shall be given due weight by the Board in determining whether respondent's conduct constitutes a clear and immediate danger as required pursuant to Connecticut General Statutes, sections 4-182(c) and 19a-17(c). The Department and respondent understand that the Board has complete and final discretion as to whether a summary suspension is ordered.
13. In the event respondent does not practice as a registered nurse for periods of thirty (30) consecutive days or longer, respondent shall notify the Department in writing. Such periods of

time shall not be counted in reducing the probationary period covered by this Consent Order and such terms shall be held in abeyance. During such time period, respondent shall not be responsible for complying with the terms of probation of this Consent Order. In the event respondent resumes the practice of registered nursing, respondent shall provide the Department with thirty (30) days prior written notice. Respondent shall not return to the practice of registered nursing without written pre-approval from the Department. Respondent agrees that the Department, in its complete discretion, may require additional documentation from respondent and/or require respondent to satisfy other conditions or terms as a condition precedent to respondent's return to practice. If requested to do so by the Department, respondent further agrees to complete the following: a. attend and successfully complete coursework, remediation, and/or retraining pre-approved by the Department. Upon completion, respondent shall provide the Department with proof, to the Department's satisfaction, of successful completion. Respondent agrees that any return to the practice of registered nursing without pre-approval from the Department shall constitute a violation of this Consent Order and may subject the respondent to further disciplinary action.

14. If, during the period of probation, respondent practices nursing outside Connecticut, respondent shall provide written notice to the Department concerning such practice. During such time period, respondent shall not be responsible for complying with the terms of probation of this Consent Order, and such time period shall not be counted in reducing the probationary period covered by this Consent Order. Respondent may comply with the terms of probation while practicing outside Connecticut if pre-approved by the Department. In the event respondent intends to return to the practice of nursing in Connecticut, respondent shall

provide the Department with thirty (30) days prior written notice and agrees to comply with all terms and conditions contained in paragraph 5 above.

15. In the event respondent violates any term of this Consent Order, said violation may also constitute grounds for the Department to seek a summary suspension of respondent's license before the Board.
16. This Consent Order and terms set forth herein are not subject to reconsideration, collateral attack or judicial review under any form or in any forum. Respondent agrees that this Consent Order shall not be subject to modification as a result of any claim that the terms contained herein may result in action by third parties, including, but not limited to, healthcare facilities and/or credentialing or licensure boards and respondent waives any right to seek reconsideration or modification of this Consent Order pursuant to §4-181a of the General Statutes of Connecticut without the express consent and agreement of the Department. Respondent assumes all responsibility for assessing such actions prior to the execution of this document. Further, this Consent Order is not subject to appeal or review under the provisions of Chapters 54 and 368a of the General Statutes of Connecticut, provided that this stipulation shall not deprive respondent of any other rights that respondent may have under the laws of the State of Connecticut or of the United States.
17. Respondent permits a representative of the Department to present this Consent Order and the factual basis for this Consent Order to the Board. The Department and respondent agree that the Board has complete and final discretion as to whether an executed Consent Order is approved or accepted. Respondent hereby waives any claim of error that could be raised that is related to or arises during the course of the Board's discussions regarding whether to approve or reject this Consent Order and/or a Board member's participation during this process,

through the Board member's review or comments, including but not limited to bias or reliance on evidence outside the administrative record if this matter proceeds to a hearing on a statement of charges resulting in a proposed decision and/or final decision by the Board.

18. This Consent Order is a revocable offer of settlement, which may be modified by mutual agreement or withdrawn by the Department at any time prior to its being executed by the last signatory.
19. Respondent has had the opportunity to consult with an attorney prior to signing this document.
20. The execution of this document has no bearing on any criminal liability without the written consent of the Director of the Medicaid Fraud Control Unit or the State's Attorney's Office where the allegation occurred or Bureau Chief of the applicable unit in the Chief State's Attorney's Office. The purpose of this Consent Order is to resolve the pending administrative license disciplinary petition only, and is not intended to affect any civil or criminal liability or defense.
21. This Consent Order embodies the entire agreement of the parties with respect to this case. All previous communications or agreements regarding the subject matter of this consent order, whether oral or written, between the parties are superseded unless expressly incorporated herein or made a part hereof.

STATEMENT OF CHARGES

Pursuant to the General Statutes of Connecticut, §§19a-10 and 19a-14, the Department of Public Health (hereinafter "the Department") brings the following charges against Kristin Brice:

1. Kristin Brice of Shelton, Connecticut (hereinafter "respondent") is the holder of Connecticut licensed practical license number 038597.
2. In November 2017, the Connecticut Board of Examiners for Nursing (hereinafter "the Board") ordered a Consent Order, Petition No. 2015-1510, based, in part, upon respondent's abuse of controlled substances. The Consent Order placed respondent's license on probation for two years and prohibited her from obtaining or using controlled substances. It also required her to undergo random urine drug screens which were to be negative for the presence of drugs and alcohol.
3. In June 2018, respondent's license lapsed.
4. In December 2019, respondent's license was reinstated pursuant to Reinstatement Consent Order, Petition No. 2019-1170 which placed respondent's license on probation for fourteen months. The Reinstatement Consent Order prohibited respondent from obtaining or using controlled substances and required her to undergo random urine drug screens which were to be negative for the presence of drugs and alcohol.
5. On or about October 16, 2020, respondent abused and/or utilized to excess opiates and/or hydrocodone.
6. On or about October 16, 2020, respondent's urine drug screen tested positive for opiates and/or hydrocodone.
7. Respondent's abuse and/or excessive use of opiates and/or hydrocodone does, and/or may, affect her practice of nursing.
8. Respondent's conduct as described s constitutes violations of the terms of probation required by the Reinstatement Order and subjects her license to revocation or other disciplinary action authorized by Connecticut General Statutes §§19a-17 and 20-99(b) including, but not limited to, §20-99(b)(2) and/or §20-99(b)(5).

THEREFORE, the Department prays that:

The Connecticut Board of Examiners for Nursing, as authorized by Connecticut General Statutes §§20-99(b) and 19a-17, revoke or order other disciplinary action against respondent's nursing license as it deems appropriate and consistent with law.


WHEREAS, the Department of Public Health having moved for an order of summary suspension in this matter and having submitted duly verified affidavits in support of its motion; and,



MEMORANDUM OF DECISION

I

Procedural Background

On March 12, 2013, the Department of Public Health ("Department") filed a Statement of Charges ("Charges") with the Board of Examiners for Nursing ("Board"). Board Exhibit ("Bd. Ex.") 1. The Charges allege violations of Chapter 378 of the General Statutes of Connecticut ("Conn. Gen. Stat.") by Natalie Primini ("Respondent"), which would subject Respondent's licensed practical nurse ("L.P.N.") license to disciplinary action pursuant to Conn. Gen. Stat. §§ 19a-17 and 20-99(b). Bd. Ex. 1.

On April 3, 2013, the Department filed a Motion for Summary Suspension ("Motion") with the Board, which was granted. Bd. Ex. 2.

Based on the allegations in the Charges, the Board found that Respondent's continued nursing practice presented a clear and immediate danger to public health and safety and ordered, on April 3, 2013, pursuant to Conn. Gen. Stat. §§ 4-182(c) and 19a-17(c), that Respondent's L.P.N. license be summarily suspended pending a final determination by the Board of the allegations contained in the Charges ("Order").

Bd. Ex. 2.

On April 13, 2013, a State Marshal served Respondent the Order, Charges, and Notice of Hearing ("Notice") at her usual place of abode. The hearing was scheduled for April 17, 2013. Bd. Ex. 1-3.

On April 17, 2013, Respondent appeared at the hearing. She was not represented by an attorney. Attorney Diane Wilan represented the Department. Transcript ("Tr.") 4/17/13, p. 4. The Board granted Respondent's request for a continuance. Tr. 4/17/13, pp. 5-6.

On April 19, 2013, the hearing was scheduled to convene on June 5, 2013.
Bd. Ex. 4.

On June 5, 2013, the Board granted Respondent's request for a second continuance. The hearing was rescheduled to convene on September 18, 2013. Bd. Ex. 6.

On September 17, 2013, Attorney Joseph Summa filed a letter of appearance on Respondent's behalf and requested a six month continuance to permit Respondent to seek medical treatment. Bd. Ex. 8. The Board granted the request and the hearing was continued until March 19, 2014. Bd. Ex. 7.

On March 18, 2014, Attorney Summa requested a continuance of the March 19, 2014 hearing on Respondent's behalf. Bd. Ex. 9.

On March 19, 2014, the Board granted the request and continued the hearing until May 7, 2014. The Board also ordered Respondent to file an Answer to the Charges by April 1, 2014 and to surrender her license immediately. Bd. Ex. 10.

On April 24, 2014, Attorney Summa notified the Department that Respondent was in Florida. Despite Respondent's stated intentions and her attorney's understanding of the matter, she had not voluntarily surrendered her license. Bd. Ex. 11.

On May 7, 2014, the hearing was held. Neither Respondent nor her attorney was present. Attorney Diane Wilan represented the Department. Tr. 5/7/14, p. 2.

Respondent did not file an Answer to Charges. Tr.5/7/14, pp. 5-6. Attorney Wilan orally moved to deem the allegations admitted ("Motion"). Tr. 5/7/14, pp. 6-7. The Board granted the Motion. Tr.5/7/14, p. 7.

Following the close of the record, the Board conducted fact finding.

Each member of the Board involved in this decision attests that she was present at the hearing or has reviewed the record, and that this decision is based entirely on the record, the law, and the Board's specialized professional knowledge in evaluating the evidence. *Pet v. Department of Health Services*, 228 Conn. 651 (1994).

II

Allegations

1. In paragraph 1 of the Charges, the Department alleges that Natalie Primini of Wallingford, Connecticut is, and has been at all times, referenced in the Charges, the holder of Connecticut licensed practical nurse license number 034112.

2. In paragraph 2 of the Charges, the Department alleges that at all relevant times, Respondent was employed as a L.P.N. at Masonic Healthcare Center (“Masonic Healthcare”) in Wallingford, Connecticut.
3. In paragraph 3 of the Charges, the Department alleges that during approximately December 8, 2012 through December 10, 2012, while working as a L.P.N. at Masonic Healthcare, Respondent:
 - a. administered acetaminophen to a patient instead of Percocet, as prescribed;
 - b. failed to follow proper medication administration procedures; and/or
 - c. failed to completely, properly and/or accurately document medical or hospital records.
4. In paragraph 4 of the Charges, the Department alleges that the above described facts constitute grounds for disciplinary action pursuant to Conn. Gen. Stat. § 20-99(b), including but not limited to § 20-99(b)(2).

III

Findings of Fact

1. The Department provided Respondent with reasonable and adequate written notice of the hearing and the allegations contained in the Charges. Bd. Ex. 9-11
2. On May 7, 2014, neither Respondent nor her attorney appeared at the hearing. Neither Respondent nor her attorney requested a continuance. Tr. 5/7/14, p. 2.
3. Respondent did not file an Answer, although the Board had extended the filing deadline until April 1, 2014. Tr. 5/7/14, pp. 6-7.
4. The factual allegations contained in paragraphs 1 through 3 of the Charges are deemed admitted and true. Tr. 5/7/14, pp. 6-7.

IV

Discussion and Conclusions of Law

The Department bears the burden of proof by a preponderance of the evidence in this matter. *Jones v. Connecticut Medical Examining Board*, 309 Conn. 727, 739-740 (2013). The Department sustained its burden of proof with regard to all of the allegations contained in the Charges.

Conn. Gen. Stat. § 20-99 provides, in pertinent part, that:

- (a) The Board . . . shall have jurisdiction to hear all charges of conduct which fails to conform to the accepted standards of the nursing profession brought against persons licensed to practice nursing. After holding a hearing . . .

said board, if it finds such person to be guilty, may revoke or suspend his or her license or take any of the actions set forth in section 19a-17

(b) conduct which fails to conform to the accepted standards of the nursing profession includes, but is not limited to, the following: . . . (2) illegal conduct, incompetence or negligence in carrying out usual nursing functions;
...

Since Respondent did not file an Answer, the allegations are deemed admitted. Conn. Agencies Regs. § 19a-9-20. Therefore, the Department established by a preponderance of the evidence that during December 8 through December 10, 2012, Respondent, while working as a L.P.N. at Masomic Healthcare administered acetaminophen to a patient instead of Percocet, as prescribed; failed to follow proper medication administration procedures; and/or failed to completely, properly and/or accurately document medical or hospital records. Thus, the Board concludes that Respondent's conduct, as alleged in paragraphs 1 through 3 of the Charges, is deemed to be admitted and true, and constitutes grounds for disciplinary action pursuant to Conn. Gen. Stat. §§ 20-99(b)(2) and 19a-17.

Order

Based on the record in this case, the above findings of fact and conclusions of law, the Board hereby orders, with respect to license number 034112 held by Natalie Primini to practice as a L.P.N. in the State of Connecticut is hereby **REVOKE**D.

This Memorandum of Decision becomes effective on the date signed by the Board.

The Board hereby informs Respondent, Natalie Primini, and the Department of this decision.



2. Respondent has a history of abusing multiple substances, and in approximately January 2020 was diagnosed with alcohol dependence, opioid dependence, and cocaine dependence.
3. Respondent entered into a Preliminary Agreement Not to Practice registered nursing in the State of New Hampshire, effective on or about May 24, 2019, as a result of a “Delta Level Drug Overdose” per Merrimack Police Department.
4. Respondent’s abuse of alcohol, opioids, and cocaine does, and/or may, affect her ability to practice as a registered nurse.
5. Respondent has a history of mental health issues and in approximately January 2020 was diagnosed with major depressive disorder.
6. The above-described facts constitute grounds for disciplinary action pursuant to the General Statutes of Connecticut §20-99(b) including, but not limited to:
 - a. §20-99(b)(4); and/or
 - b. §20-99(b)(5).

THEREFORE, the Department prays that:

The Connecticut Board of Examiners for Nursing, as authorized in §§19a-17 and 20-99(b), revoke or order other disciplinary action against the registered nurse license of Channelle Walker as it deems appropriate and consistent with law.
