The above-captioned matter was heard as a contested case on September 27, 2019, at which time the respondents appeared but the complainant did not personally appear. A non-lawyer representative of the complainant appeared. At the conclusion of the preliminary remarks, the respondents moved for dismissal.

In their motion for dismissal, the respondents contended that the absence of the named complainant precluded them from being able to cross-examine the complainant regarding conversations and correspondence exchanged between the complainant and the respondents.

It is found that in a letter to the Commission filed September 13, 2019, the complainant asked that a non-lawyer representative, Mr. Joseph Lagosz, be allowed to represent him at the hearing in this matter scheduled for September 17, 2019. The complainant made such request citing a heavy work schedule. However, the respondents moved to reschedule the September 17, 2019 hearing and the hearing was subsequently rescheduled to September 27, 2019. Notice was sent to all parties regarding the new date for the hearing. The Commission received no notice from the complainant indicating he would not be available to personally attend the hearing on September 27, 2019, nor did the Commission receive notice that Mr. Lagosz would continue to serve as the complainant's representative.

Mr. Lagosz appeared at the September 27, 2019 as a representative of the complainant. In response to the respondents' motion to dismiss, Mr. Lagosz did not voice an objection but said, "If she [Atty. Sexton, representing the respondents] doesn't like this, I can re-file under my name and we can all go home today."

Accordingly, the respondents' motion to dismiss was granted.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. The complaint is hereby dismissed.
