The above-captioned matter was heard as a contested case on May 13, 2022, at which time the complainant and the respondents appeared, and presented testimony, exhibits and argument on the complaint. Due to the COVID-19 pandemic and the state's response to it, the hearing was conducted through the use of electronic equipment (remotely) pursuant to §149 of Public Act 21-2 (June Special Session), as amended by §1 of Public Act 22-3. At the time of the request and hearing in this matter, the complainant was incarcerated.


At the hearing, the respondents' attorney represented that, on May 10, 2022, records responsive to the complainant's November 22, 2021 request were sent to the Department of Correction. The complainant testified that he had not yet received any records, but that he would withdraw his complaint if responsive records were provided to him. The hearing was continued.

Prior to the continued hearing, by form dated and filed with the Commission on May 18, 2022, the complainant withdrew his complaint. The Commission takes administrative notice of such withdrawal.

The following order by the Commission is hereby recommended on the basis of the record concerning the above-captioned complaint:

1. Based on the withdrawal of the complaint, the case is dismissed.


