**RESOLUTION**

Be it Resolved by the Office of Health Care Access that:

**WHEREAS**, Rockville General Hospital (“Hospital”), a hospital as defined in Section 19a-659 of the Connecticut General Statutes (“C.G.S.”), is required to report with respect to its actual operating results for the fiscal year ending September 30, 2006 (“FY 2006”) to the Office of Health Care Access (“OHCA”) pursuant to Sections 19a-644, 19a-649 and 19a-676, C.G.S., and Section 19a-167g-91 of the Regulations of Connecticut State Agencies (“Regulations”); and

**WHEREAS**, Sections 19a-644, 19a-649 and 19a-676, C.G.S., and Section 19a-167g-91 of OHCA’s Regulations set forth the information to be reported by the Hospital to OHCA with respect to its operations in the prior fiscal year in the Hospital’s Annual Reporting and Twelve Months Actual Filing; and

**WHEREAS**, pursuant to Section 19a-649, C.G.S., the Hospital is also required to obtain an independent audit of the level of charges, payments and discharges by payer and to provide this information in an independent audit report to be submitted to OHCA with the Hospital’s Twelve Months Actual Filing; and

**WHEREAS**, the Hospital reported under Docket Number 06-032AR its FY 2006 actual operating results in the Hospital’s FY 2006 Annual Reporting and Twelve Months Actual Filing, and provided the attachments and schedules included in the Hospital Budget System and an independent audit report: and

**WHEREAS**, the Hospital has not yet received all of the necessary data from the Centers for Medicare and Medicaid Services in order to complete the Hospital’s FY 2006 Medicare Cost Report and to submit the electronic version of this report to OHCA.

**NOW, THEREFORE**, with respect to the FY 2006 Annual Reporting and Twelve Months Actual Filing of Rockville General Hospital under Docket Number 06-032AR, it is hereby ordered that:

1. The FY 2006 actual operating results for Rockville General Hospital are hereby finalized as set forth in the Hospital's FY 2006 Annual Reporting and Twelve Months Actual Filing and in the attachments and schedules included in the Hospital Budget System.
2. The Hospital will submit the electronic version of the Hospital's FY 2006 Medicare Cost Report, as filed, to OHCA by no later than August 31, 2007.
