**RESOLUTION**

Be it Resolved by the Office of Health Care Access that:

**WHEREAS**, Saint Vincent's Medical Center ("Hospital"), a hospital as defined in Section 19a-659 (2) of the Connecticut General Statutes ("C.G.S."), is required to annually report with respect to its actual operating results for the most recently completed fiscal year, ending September 30, 2007 ("FY 2007"), to the Office of Health Care Access ("OHCA") pursuant to Sections 19a-644, 19a-649 and 19a-676, C.G.S., and Section 19a-643-206 of the Regulations of Connecticut State Agencies ("Regulations"); and

**WHEREAS**, Sections 19a-644, 19a-649 and 19a-676, C.G.S. and Section 19a-643-206 of OHCA's Regulations set forth the information to be reported by the Hospital with respect to its operations in the most recently completed fiscal year in the Hospital's Annual Reporting and Twelve Months Actual Filing; and

**WHEREAS**, the Hospital is also required to annually submit the Hospital's approved operating budget for the fiscal year commencing on October 1st of the previous calendar year and ending in the current fiscal year, on September 30, 2008 ("FY 2008"), pursuant to Section 19a-637a, C.G.S. and Section 19a-643-205 of OHCA's Regulations; and

**WHEREAS**, Section 19a-637a, C.G.S. and Section 19a-643-205 of OHCA's Regulations set forth the information to be submitted by the Hospital with respect to its hospital operating budget for the current fiscal year in the Hospital's Budget Filing; and

**WHEREAS**, pursuant Section 19a-643-206 (b) (15) of OHCA's Regulations and Section 19a-659 (6), C.G.S., the Hospital is required to submit annually as part of its Annual Reporting the hospital's uncompensated care policies regarding its charity care and bad debts, which are to be approved by and on file at OHCA.
