ATTACHMENT TO CERTIFICATE OF INCORPORATION DAY KIMBALL MEDICAL GROUP, INC.

4. The nature of the activities to be conducted or the purposes to be promoted by the Corporation:

Day Kimball Medical Group, Inc. shall be organized and operated exclusively for charitable, scientific, literary and educational purposes permitted within the scope of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, provided, however, the purpose of the Corporation shall be exclusively for practicing medicine and providing healthcare services as a medical foundation under Title 33, Chapter 594B of the Corporation may exercise all rights and powers conferred by the laws of the State of Connecticut upon nonprofit corporations; provided, however, the Corporation shall not act so as to impair its eligibility for exemption under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or as a medical foundation under Title 33, Chapter 594B of the Connecticut General Statutes.

5. Other Information.

- The sole member of the Corporation shall be Day Kimball Healthcare, Inc., a Connecticut not-for-profit, non-stock corporation with a registered address of 320 Pomfret Street, Putnam, Connecticut, 06260. Said Member shall not be subject to election or removal by the Board of Trustees of the Corporation. Said Member shall have all of the rights and liabilities of a member as provided in the Connecticut Revised Nonstock Corporation Act (C.G.S.A. § 33-1000, et. seq.) and in the Bylaws of the Corporation.
- b. Amendments to this Certificate of Incorporation for any purpose may be made by the Member or by the Board of Trustees of the Corporation, provided that no amendment may be made to this Certificate of Incorporation by the Board of Directors without the prior consent of the Member as provided in the Bylaws of the Corporation.
- c. The Corporation does not contemplate pecuniary gain or profit, incidental or otherwise. No part of the net earnings of the Corporation shall inure to the benefit of any director or officer of the Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation effecting one or more of its purposes), and no director or officer of the Corporation, or any private individual, shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.
- d. The term of existence of the Corporation shall be perpetual.

- e. The Corporation shall be governed by a Board of Trustees, which shall consist of such numbers of directors as may be fixed from time to time in the Bylaws of the Corporation, subject to oversight of the Member as provided in the Bylaws of the Corporation.
- f. Notwithstanding any other provision of this Certificate of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and its regulations, as they now exist or as they may hereafter be amended. In addition, notwithstanding any other provision of this Certificate of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization, contributions to which are deductible under Section 170 of said Internal Revenue Code and its regulations, as they now exist or as they may hereafter be amended.
- Upon dissolution of the Corporation or the winding up of its affairs, the Board of Trustees shall, after making provision for the payment of all of the liabilities of the Corporation, transfer the assets of the Corporation to Day Kimball Healthcare, Inc., an organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). If Day Kimball Healthcare, Inc. shall not exist or shall no longer qualify as an exempt organization under Section 501(c)(3) of the Code at the time of the dissolution or liquidation of this Corporation, any assets of the Corporation shall be transferred to such organizations which are described in Section 501(c)(3) of the Code or the corresponding provisions of any subsequent United States Internal Revenue law, as the Board of Trustees shall determine. Any assets not so disposed of shall be wife disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located to such organizations described in Section 501(c)(3) of the Code or in accordance with the corresponding provisions of any subsequent United States Internal Revenue law, as such court shall determine.
