Monthly Indicators Report

Highlights

- The state's prisons and jails held 15,023 prisoners on September 1, 2016. A year ago, 16,168 people were incarcerated in CT, a drop of 7.1%. On September 3rd, the prison population dropped below 15,000, a milestone that few thought possible several years ago (see chart3).
- Chart 3 captures a single-day, 70-inmate bump in the prison count between Tuesday the 6th and Wednesday the 7th. Increases this sudden are normal following three-day holiday weekends as an extra day's worth of pre-trial defendants finally make their way to court.
- On September 1st, there were 11,182 sentenced prisoners incarcerated in the state. This was the DOC's lowest, first-of-the-month, sentenced population total since November 1993.
- During the last year, the number of special parolees on supervision in the community rose by 259. This represents a 19.8% increase over a 12 month period (see chart 8).
- Interactions through the Jail Re-interview (JRI) program have declined significantly since layoffs and forced transfers were enacted by the Judicial Branch (see table 6). The longer term impact of this on the pre-trial population is presently unclear.
- If the ratio of offenders on community supervision to offenders in prison was the same today as it was last September, there would currently be 15,650 people in prison, a number oddly similar to OPM's February forecast.
- 12-month recidivism rates for offenders released in 2014 were down only slightly from 2011. Recidivism events, however, were down by 19% (see chart 2b).

Prison Population Forecast

The gap between OPM's February prison population projection and the actual prison count continues to widen. This is good news. OPM's forecast was designed to project the future prison population were the criminal justice system running at 'normal' operational levels. The fact that the count is 600 prisoners below the estimate suggests a significant improvement in system efficiency.

Over the last year, the prison population has dropped by over 1,100 prisoners. There is no single explanation. Certainly, admits to prison are down this year compared to last year. Releases, though down, are down by a smaller margin.

Tracking total prison admissions and releases, however, does not explain why the prison population is contracting as quickly as it is. A critical piece of system information is lacking. We, currently, do not know how many extra days appropriate, release-eligible prisoners spend in prison facilities past their earliest possible release dates. It is an elusive measure but a key one if we ever hope to squeeze more efficiency out of existing re-entry processes.

In the past, it was not uncommon for some release-eligible offenders to languish a few extra days, weeks, or even months, in prison beyond their earliest possible release dates. We know that if every offender who was reviewed and approved was released from prison on their eligibility date, the state would realize substantial savings. OPM suspects that the DOC's Community Release Unit had already begun to squeeze some of these bed-day savings out of the re-entry process. OPM's new challenge is to determine when the state's declining prison population will settle out.

January 1, 2015 through February 1, 2017

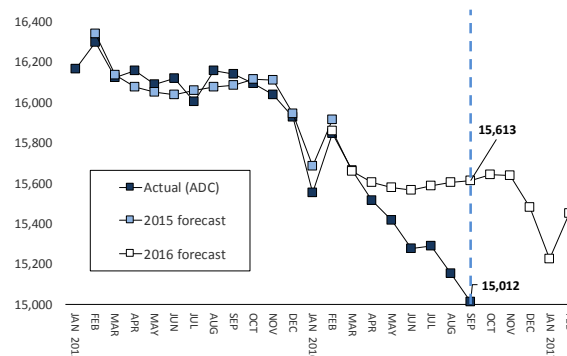


Chart 2 - Criminal justice, monthly counts and flows

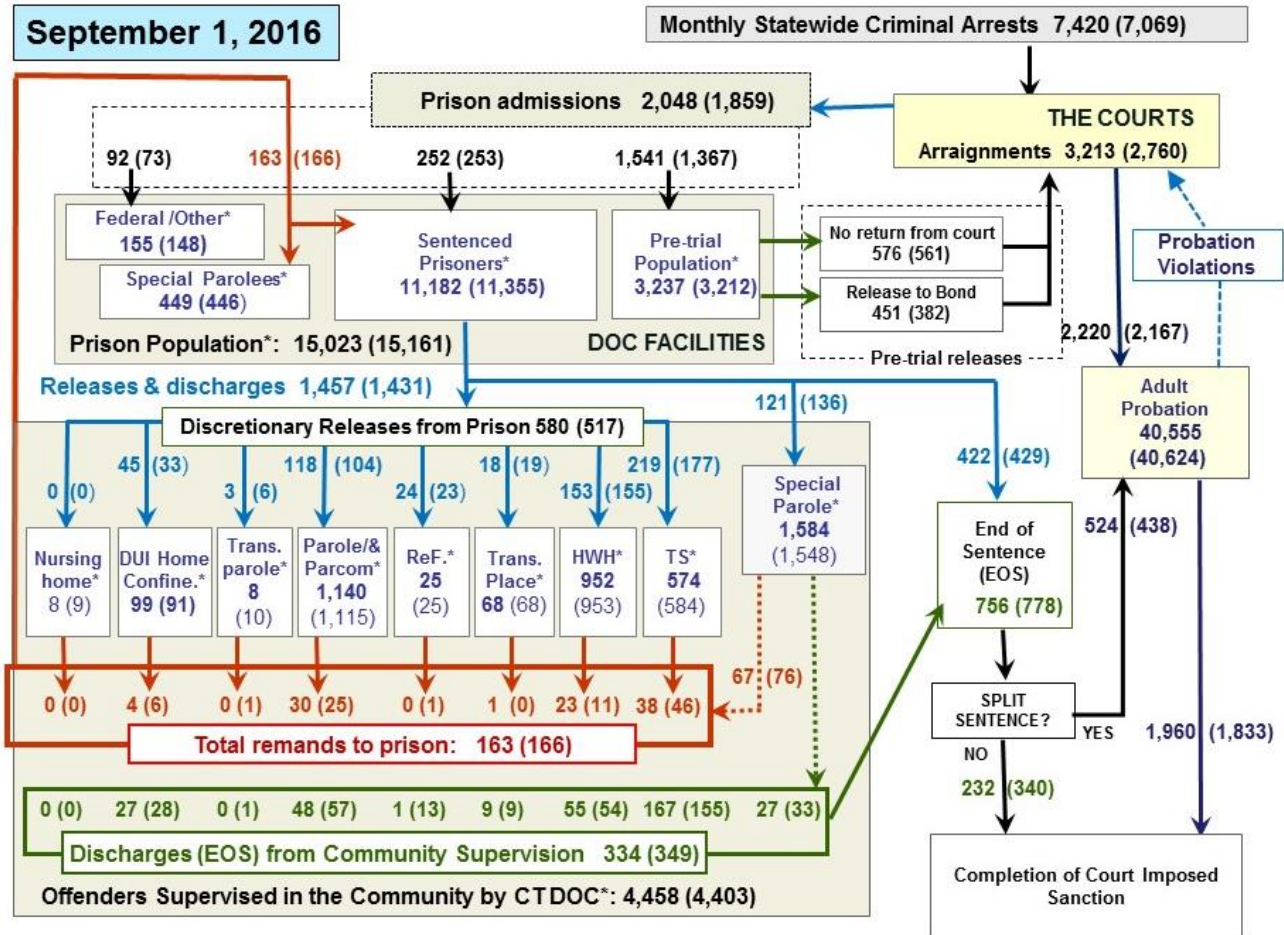
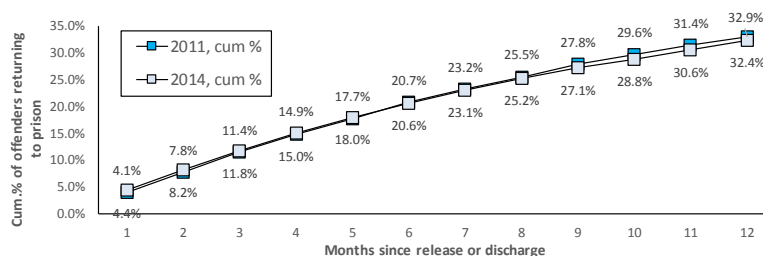

OPM recently received offender-movement data from CT DOC's MIS unit for all sentenced prisoners who were released or discharged from prison during calendar year 2014. The data allowed this office to calculate 12-month recidivism rates for returns-to-prison. The findings were compared with recidivism data for a similar cohort of offenders in 2011.

returning to prison in the 2014 was virtually unchanged from the recidivism rate of offenders who left prison in 2011. However, the 2014 prisoner cohort was 17.9% smaller than the 2011 cohort (see table). As a result, many fewer former prisoners, 790 in fact, were returned to prison within 12-months from the 2014-cohort than from the 2011-cohort. This translates into 19.1% fewer return-to-prison events.

The comparative analysis revealed an important detail that can commonly be overlooked when people think about and discuss recidivism, i.e., recidivism rates and recidivism events cannot be used interchangeably.

These returns-to-prison include readmissions for a variety of reasons including technical violations of supervision conditions, rearrests for new charges, and admissions to prison to begin a new term of incarceration. OPM will publish more complete findings from this analysis in the coming weeks and months.

OPM's preliminary analysis, for example, revealed that the 12-month recidivism rate for offenders

First week of the month, avg. daily count (ADC)

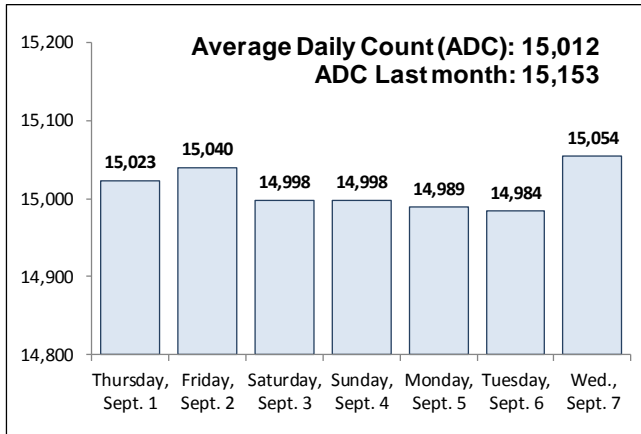


Chart 6 – Monthly DOC Admissions

July 2015 through August 2016

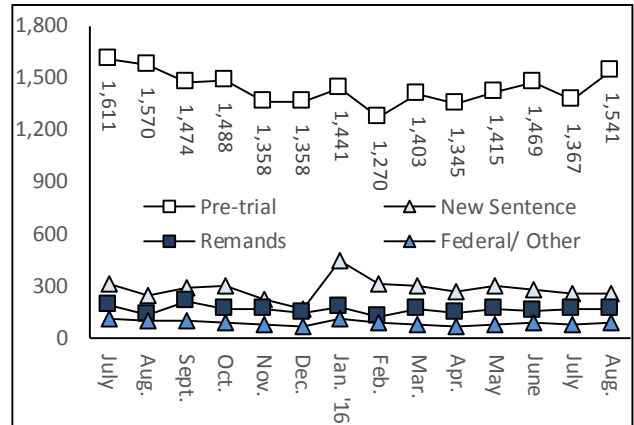


Chart 4 – Prison population, first-of-month

2014, 2015 and 2016

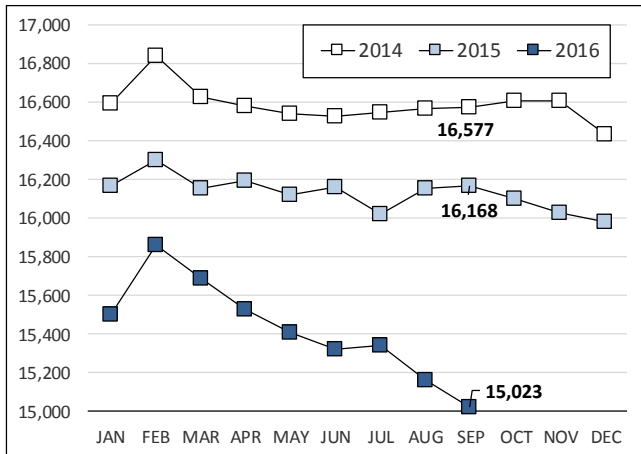


Chart 7 – Remands from community release

August 2016

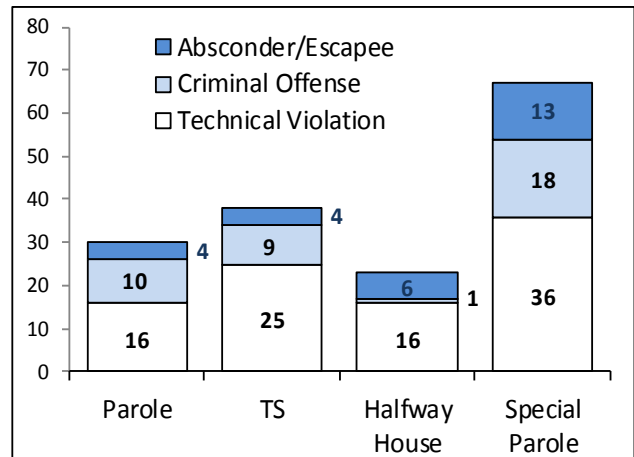


Chart 5 – Statewide criminal arrests

2015 and 2016

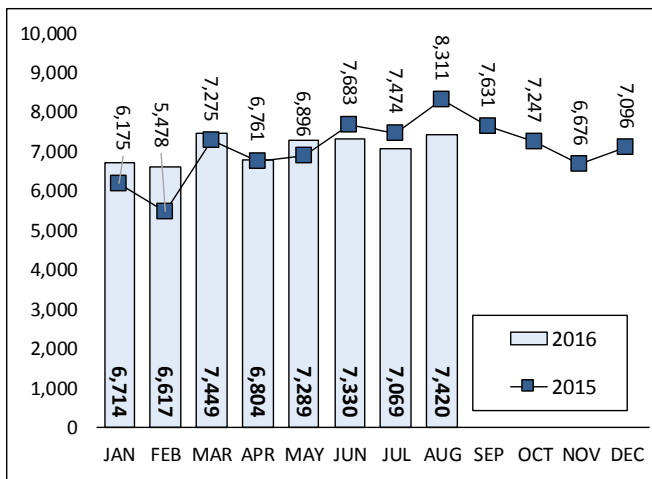
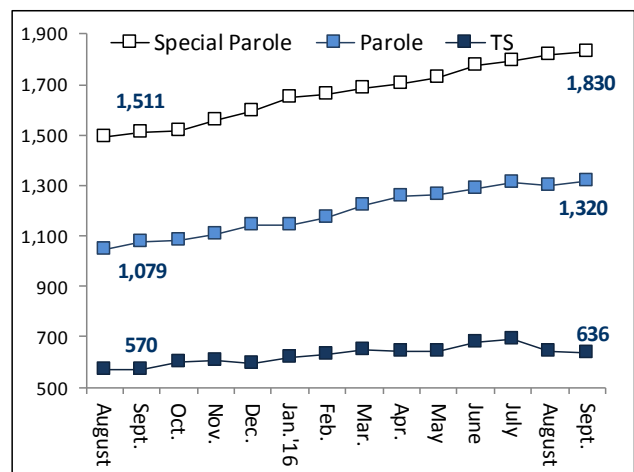


Chart 8 – DOC community supervision
