Brief Project Description/Summary:

The Department of Revenue Services (DRS) has embarked on an Enterprise Content Management (ECM) initiative that will provide (1) scanning and imaging, (2) FileNet conversion and (3) document management. The deliverables for ECM scanning and imaging will replace existing outdated and obsolete remittance and data entry equipment and enable streamlined processes. Such a system would allow DRS to convert paper checks, returns, and correspondence into digital -only format. This will enable better revenue processing, improved communications with taxpayers regarding the status of tax returns, control access to such information, route business processes through our imaging data (enhanced workflow), and adopt document retention schedules as set forth by the Office of Public Records Administrator (OPRA).

Issues and Risks:

Development and User Acceptance Testing will be completed prior to any migration to the ECM Production environment to minimize any potential issues on the forms already "live" and processed through the ECM system.

Next Steps & Project Milestones:

1. Update ECM for CTAX Rollout 3 Forms being migrated September 12, 2022. (CTAX Project is an agency-wide, four phase IT modernization project)

ECM Process updated to include changes needed for the way payments and returns process through the current ECM system. CTAX is a transactional tax system and ITAS is a batch tax system. Therefore, specific changes are needed in ECM to change the way each tax type specific transaction processes as it is transitioned from ITAS to CTAX.

The changes needed for each phase of the CTAX implementation are as follows:

- Update ECM process to capture taxpayer ID and period the payment is for prior to the money being sent to bank. NOTE: CTAX processes the payment and return as separate and distinct pieces of a transaction whereas ITAS processes them as one transaction with the payment needing the return to tell it the taxpayer's id, tax type, and period to post to.
 - Generation of 2nd Image Cash Letter (ICL) to BofA for CTAX payments. This will keep CTAX and ITAS payments in separate ICL to allow for better control.
 - Generation of new Output Payment file in XML format for CTAX payments. This file will stitch together all CTAX payments in one file.
 - Generation of new Output Return file in XML for each transaction (return, estimate, extension, voucher, etc.).
 - Generation of image file for each Work Object which will be sent to CTAX and allow employees to view entire contents of transaction within CTAX system by clicking on a hyperlink.
 - Update the current Patch Sheet process for CTAX to output the image file of the additional information and tie it to the transaction in CTAX. It will be able to be viewed with the transaction it is supporting.
 - Multiples will be greatly improved with CTAX as the new system is able to handle all types of multiples (any number of returns and checks due to it being that it is transactional system. In depth development and testing will be performed to confirm the handling of any combination of returns and checks within one transaction.
2. ECM development, testing, and migration for all tax returns requiring 2022 mid-year form changes and any possible Legislative Changes enacted during the 2022 Legislative Session.
