Pursuant to Sections 3-37(b) and 3-21(f)(2)(A) of the General Statutes, please find attached the Report for October 2021, which provides information regarding the State's cash position and bonding activity.

Cash balances for November continued to be strong, with total available cash at \$9.4 billion, including the common cash pool of \$8.2 billion as of November 27, 2021. Given the economic uncertainty associated with the ongoing pandemic and the potential impact on State cash receipts and disbursements, we continue to diligently monitor, assess, and revise our Cash projections. No temporary transfers from bond proceeds investment accounts have been made since December 2017.
