Treasurer Russell has been advised that the underwriters do not owe the State a statutory fiduciary duty arising under Section 975 of the Dodd-Frank Wall Street Reform and Consumer Protection Act, but may owe it other duties, including, without limitation, duties arising under other statutes, the common law, and contract, such as a duty of good faith and fair dealing. The State hereby reserves all of its rights. Treasurer Russell does not consent to any limitations of duties, conflicts of interest or other matters described in such letters, and any communication relating to such letters should not be interpreted as such.
