#### **Call to Order**

Treasurer Shawn T. Wooden called the meeting to order at 9:33 a.m. He greeted the members virtually and welcomed them to the meeting. Treasurer Wooden then welcomed the newest members of the

CHET Advisory Committee to the meeting and delivered welcoming remarks that highlighted the activity of the office in 2021.

He then turned the meeting over to Deputy Chief Investment Officer Raynald Leveque to chair the remainder of the meeting.

### **Adoption of Minutes**

Treasurer Wooden made a request to entertain a motion to approve the minutes from the prior meeting on December 7, 2020. A motion was made by State Rep. Sean Scanlon to approve the minutes, seconded by State Rep. Kathleen McCarthy. The minutes were approved with one minor correction by majority vote.

### **Presentation by the Office of the Treasurer**

Raynald Leveque began his remarks by introducing the newly appointed Chief Investment Officer, Ted Wright, to the Committee members. He then briefed the Committee on the agenda for the meeting.

Raynald Leveque gave an overview of the conversion from TIAA-CREF (Direct) & Hartford Funds (Advisor) to Fidelity. Next, he discussed the benefits that Fidelity brings to improve investment outcomes to CHET. Lastly, he spoke to initiatives that will be enhancements to the CHET programs and highlighted those enhancements since the conversion to Fidelity Investments. State Rep. Kathleen McCarthy inquired about the Progressive glidepath benefit, and Mr. Leveque provided a brief overview of the benefit.

### **Presentation by Fidelity Investments**

Tony Durkan, gave his opening remarks and introduced members of the Fidelity team. Ron Hazel gave a presentation of the CHET Advisor program and provided an overview of the 529 Industry Update. Jared Newman gave an overview of the CHET Direct program. He responded to questions from Rep. Kathleen McCarthy and Rep. Holly Cheesman about the CHET program. Heather Zakian provided a more detailed explanation of the investment philosophy and process regarding glide path strategic asset allocation.

### **Presentation by AKF Consulting**

Andrea Ferstein discussed AKF's role in setting a baseline for the CHET program. She gave an overview of the 529 Savings Market, Trends and Developments, and commented on Morningstar Rating Methodology.
