



Juvenile Offenders – Parole Eligibility

Public Act 15-84, establishes new parole eligibility rules for minors who commit crimes and are sentenced to more than 10 years in prison, as follows:

1. If the offender is sentenced to 10 to 50 years in prison, the offender is eligible for parole after serving 12 years or 60% of his or her sentence, whichever is greater, or;
2. If the offender is sentenced to more than 50 years in prison, the offender is eligible for parole after serving 30 years. [Click here for more information about Public Act 15-84.](#)
