Governor Lamont signed the following legislation of the 2021 Regular Session on June 16:

HB 6121 SA 21-10	AN ACT CONCERNING A WORKFORCE DEVELOPMENT PIPELINE FOR PERSONS WITH DISABILITIES.
SB 2 PA 21-46	AN ACT CONCERNING SOCIAL EQUITY AND THE HEALTH, SAFETY AND EDUCATION OF CHILDREN.
SB 356 PA 21-48	AN ACT ESTABLISHING AN ENERGY EFFICIENCY RETROFIT GRANT PROGRAM FOR AFFORDABLE HOUSING.
SB 883 PA 21-49	AN ACT CONCERNING THE RECOMMENDATIONS OF THE GOVERNOR'S COUNCIL ON WOMEN AND GIRLS.
SB 894 PA 21-50	AN ACT CONCERNING THE MANUFACTURE, SALE AND DISTRIBUTION OF ALCOHOL-INFUSED CONFECTIONS, THE AUTHORIZATION OF SELF- POUR AUTOMATED SYSTEMS FOR CERTAIN ALCOHOLIC LIQUOR, A STUDY OF EXTENDING ALCOHOLIC LIQUOR SERVICE HOURS AND BACKERS OF GROCERY STORE BEER PERMITS.
SB 914 PA 21-51	AN ACT CONCERNING HMONG LAOTIAN SPECIAL GUERILLA UNITS WHICH SERVED IN THE KINGDOM OF LAOS.
SB 925 PA 21-52	AN ACT PROHIBITING THE IMPORT, SALE AND POSSESSION OF AFRICAN ELEPHANTS, LIONS, LEOPARDS, BLACK RHINOCEROS, WHITE RHINOCEROS AND GIRAFFES.
SB 952 PA 21-53	AN ACT CONCERNING ENERGY STORAGE.
SB 972 PA 21-54	AN ACT CONCERNING COMMUNICATION SERVICES IN CORRECTIONAL AND JUVENILE DETENTION FACILITIES.
SB 975 PA 21-55	AN ACT STRENGTHENING THE BILLS OF RIGHTS FOR LONG-TERM CARE RESIDENTS AND AUTHORIZING THE USE OF RESIDENT TECHNOLOGY FOR VIRTUAL VISITATION AND VIRTUAL MONITORING.

SB 1008 PA 21-57	AN ACT CONCERNING HEALTH EQUITY, THE CORONAVIRUS PANDEMIC AND PULSE OXIMETERS.

HB 5310 PA 21-59	AN ACT CONCERNING DATA PRIVACY BREACHES.
HB 5312 PA 21-60	AN ACT CONCERNING ACCEPTABLE FORMS OF CURRENCY AS PAYMENT IN LOCAL BUSINESSES.
HB 5420 PA 21-61	AN ACT CONCERNING DRIVER RESPONSIBILITY AT INOPERATIVE TRAFFIC CONTROL SIGNALS.
