### LEARNER ENVIRONMENT

Indicator	Standard for Proficient	What observable evidence (words or actions) support this? How do you know?
<i>Rapport and positive social interactions</i>	Interactions between teacher and students are <u>consistently</u> <b>positive and respectful</b> and the teacher <u>regularly</u> <b>promotes positive social interactions</b> among students.	
<i>Respect for student diversity</i>	Maintains a learning environment that is <u>consistently</u> <b>respectful of</b> all students' cultural, social and/ or developmental <b>differences</b> .	
<i>Environment supportive of intellectual risk-taking</i>	Creates a learning environment in which <u>most</u> students are <b>willing to take intellectual risks</b>	
<i>High expectations for student learning</i>	Establishes and consistently reinforces <b>high expectations</b> for learning for <u>all</u> students.	

INSTRUCTION FOR ACTIVE LEARNING

Indicator	Standard for Proficient	What observable evidence (words or actions) support this? How do you know?
<i>Strategies, tasks and questions</i>	<p>Employs <b>differentiated</b> strategies, tasks and questions that cognitively engage students in constructing new and meaningful learning through appropriately integrated recall, <b>problem-solving, critical and creative thinking</b>, purposeful discourse and/or <b>inquiry</b>. <u>At times</u>, students take the lead and develop their own questions and problem solving strategies.</p>	<p>*Note: whole group, recall, DOK 1 activities (lecture, read &amp; answer questions) would not meet qualifications for proficient</p>
<i>Instructional resources and flexible groupings</i>	<p>Uses <b>resources</b> and flexible <b>groupings</b> that cognitively engage students in demonstrating new learning in <i>multiple ways</i>, including application of new learning to make <b>interdisciplinary, real world, career or global connections</b>.</p>	<p>*Note: lesson should address “why are we doing this/when will I use this?”, attention to different reading levels and learning styles, options for materials</p>
<i>Student responsibility and independence</i>	<p>Implements instruction that provides <i>multiple opportunities</i> for students to develop <b>independence</b> as learners and <b>share responsibility</b> for the learning process.</p>	<p>*Note: student centered; students have some choices. Teacher frames learning and facilitates and coaches rather than making all decisions</p>

SERVICE DELIVERY

Indicator	Standard for Proficient	What observable evidence (words or actions) support this? How do you know?
<i>Precision of service delivery</i>	Delivery of services is <b>consistent with planning</b> and demonstrates <b>flexibility</b> and sensitivity for the <u>majority</u> of learners.	
<i>Feedback to learner</i>	Provides <b>specific, timely, accurate and actionable feedback</b> that supports the improvement and advancement of academic or social/behavioral outcomes.	
<i>Adjustments to service delivery</i>	<b>Adjustments</b> to service delivery are responsive to learner performance or engagement in tasks.	
<i>Maintenance of records</i>	Records are <b>complete, organized and accurate</b> . Confidential information is stored in a secured location.
