V. Report of the Commissioner

Commissioner Cardona opened with a special recognition of thanks and appreciation to student Board members, Sophia and Milan, who are high school seniors.

The Commissioner made the following acknowledgements:

- He welcomed Chief Academic Officer, Irene Parisi to the agency team.
- He welcomed Dr. Gladys Labas, Director of Equity and Language to the agency team.
- He welcomed Board member Mr. Woody Exley to his first public Board meeting.
- He thanked Ajit Gopalakrishnan and Matt Falconer and for their technical administration of the virtual meeting format.
- He expressed appreciation to all who had submitted on-line public comments.

Commissioner Cardona provided a summary of some of the activities at the agency. He shared that the agency was working on a reopening plan for Connecticut schools and expressed that this was an important undertaking that would require tremendous collaboration, coordination, and communication with partners throughout the State of Connecticut.

He highlighted the following agency activities:

- Bi-weekly conference calls with superintendents.
- Weekly educational partner calls with presidents of AFT, CEA, CAPSS, CABE, and CAS.
- Agency participation in three or four calls a week with the Council of Chief State School Officers.
- The Educational Supports and Wellness area of our agency has supported the serving of approximately 4 million meals in the State of Connecticut since the pandemic took place.
- CSDE partnership with the Connecticut Department of Social Services (DSS) to implement the Pandemic Electronic Benefits Transfer Program (P-EBT).
- Increased efforts to provide social emotional support and guidance support to districts.
- o CSDE's professional support series for districts and families.
- A heavy focus on Special education guidance and support.
- Providing flexibility for districts and educators where it is needed to allow districts to adjust to their needs.
- The Academics and Innovation area of our agency is working to make sure that we are identifying the needs of districts, as well as, connecting with the districts that have the most challenge connecting with students to provide more targeted support.

- The creation of four resource guides with updates on professional learning opportunities for families and districts to engage with students for academic learning with free resources for districts.
- The Learn from Home Task Force with the support of Superintendents Nate Quesnel and Paul Freeman have worked to see to it that the donation of 60,000 laptops and 200,000 sets of materials make their way to students right away. Our Academics and Innovation Department is working with the Learn from Home Task Force.
- CARES Act. The Commissioner reiterated that we are going through an unprecedented time and all sectors are going to be affected by this pandemic. We have to make sure that we are supporting our learners by ensuring that we are providing equity and access to learning despite the pandemic and we are going to continue to do that as an agency.

Commission Cardona concluded his report by stating that these are just some of the examples of things that we are doing and the work that is going to keep us moving forward into the summer.

The Board members then engaged Commissioner Cardona in discussion.

E. Connecticut Technical Education and Career System Board

CTECS Chairman Trefry and Superintendent Jeffrey Wihbey presented an update on distance learning that the system started on March 30, 2020. They provided multiple examples of teachers being innovative in teaching to compensate for the loss of the hands-on component in the trades. Students were provided with resource guidance on where to get free breakfast and lunch, as well as guidance on social-emotional support for the parents and the professional resources for educators. CTECS has donated well over a thousand pounds of food throughout Connecticut along with goggles, gloves, and respirators to the first responders early on in the process. The students used the 3-D printers make face masks. Discussion ensued.
