Dear Superintendents and School Business Officials,

As you know, the issue of providing "equitable services" for nonpublic schools under the CARES Act, Elementary and Secondary School Education Relief (ESSER) fund, has been subject to much debate and litigation.

On September 16, 2020, the Connecticut State Department of Education (CSDE) recommended that all school districts follow the Equitable Services rules and practices under Section 1117 of the Elementary and Secondary Education Act (ESEA), and that they not spend more than the Title I methodology calculation amount. Since that time, the United States Education Department (USED) has confirmed they will not appeal the federal court rulings to invalidate USED's July final rule and April non-regulatory guidance for CARES Act equitable services requirements.

Revision of Spending Plans

In light of this new information, if districts did not calculate ESSER fund equitable services based on the Title I proportionate share methodology, it will be necessary to recalculate equitable services using the proportionate share calculation for Title I, Part A, using 2019-2020 which follows the methodology in Section 1117 of ESEA as required in Section 18005 of CARES Act.

The change in the calculation of the proportional share of equitable services under the CARES Act will require revisions to districts' ESSER fund applications.

In addition, school districts will need to reengage in contacting the private schools that are eligible to participate, including those that may have declined or are located across district boundaries.

Previously Expended Funds and Encumbered Funds (Pending Purchase Orders)

For school districts that have already expended funds to provide equitable services to nonpublic schools that exceeds the Title I methodology calculation, both federal regulations and a letter published on September 25, 2020 by the USED provide cover for school districts who reasonably relied on the prior guidance and IFR prior to the court decision. Any efforts to reclaim technology and items previously distributed to a nonpublic school in excess of the Title I methodology should be done in consultation with legal counsel. The Department is not requiring school districts to do so; however, it would not be appropriate to make no change to the amount allocated to private schools on a going forward basis.

Related to pending orders for goods or services to be provided to a nonpublic school that would be in excess of the amount due under the Title I methodology, school districts should stop these from progressing to the greatest extent possible according to vendor requirements and cancellation policies and as legally permitted. If pending orders cannot be canceled or the school district attorney advised against it, the USED has announced it will not take action against the school district.

As a reminder, the ESSER funding is available to be obligated until September 30, 2022.
