## Determining Eligibility Resource List for Module 1: Introduction to Application Certification

The CSDE's *Determining Eligibility* training program is a series of recorded modules that provide comprehensive guidance on complying with the U.S. Department of Agriculture (USDA) regulations for determining a child's eligibility for free or reduced-price meals or free milk in the [school nutrition programs](#), free meals in the [Summer Food Service Program \(SFSP\)](#), and S-EBT.
