38th Assembly District Convention Minutes
May 18, 2020, at 7:00 p.m.
Waterford CT, via Zoom videoconference

Convention called to order at 7:05 p.m.; Temporary Chair Susan Driscoll announced appointment of Cathy Barnard as Temporary Secretary.

Cathy Barnard called roll for attendance and reported 10 delegates, 1 proxy for a total of 11 present and voting.

Susan Driscoll asked for nominations of Permanent Chair. Motion to nominate Susan Driscoll by Bill Sheehan; second by Betsy Ritter. Bill Sheehan made a motion to close the nominations. Betsy Ritter seconded the motion and it passed unanimously by voice vote. Voice vote was held on the nomination of Susan Driscoll as Permanent Chair and it passed unanimously.

Susan Driscoll asked for nominations of Permanent Secretary.

Motion to nominate Cathy Barnard by Betsy Ritter; second by Rita Provatas and it passed unanimously by voice vote.






