*This application must be executed in duplicate and may be made no earlier than 45 days before the presidential election.*

FORMER RESIDENT: a. You were formerly a resident of the town to which you are directing this application and b. you have moved to your present residence in another state within thirty days prior to the date of the presidential election and for that reason are prevented from registering to vote in the town of your present residence.

NOTE: Any elector (registered voter) who expects to be absent from the town during all hours of voting is entitled to use the regular absentee ballot containing all officers to be voted on. In such case, application should be made on the form entitled "Application for Absentee Ballot" which may be obtained from your Town Clerk.

DEADLINE FOR MAKING APPLICATION. Close of the polls on the day of the presidential election.

**PENALTY FOR FALSE STATEMENTS**

(a) PERSONS ARE GUILTY OF FALSE STATEMENT IN ABSENTEE BALLOTING when they intentionally make a false written statement on, or sign the name of another person to, the inner envelope accompanying any presidential ballot. (Sec. 9-158(1) and 9-359(a) (b) False statement in absentee balloting is a class D felony. Sec. 9-359(a) (c) A SENTENCE for a class D felony shall not exceed five years in prison.(Sec. 53(a) - 35(a) (d) A FINE for the conviction of a class D felony shall not exceed five thousand dollars. (Sec. 53a-41)

**IDENTIFICATION**

A person applying for a presidential ballot in person or by mail shall present with this application: (1) A current and valid photo identification, or (2) a copy of a current utility bill, bank statement, government check, paycheck or other government document that shows the name and address of the voter.

If your town clerk has a fax machine, you may fax this application to the clerk but must also mail this completed application with your original signature to the clerk, either separately or with your presidential ballot. If your application with your original signature is not received by the close of polls on the day of election, your presidential ballot will not be counted.
