

To the Leaders of the Connecticut General Assembly:

In accordance with Connecticut General Statutes (CGS) Sec. <u>2-32c</u>, as amended by Sec. 107 of <u>PA 17-2 of the June Special Session</u> and Sec. 3 of <u>PA 19-193</u>, attached is a list of new or expanded state mandates and mandate reductions arising from the 2019 legislative session.

As discussed in the reports covering the 2017 and 2018 sessions, those reports were delayed by 2017's prolonged special sessions and by Sec. 107 of PA 17-2 of the June Special Session, postponed those years' ACIR mandate reporting. The ACIR submitted the 2017 report in early 2019 and the 2018 report is being submitted at the same time as this 2019 report, which is due by November 15 in accordance with the updated requirement of CGS 2-32c.

The statutory definition of mandate utilized in this listing includes actions that require a local government to create, expand or modify its activities in such a way as to necessitate additional expenditures from local revenues. Specifically excluded are legislation that do the same but are enacted to comply with federal mandates, as well as legislation required by court order.

The 2019 regular and special session resulted in twenty public acts that included one or more sections that the ACIR determined to include new or expanded mandates. That is six more than in 2018, a short legislative session, and three more than in 2017, the previous odd-year long legislative session. The ACIR does compare the number of new or expanded mandates with numbers from previous years but must highlight that, even if the number had been reduced this year relative to previous years, the ACIR would point out that it should not be considered an achievement. The ACIR believes the focus each year should be on the fact that mandates were created or expanded and, this year, that was done in twenty public acts.

This report identifies an additional five public acts that included one or more sections having the impact of mandates, but that are not specifically directed at municipalities. That is two more than in 2018 and the same as in the long-session year of 2017. These are identified as "Section C" mandates in the ACIR's separate mandates compendiums.

A long-standing objective of the ACIR has been to encourage mandate reductions that can lead to administrative and/or fiscal relief for municipalities. This report identifies five public acts that included one or more sections reducing mandates, which is one more than in 2018 but six less than in 2017.

It is not uncommon for a single public act to include multiple sections imposing mandates or some imposing mandates and others providing mandate relief. One act listed in this report, in fact, includes sections imposing both kinds of mandates tracked by this report and others offering relief from other mandates. The relevant sections of such acts are discussed in each section of this report.

The list of bills was developed by ACIR staff and, while the ACIR believes all relevant legislation has been identified, the ACIR welcomes input from others regarding any legislation that should be included or excluded. In addition to the listing of the bills as required in the statute, this report provides several additional pieces of information to assist the General Assembly.

Mandate Description - A short explanation of those portions of the bill which meet the mandate definition.

Committee(s) Reviewing Bill - A listing, beginning with the Committee of Cognizance, of all committees which considered the bill.

Office of Fiscal Analysis (OFA) Fiscal Impact Statement - The statements, if any, used by OFA to characterize the municipal fiscal impact of the mandate.

No matter how worthwhile, each mandate imposes a burden on municipalities. The burden of a specific mandate might be large, in and of itself, and the legislature's Office of Fiscal Analysis, as well as municipalities, school districts and organizations representing them call attention to such mandates during the legislative session. Many mandates, on the other hand, impose only a small burden individually and, therefore, attract little attention as focus is drawn to larger concerns. Multiple small mandates, however, can have a substantial cumulative impact, creating a hidden burden on municipalities and municipal officials.

The ACIR urges the General Assembly to consider the impact of state mandates on local governments. This is directly connected to the positive working relationship between the State and its cities and towns: state mandates represent the establishment of priorities and constraints for an individual city or town by officials representing other cities and towns. To the extent these mandates are unfunded or underfunded, such decisions can create an obligation for municipalities to raise additional funds or to change spending priorities from those that would reflect the will of the local community. Similar consideration should be also be given when enacting mandates that are funded at the onset, but whose funding might be reduced or discontinued in future years.

This list of mandates should not be considered to be a list of bad statutes. State and local officials concur that some state guidelines and requirements are appropriate under our system of government from both legal and practical standpoints. There are many governmental issues that are best administered by local governments, but in a manner that promotes statewide uniformity. These issues can range from elections to property assessment standards to police training to aspects of education administration and beyond. The details of such requirements and responsibility for the resulting costs have been, are now, and will continue to be the subjects of much debate.

#### **State Mandate Definition**

<u>Connecticut General Statutes Sec. 2-32b</u>. State mandates to local governments. Definitions. Cost estimate required. Procedures re bills creating or enlarging mandates.

#### (a) As used in this section:

- (1) "Local government" means any political subdivision of the state having power to make appropriations or to levy taxes, including any town, city or borough, consolidated town and city or consolidated town and borough, any village, any school, sewer, fire, water or lighting district, metropolitan district, any municipal district, any beach or improvement association, and any other district or association created by any special act or pursuant to chapter 105, or any other municipal corporation having the power to issue bonds;
- (2) "State mandate" means any constitutional, statutory or executive action that requires a local government to establish, expand or modify its activities in such a way as to necessitate additional expenditures from local revenues, excluding any order issued by a state court and any legislation necessary to comply with a federal mandate;
- (3) "Local government organization and structure mandate" means a state mandate concerning such matters as: (A) The form of local government and the adoption and revision of statutes on the organization of local government; (B) the establishment of districts, councils of governments, or other forms and structures for interlocal cooperation and coordination; (C) the holding of local elections; (D) the designation of public officers, and their duties, powers and responsibilities and (E) the prescription of administrative practices and procedures for local governing bodies;
- (4) "Due process mandate" means a state mandate concerning such matters as: (A) The administration of justice; (B) notification and conduct of public hearings; (C) procedures for administrative and judicial review of actions taken by local governing bodies and (D) protection of the public from malfeasance, misfeasance, or nonfeasance by local government officials;
- (5) "Benefit spillover" means the process of accrual of social or other benefits from a governmental service to jurisdictions adjacent to or beyond the jurisdiction providing the service;
- (6) "Service mandate" means a state mandate as to creation or expansion of governmental services or delivery standards therefor and those applicable to services having substantial benefit spillover and consequently being wider than local concern. For purposes of this section, applicable services include but are not limited to elementary and secondary education, community colleges, public health, hospitals, public assistance, air pollution control, water pollution control and solid

waste treatment and disposal. A state mandate that expands the duties of a public official by requiring the provision of additional services is a "service mandate" rather than a "local government organization and structure mandate";

- (7) "Interlocal equity mandate" means a state mandate requiring local governments to act so as to benefit other local governments or to refrain from acting to avoid injury to, or conflict with neighboring jurisdictions, including such matters as land use regulations, tax assessment procedures for equalization purposes and environmental standards;
- (8) "Tax exemption mandate" means a state mandate that exempts privately owned property or other specified items from the local tax base;
- (9) "Personnel mandate" means a state mandate concerning or affecting local government: (A) Salaries and wages; (B) employee qualifications and training except when any civil service commission, professional licensing board, or personnel board or agency established by state law sets and administers standards relative to merit-based recruitment or candidates for employment or conducts and grades examinations and rates candidates in order of their relative excellence for purposes of making appointments or promotions to positions in the competitive division of the classified service of the public employer served by such commission, board or agency; (C) hours, location of employment, and other working conditions and (D) fringe benefits including insurance, health, medical care, retirement and other benefits.

### **New State Mandates**

PA 19-4 (HB 5004) An Act Increasing The Minimum Fair Wage

### **Mandate Description**

Sec. 1. increases the C-mandate in Subsec. (i) of CGS 31-58 by increasing the minimum wage as specified.

## **Committee(s) Reviewing Bill**

Labor – Committee of Cognizance Appropriations

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: STATE MANDATE – Cost. The fiscal note explains that the bill increases costs to municipalities that employ minimum wage workers, with a cost of up to \$1 million for larger cities ranging down to a cost of <\$50,000 for towns of population <20,000. The fiscal note also mentioned the impact of wage compression, the likely increase in wages that are only slightly above the new minimum wage.

<u>PA 19-12</u> (HB 7082)

An Act Concerning The Inclusion Of Black And Latino Studies In The Public School Curriculum

## **Mandate Description**

Sec. 1 increases the existing mandate of CGS 10-16b by expanding each school district's program of instruction to include African-American and black studies and Puerto Rican and Latino studies and, at the secondary level, a black and Latino studies course. Sec 2 is a new mandate stating that the expansion of the mandate of CGS 10-16b requires the curriculum to include African-American and black studies and Puerto Rican and Latino studies. Sec. 4 is a new mandate requiring boards of education to offer the specified black and Latino studies course in grades 9-12, beginning in the 2022-2023 school year.

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: Local and Regional School Districts: STATE MANDATE - Cost of up to \$25,000 for larger districts beginning FY2021.

PA 19-17 (SB 164)

An Act Concerning Workers' Compensation Benefits For Certain Mental Or Emotional Impairments, Mental Health Care For Police Officers And Wellness Training For Police Officers, Parole Officers And Firefighters

### **Mandate Description**

Sec. 10 creates a new mandate requiring a municipal entity providing firefighter training to include resilience and self-care technique training.

#### **Committee(s) Reviewing Bill**

Labor – Committee of Cognizance Appropriations

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: Various Municipalities: STATE MANDATE - Cost and also mentions the cost for municipalities to provide coverage for workers' compensation claims and for a psychiatric examination to be performed on an officer prior to them returning to duty.

### PA 19-20 (SB 992) An Act Concerning The Trust Act

## **Mandate Description**

Sec. 1 creates a new mandate in CGS 54-192h requiring law enforcement agencies receiving a federal a civil immigration detainer to provide a copy of it and of any resulting notification to the individual. The legislative body of any municipality with a law enforcement agency that has provided ICE access to an individual must provide specified information to OPM on a monthly basis. Sec. 3 of PA 19-23 (SB 1115), signed the same day, constrains the potential extent of the mandate by accepting a good faith effort by a law enforcement agency to contact the designated individual who should receive the specified notification.

## PA 19-25 (SB 1) An Act Concerning Paid Family And Medical Leave Mandate Description

Sec. 3 creates a new mandate by establishing the Family and Medical Leave Insurance (FMLI) program and specifying its scope and procedures. A municipality's employees are not included unless it opts in through collective bargaining. Sec. 11 creates a new mandate by specifying procedures for an employer applying to use a private plan for a Family and Medical Leave Insurance (FMLI) plan. A municipality's employees are not included unless it opts in through collective bargaining. Sec. 13 creates a new mandate by requiring an employer annually notify its employees of the specified aspects of a Family and Medical Leave Insurance (FMLI) plan. A

municipality's employees are not included unless it opts in through collective bargaining.

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: Various Municipalities - Potential Cost and explains that the bill excludes municipal employees from participation but allows them to opt-in through collective bargaining, which could result in a cost to municipal employers associated with the expansion of leave benefits.

PA 19-36 (HB 5125) An Act Increasing The Property Tax Abatement For Certain First Responders

### **Mandate Description**

Sec. 1 expands the mandate of CGS 12-81w by increasing the emergency responder tax abatement by \$500 and by \$1000 beginning FY 2021-2022.

Planning & Development - Committee of Cognizance

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: Various Municipalities - Potential Revenue Loss, Less than \$50,000 per municipality.

PA 19-66 (SB 140) An Act Expanding Eligibility For Tax Relief For Certain Elderly Homeowners

### **Mandate Description**

Sec. 1 expands the mandate of CGS 12-170aa by expanding eligibilty for the tax abatement to include owners of property held in trust for the owner as specified.

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: Various Municipalities - Grand List Reduction

PA 19-77 (SB 1062) An Act Authorizing Municipal Climate Change And Coastal Resiliency Reserve Funds

#### **Mandate Description**

Sec. 1 creates a new mandate requiring the treasurer of a municipality that chooses to establish a Climate Change and Coastal Resiliency Fund to annually provide a detailed report on the condition of the fund to other municipal officials as specified and for that report to be part of the municipality's annual report.

**Environment – Committee of Cognizance** 

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: "The bill allows municipalities to establish a Climate Change and Coastal Resiliency Fund and ... fiscal impact to a municipality would depend on how such municipality chose to administer the Fund."

PA 19-90 (SB 380)

An Act Concerning The Use Of Force And Pursuits By Police And Increasing Police Accountability And Transparency

### **Mandate Description**

Sec. 1 expands the existing mandate of CGS 7-282e by adding the use of a chokehold or engagement in pursuit to the list of incidents that must be included in the specified record and by requiring an annual reporting of all such incidents.

Public Health – Committee of Cognizance Judiciary

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: The fiscal note said "none".

PA 19-100 (SB 1020)

An Act Concerning The Inclusion Of Instruction In Culturally Responsive Pedagogy And Practice In The Preservice Training, Professional Development And In-Service Training Provided To Teachers

### **Mandate Description**

Sec. 1 expands the mandate of CGS 10-148a by adding "training in culturally responsive pedagogy and practice" to the list of professional development training provided by boards of education. Sec. 2 expands the mandate of CGS 10-220a by adding "training in culturally responsive pedagogy and practice" to the list of inservice training provided by boards of education.

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: The fiscal note said "none".

PA 19-117 (HB 7424)

An Act Concerning The State Budget For The Biennium Ending June 30, 2021, And Making Appropriations Therefor,

And Provisions Related To Revenue And Other Items To Implement The State Budget

#### **Mandate Description**

Sec. 216 create a new mandate by requiring a municipality that is obligated to or that choose to become a municipal member of the CT Municipal Redevelopment Authority to hold a hearing, enter into a memorandum of understanding, appoint a local development board. Sec. 290 creates a new mandate requiring boards of education to post current and projected expenditures and revenues online as specified and to provide copies to the municipality's legislative body or board of selectmen. Sec. 382 creates a new mandate requiring non-state public employers receiving coverage under the state employee plan for nonstate public employees to submit an annual report including specified information regarding its employee health plan. Note: Sec. 196 is not identified as an increased mandate because, although it increases CGS 19a-231's obligation on health directors by requiring the use of standardized inspection form and guidelines that include a broader range of factors, it also increases the maximum fee for inspection is increased from \$100 to \$250.

OFA reported the mandates of Sec. 216, described the mandate of Sec. 290 as a procedural change that does not result in an impact, and said Sec. 382 is not anticipated to have a fiscal impact because the information is available to the employers either via the plan carrier or third-party administrator.

PA 19-118 (SB 920)

An Act Concerning The Department Of Public Health's Recommendations For Various Revisions To The Public Health Statutes

#### **Mandate Description**

Sec. 70 expands the mandate of Subsec. 75 of CGS 12-81 by exempting nursing homes from the property tax.

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: Various Municipalities - Potential Revenue Loss and the fiscal note mentions the grand list reduction to municipalities that host nursing homes. PA 19-146 (HB 6997)

An Act Requiring The Provision Of Information Concerning Domestic Violence Services And Resources To Students, Parents And Guardians

### **Mandate Description**

Sec. 1 creates a new mandate requiring boards of education to ensure that a student, parent, or guardian who expresses concern about domestic violence receives specified information concerning services and resources available to victims.

## Summary of OFA Municipal Fiscal Impact Statement (as relates to the mandate portion of the bill)

OFA reported: The fiscal note says "none".

<u>PA 19-147</u> (HB 7000)

An Act Concerning Training For Certain Public Safety And Emergency Services Personnel

### **Mandate Description**

Sec. 4 creates a new mandate requiring emergency service providers to have specified communication aid for handling situations involving people with autism spectrum disorder, cognitive impairment, or nonverbal learning disorder.

Children - Committee of Cognizance

An Act Concerning Workers' Compensation Benefits For Certain Mental Or Emotional Impairments, Mental Health Care For Police Officers And Wellness Training For Police Officers, Parole Officers And Firefighters

### **Mandate Description**

Sec 1 increases the mandate of CGS 31-275 by expanding workers' compensation coverage for police officers experiencing mental or emotional impairment. Sec. 2 creates a new mandate by making a diagnosis of post-traumatic stress disorder eligible for workmen's compensations coverage if it results from one of the listed qualifying events and also specifies procedures. Sec. 4 creates a new mandate requiring a law enforcement unit to provide an examination by a mental health professional for a police officer who is returning to duty as specified. Sec. 7 creates a new mandate requiring law enforcement units, fire departments, and municipal entities employing fire marshals or inspectors to adopt and maintain a written policy as specified and to make peer support and mental health care services available as specified.

Sec. 2 expands mandate of CGS 38a-516b by eliminating the restriction of benefit to people of age 12 and below and by increasing the benefit to one hearing aid per ear in two years.

## **State Mandate Reductions**

PA 19-8 (HB 6643) An Act Concerning Regional Animal Control Shelters

### **Mandate Reduction Description**

Sec. 1 reduces the mandate of CGS 22-331 by expanding the authorization for regional animal control officers to include towns of up to 50,000 population. The fiscal note says "Various Municipalities: Savings".

PA 19-37 (HB 5455) An Act Concerning Qualified Forest Fire Fighters

### **Mandate Reduction Description**

Sec. 2 reduces the mandate of CGS 7-314a by stating that members of a volunteer fire company or department will be construed to be employees of the state for the purpose of receiving compensation in accordance with the provisions of chapter 568 for death, disability or injury incurred while performing fire duties under direction of the State Forest Fire Warden or state forest fire personnel. The fiscal note says "none".

PA 19-67 (SB 265) An Act Concerning Certification Of Moderators And Alternate Moderators

### **Mandate Reduction Description**

Sec. 1 reduces the mandate of CGS 9-229 by increasing the duration of election moderator certification from 2 years to 4, reducing municipal costs associated with recertification. The fiscal note says "Various Municipalities - Potential Savings" and notes the savings if a reduced number of certification classes are necessary.

PA 19-117 (HB 7424)

An Act Concerning The State Budget For The Biennium Ending June 30, 2021, And Making Appropriations Therefor, And Provisions Related To Revenue And Other Items To Implement The State Budget

### **Mandate Reduction Description**

Sec. 271 reduces the mandate of CGS 10-262j by specifying additional criteria for which the minimum budget requirement (MBR) may be reduced. Sec. 272 reduces the mandate of CGS 10-262 by revising the calculation of how changes in aid impact the minimum budget requirement (MBR). The fiscal note says these sections result in a potential savings to local and regional school districts, with the savings to a district being dependent on the specific circumstances of the district.

PA 19-148 (HB 7064) An Act Concerning Municipal Veterans' Representatives

### **Mandate Reduction Description**

Sec. 1 reduces the mandate of CGS 27-135 by authorizing a municipality to designate a volunteer, not just a town employee to be the municipal veterans' representative. The fiscal note says: Various Municipalities - Potential Savings and mentions the potential savings for municipalities choosing to appoint volunteers, rather than employees, as municipal veterans' service contacts.

## Appendix B

Sec. 2-32c. Submission to General Assembly of list of state mandates. On and after January 1, 2019, the Connecticut Advisory Commission on Intergovernmental Relations, established pursuant to section 2-79a, shall, not more than ninety days after adjournment of any regular or special session of the General Assembly or September first immediately following adjournment of a regular session, whichever is sooner, submit to the speaker of the House of Representatives, the president pro tempore of the Senate, the majority leader of the House of Representatives, the majority leader of the Senate, the minority leader of the House of Representatives and the minority leader of the Senate a report which lists each state mandate enacted during said regular or special session of the General Assembly. Within five days of receipt of the report, the speaker and the president pro tempore shall submit the report to the Secretary of the Office of Policy and Management and refer each state mandate to the joint standing committee or select committee of the General Assembly having cognizance of the subject matter of the mandate. The secretary shall provide notice of the report to the chief elected official of each municipality.
