

This group, diverse in their experience, background, and membership role, all share a common desire- to act as the voice for individuals receiving services through the CT Bureau of Rehabilitation Services.

2023 brought continued challenges and opportunities for both BRS and the SRC, and both are working to position themselves to continue to solve and plan for these in 2024. Individuals receiving services remain the obvious focus of both, with the quality and accessibility of service delivery at the forefront of the decisions being made. The stability of Community Rehabilitation Providers across the state, as well as the accessibility of BRS offices and services, continue to be closely reviewed.

The SRC assisted with and offered insight into the CT Statewide Needs Assessment, prepared recommendations for BRS to be included in the State Plan and gave feedback on the VR portion of the State Plan. The SRC has welcomed several new member appointees this year and is grateful to have these committed new voices. We have also had several members exit after years of service to the SRC, and we are grateful for their commitment and the time they have given. Two successful planning retreats were held, with members reviewing the purpose and commitment necessary to move the work of the SRC forward and restructuring the committees of the SRC to better focus on the mandated functions of the group. New consumer satisfaction survey tools were explored, and the SRC looks forward to implementation of these in 2024. Members continued to represent CT on the Board of Directors of the National Coalition of State Rehabilitation Council, facilitating 2 national conferences over the year.

The SRC continues to be appreciative of the collaborative working relationship with BRS Director David Doukas, and other BRS staff. The SRC looks forward to this continued partnership in the next year.

Mission, Goals, Functions

MISSION

The State Rehabilitation Council (SRC) provides assessment, advice, and recommendations to the Bureau of Rehabilitation Services (BRS) and others regarding coordination and effectiveness of programs and strategies which promote community-based competitive employment for persons with disabilities.

GOALS

- To assess the effectiveness and delivery of vocational services provided by BRS to individuals with disabilities.
- To improve the coordination of vocational services among BRS, state agencies, and public and private entities for the benefit of BRS job seekers.
- To make recommendations to BRS, the Governor, the Rehabilitation Services Administration (RSA) and others for developing and improving strategies for the employment of, and vocational services for, individuals with disabilities.

FUNCTIONS

- To review, analyze, and advise BRS regarding its performance in carrying out its responsibilities as the state agency designated to administer the public Vocational Rehabilitation Program.
- To provide input to BRS regarding the Bureau's coordination of activities with Connecticut's workforce investment system.
- To review the effectiveness of, and consumer satisfaction with, the performance of the Bureau and other public and private agencies in providing vocational rehabilitation services to Connecticut residents with disabilities.
- To prepare and submit an annual report to the Governor of Connecticut and the Commissioner of the Rehabilitation Services Administration (RSA).
- To coordinate with other advisory councils in the state which oversee services to individuals with disabilities.
- To perform other functions as appropriate to the mission of the Council.

SRC Committees

THE PROGRAM REVIEW & EVALUATION COMMITTEE

Purpose:

The purpose of the Program Review and Evaluation Committee is to review and evaluate programs within BRS and provide recommendations for future presentations to the group. This committee will also be responsible for obtaining consumer viewpoints of their satisfaction with vocational rehabilitation services and the effectiveness of BRS in assisting consumers to obtain and maintain competitive employment.

Review of 2023 Accomplishments:

- Arranged for presentations and review of several BRS programs. CT Customized Employment, Level Up, BRS Data reporting, the new BRS website and changes to the Employment Consultants Division.
- Involved in the coordination and completion of the Comprehensive Statewide Needs
 Assessment, including discussion and contracting with vendors, identification of
 questions to be utilized, and focus areas.
- Surveyed other SRCs across the country for best practices regarding the collection of satisfaction surveys, in order to increase the responses and value of the data being received. Contacted several recommended sources that provide this service to explore options and pricing, with meetings still happening to determine a final service and product to utilize moving forward.
- Implemented a set meeting schedule for the committee.

Goals for 2024:

- Finalize plans and method for satisfaction surveys to be administered to recipients of BRS services, in order to gather more data to make decisions with.
- Continue collaboration with other SRCs across the country for best practices regarding the collection of satisfaction surveys, in order to increase the responses and value of the data being received.

- Seek out opportunities for collaboration among other SRCs across the country for best practices regarding the service types and supports for identified high needs groups.
- Develop template of questions to focus the presentations and review of BRS programs, as well as the recommendations and follow up questions that may come from those reviews.
- Continue to set a schedule for BRS staff members to present on programs and grants. Identified programs/grants for the 2024 calendar year will be: CT PIE; CT Customized Employment; Community Rehabilitation Providers
- Consideration and utilization of the Comprehensive Statewide Needs Assessment results to inform SRC input on BRS practices
- Monitor access to offices and services, to ensure adequate quality of supports are being provided to those seeking services and those choosing in person supports.

THE MEMBERSHIP COMMITTEE

Purpose:

The purpose of the Membership Committee is to recruit, interview, and nominate potential members to the SRC. They may assist in training SRC members to foster effective council teamwork.

Review of 2023 Accomplishments:

- Reviewed SRC full committee meeting notes and relevant forwarded information.
- Continued efforts to recruit potential candidates in accordance with Title I, Section 105 of the Rehabilitation Act 1973, as amended for appointment to the SRC from the Governor.
- Reviewed the SRC Membership Composition Mandates and those members filling the roles.
- All committee members developed a simple "Interview and Score" worksheet to use with
 potential candidates during the process and to be forwarded to the executive committee as
 requested.
- Three new candidates were recommended to the executive committee.
- Developed a postcard for recruiting businesses and offering information to the community.
- Published the postcard and increased exposure on the new BRS website.

Goals for 2024:

- Recruit potential candidates to fill historically vacant categories of membership on the SRC, specifically employers, individuals with disabilities, and individuals from parent and advocacy groups.
- Identify prospective members to invite to SRC meetings.
- Conduct SRC applicant interviews, facilitate new member orientation, and provide mentorship to foster the ongoing learning process of becoming an active and involved SRC member.

LEGISLATIVE, POLICY, & PLANNING COMMITTEE

Purpose:

The purpose of the Legislative, Policy, and Planning Committee is to assist in developing the State Plan and strategic plans for vocational rehabilitation services and stay updated on federal and state regulations related to employment of persons with disabilities to assure that the CT Rehab Council and BRS staff have the knowledge and skills, values and attitudes, and resources needed to facilitate CIE that is a win-win for all jobseekers, employees, and their current and prospective employers.

Review of 2023 Accomplishments:

- Developed a vision and mission statement for committee work to assure compliance with the purpose of the committee.
- Provided technical assistance to SRC discussions about WIOA and Level Up (Pre-Et Reviewed SRC full committee meeting notes) as well as policy discussions about, e.g., virtual vs. inoffice staffing and services.
- Provided technical assistance to SRC discussions about proposed legislation for the 2023 legislative session.
- Participated in conceptualization and implementation of the systems change activities of the Pathways to Integrated Employment grant (main work group, committees, and Communities of Practice).
- Supported the collaboration of BRS and the CT Department of Developmental Services, as well as BRS collaboration with other entities such as the UConn Center for Excellence in Developmental Disabilities, individuals with disabilities, employers, and CRPs.
- By proxy, assisted in preparation of the Annual Report, the VR portion of the Unified State Plan, and assured SRC input to the Unified State Plan.

Goals for 2024:

- To meet regularly as a committee.
- Develop policy recommendations to address:
- Streamlined eligibility and assessment processes that are person-centered and strengths-based in collaboration with systems changes via the PIE grant.
- Assure disability expertise is developed in other employment activities of the State of CT.

- Transition (pre-ETS) supports that build on individual strengths, existing skills, interest, and preferences and are family friendly.
- Barriers to BRS counsellors' ability to embrace "Employment First for All" values and skills to implement strategies to obtain and retain employment for challenging individuals.
- Other service gaps this group has identified from personal and professional experiences.
- Needs of people with disabilities not eligible for DDS, ASD, or other eligibility-based employment supports.
- Develop legislative recommendations as necessary:
- To support policy recommendations of this Committee.
- To assure legislative proposals at the state and federal levels are consistent with SRA mandates that support coordination, collaboration, braiding or blending of funds for individuals, and other activities to increase employment outcomes of people with disabilities in CT.
- As appropriate, to address multi-agency involvement with employment services for all disenfranchised populations without duplication of services or a "one-size fits all" approach.
- Consider or support external monitoring of BRS services that go beyond "counts and amounts."
- Assist and provide input to the SRC, and BRS by extension, in preparation of the Annual Report and the VR portion of the Unified State Plan.

The NCSRC strives to cultivate the strengths and necessary expertise of local SRCs, so they become effective, viable partners in the vocational rehabilitation (VR) program. While SRCs in each state collaborate with their local VR program to address common issues, members of the NCSRC share best practices and strategies to address common concerns. The NCSRC gives a national voice to jobseekers with disabilities as it works on issues that impact the VR program on the national level.

On behalf of people with disabilities, our national membership coalition will advocate for and work in partnership with the national public vocational rehabilitation system's continual quest for excellence.

The NCSRC currently consists of 53 SRCs of states and territories that provide public VR services. In addition to conference calls bi-monthly, the NCSRC hosts two training conferences each year that coincide with the national meetings of the Rehabilitation Services Administration (RSA). Message from the BRS Director

Dear Friends,

As 2023 draws to a close, it is my pleasure to share this year's annual report from Connecticut's State Rehabilitation Council (SRC). Connecticut's general Vocational Rehabilitation (VR) program is a part of the Department of Aging and Disability Services, Bureau of Rehabilitation Services (BRS). We welcome opportunities for collaboration with other programs to best aid individuals with disabilities. This report highlights the achievements of BRS to accomplish that mission and its partnership with the SRC.

In retrospect, 2023 was a year marked with great challenges, as well as the emergence of great opportunity within BRS and in public vocational rehabilitation program. Ongoing capacity issues precipitated by both internal staff attrition, as well as amongst external Community Rehabilitation Providers and other relied upon contracted vendors have made meeting consumer's demand for services difficult. The




Bureau has focused much energy on the recruitment and retention of staff, as well as in seeking to implement changes in our service delivery model to improve efficiency. Despite the many challenges, BRS was awarded the US Department of Education, Rehabilitation Services Administration, Disability Innovation Fund, Pathways to Partnerships grant. The Demonstration Project, which has been named "Bridge CT," will seek to examine the impact of early introduction of vocational planning and increase coordination of services amongst various partners that serve CT's population of students with disabilities. When coupled with additional staffing availed through recently passed state-level legislation and BRS already robust investment of resources to provide Pre-Employment Transition Services through our Level Up program, this grant will be leveraged to inspire system-wide advances in challenging and changing perspectives concerning the potential for students with significant disabilities to seek post-secondary training and competitive integrated employment. In addition, BRS continues to be sought to work closely with our partners in CT's Workforce system and directly with employers to ensure training programs and work environments are created with the principles of universal design and access in mind. The SRC's continued support and guidance has been invaluable as we have worked to address our capacity deficits, while at the same time developing strategies to maximize available opportunities to expand our VR program.

It is certain that BRS and the SRC will continue to collaborate next year, united in the common belief that all individuals should have the opportunity for competitive employment in an integrated setting where they can realize their full potential. I sincerely thank the SRC for all its great work, valuable guidance, and unwavering support of our VR program. We are excited and look forward to building our relationship in the next year and in the years to come.





BRS Statistics - Federal Fiscal Year 2023





Competitive Employment Federal Fiscal Year (FFY) 2023






Average # of Hours Per Week




