

Falls Free CT Kickoff Meeting

I. Introduction

Robin Tousey-Ayers welcomed everyone to the meeting and provided a brief introduction to the purpose of Falls Free CT.

II. Survey Results Highlights

Angela Vázquez thanked everyone who was able to complete the Falls Free CT survey that was shared after the kick-off meeting in September. A total of 65 survey responses were received. Based on the feedback and information provided, working group topics were selected, a new falls prevention program guide was developed, and a steering committee was formed.

The working group topics that were chosen include: community-based programming and screenings, community awareness and education, data collection and surveillance, home safety modifications and falls prevention technology, and workforce development and training. Working group meetings will be coordinated to meet monthly beginning in January 2025. Working groups will be very action oriented and a space where projects and initiatives can be planned and implemented collaboratively.

IV. Connecticut Steps to Safety Training

A Steps to Safety training will be offered in CT on Wednesday, March 19, 2025. The training will be led by an expert from the National Fire Protection Association. This training is open to all fire service, EMS, public health, injury prevention, elder care, and social service professionals who want to work together to reduce the impact of fire and falls among the older adults in their community. It is recommended that a team of 2-3 professionals from a municipality committed to offering STS attends together. More details and a registration link will be shared after the meeting.

VI. Title III-D Funding

Angela Vázquez shared about a funding opportunity for evidence-based falls prevention programs, such as A Matter of Balance, Tai Ji Quan Moving for Better Balance, and Bingocize. Each year, CT's five Area Agencies on Aging receive federal Title III-D funding through the Older Americans Act to offer evidence-based health promotion programs. Community agencies and organizations are invited to apply for Title III-D funding at the start of every year.
