1. What is the approximate dollar amount of donations and pledges that your organization has received to date in response to the Sandy Hook tragedy?

Since 12/14 our organization has received and or is pledged to receive \$95.2

Since 12/14 our organization has received and or is pledged to receive \$95,215. Our organization was formed prior to the events of 12/14. Consequently, is not clear if all proceeds received are in response to 12/14.

Of the \$95,215 received or pledged to receive, \$75,340 (net) was generated from one fundraiser sponsorded by Newtown in Boston. Through 3/31/13, \$16,937 of the proceeds from the Newtown in Boston fundraiser have been collected and the remaining \$58,403 is expected to be collected over the next few weeks.

All funding we have received was donor directed to EverWonder and will be used to further our charitable mission, which is to encourage a lifelong love- of- learning in children.

2. Will these funds be used solely for the Sandy Hook tragedy? If not, approximately what portion will be used for relief for victims and what other purposes, and in what proportions, will funds be used for?

The \$75,340 (net) received from the Newtown in Boston fundraiser is restricted to fund The EverWonder Experience, a temporary museum space that is providing free arts, science, and peace education programming to the children of Newtown (and surrounding communities). The remianing funds are unrestricted and may be used for other purposes.

3. Approximately how much has your organization spent to date related to the Sandy Hook tragedy?

Through 3/31/13, we have spent \$26,816 (including \$10,000 that is due to to the Sciencenter in Ithaca, NY for the acquisition of exhibits) to prepare The EverWonder Experience for use and for programming materials.

4. What services has your organization provided to those affected by the Sandy Hook tragedy? What populations or class of victims are being served by your organization in response to the Sandy Hook tragedy? What services does it expect to provide in the future?

The EverWonder Experience, which opened on April 6, 2013, is providing free arts, science, and peace-education programming to the children of Newtown (and surrrounding communities) until September 2013. While the prorgamming provided is not specifc to the direct and indirect victims, our intention is to provide all the children of Newtown unique programmig opportunities that help promote and excite learning through arts and science.

5. Has your organization provided funding to other organizations for purposes related the Sandy Hook tragedy? If so, which organizations have received those funds and what is the approximate dollar amount provided to them? How does your organization determine the need for funding?

N/A - No funding has been given to other organizations.
