Yes, the funds will be used for the Sandy Hook tragedy.

3. Approximately how much has your organization spent to date related to the Sandy Hook tragedy?

NPC has spent approx. \$25,200.00.

- Immediately following the tragedy, NPC offered a workshop consisting of a panel of grief counseling experts to the community.
- Counseling support sessions for the Sandy Hook School faculty and staff has been provided.
- -Counseling support sessions for spouses/significan others of Sandy Hook School faculty and staff
- NPC has offered and paid for year memberships at the Newtown Youth Academy to interested victims' families, first responders and families of surviving children.
 - NPC paid for the use of NYA for 3 day-long events for the children of Sandy Hook.
- -NPC helped fund the Toy Tree Shop to provide gift certificates to the Sandy Hook School students per the request of a specific donor.
 - 5. Has your organization provided funding to other organizations for purposes related the Sandy Hook tragedy? If so, which organizations have received those funds and what is the approximate dollar amount provided to them? How does your organization determine the need for funding?
