As NWC is a philanthropic and community service organization, many of our members immediately began assisting in their own way, rather than waiting for an "official" task. One of the first members to act owns a funeral home which provided services free of charge to eleven families. Other members provided food for memorial services, fundraising events, and provided meals for victims' families. Many members volunteered at the call center and donation warehouse. There were many other instances of personal volunteerism by NWC members within the community of which this writer is unaware.

Our Club sponsored a play as a fundraiser for Sandy Hook in February, 2013. 100% of ticket sales, less venue costs, were donated. The actor's customary fees were waived. Refreshments and decorations were also donated by members.

NWC members will undoubtedly continue to assist in any way they can.

5. Has your organization provided funding to other organizations for purposes related the Sandy Hook tragedy? If so, which organizations have received those funds and what is the approximate dollar amount provided to them? How does your organization determine the need for funding?

Our members voted to disburse the donations to our volunteer first responders and their families, especially to those who may not have other sources of immediate financial aid. With the exception of donations earmarked for specific groups or projects, all of our donations have been to first responder organizations which, in turn, distribute them to individuals.

As of May 31, 2013, NWC has disbursed a total of \$6,272.75 to the following organizations:
