Name of Organization: Save the Children Federation, Inc.

1. What is the approximate dollar amount of donations and pledges that your organization has received to date in response to the Sandy Hook tragedy?

Our organization did not raise or receive any money in connection with the tragic incident at Sandy Hook Elementary. We received a nominal amount of gifts-in-kind (GIK), specifically stationery and supplies.

2. Will these funds be used solely for the Sandy Hook tragedy? If not, approximately what portion will be used for relief for victims and what other purposes, and in what proportions, will funds be used for?

The small quantity of GIK items was used entirely for our Sandy Hook relief effort.

3. Approximately how much has your organization spent to date related to the Sandy Hook tragedy?

Approximately 15 Save the Children staff members devoted a total of about 68 working days to our Sandy Hook relief effort. The approximate value of their time devoted to that effort is \$28,599.47. We also expended two Child Friendly Spaces kits, which had a total retail value of \$1,300.

4. What services has your organization proved to those affected by the Sandy Hook tragedy? What populations or class of victims are being served by your organization in response to the Sandy Hook Tragedy? What services does it expect to provide in the future? **From December 14 to December 24, 2012 Save the Children provided its Child Friendly Spaces program to over 370 children whose families came to the John Read Intermediate School in Newtown for crisis counseling. Save the Children created the Child Friendly Spaces program and it is provided to children following emergencies through the world. It provides children with a safe, supportive environment and enables them to interact with peers. Many of the 370 children were from Sandy Hook Elementary and the program enabled the children to reconnect with their classmates and friends. We do not expect to provide services in the future.** 5. Has your organization provided funding to other organizations for purposes related to the Sandy Hook tragedy? If so, which organizations have received those funds and what is the approximate dollar amount provided to them? How does your organization determine the need for funding?

No, we have not provided funding to other organizations in connection with the Sandy Hook tragedy.

If so, what is the approximate dollar amount that your organization has provided to date and approximately how much direct financial assistance does it expect to provide in the future?
