Proposal Summary: Vanguard Health System ("Vanguard") and Greater Waterbury Health Network ("GWHN") are proposing the creation of a joint venture to purchase the assets of GWHN. The joint venture will be 80% owned by Vanguard and 20% owned by GWHN. The joint venture will purchase the assets of GWHN for \$45,000,000 plus/minus certain working capital adjustments and less certain liabilities being assumed. Additionally, the newly formed joint venture has committed to spending no less than \$55,000,000 towards capital improvements and the development and improvement of ambulatory services in the region.
