APPLICATION FOR INJUNCTIVE AND OTHER RELIEF FOR FAILURE TO COMPLY WITH CIVIL INVESTIGATIVE DEMAND

TO THE SUPERIOR COURT FOR THE JUDICIAL DISTRICT OF HARTFORD:

Petitioner Bryan Cafferelli, Commissioner of Consumer Protection of the State of Connecticut, represented by William Tong, Attorney General of the State of Connecticut, pursuant to General Statutes § 42-110k, affirms that:

- Petitioner Bryan Cafferelli is the Commissioner of Consumer Protection of the State of Connecticut ("Petitioner").
- 2. Petitioner is empowered by General Statutes § 42-110d to issue Civil Investigative Demands to any person relevant to an investigation of alleged violations of the Connecticut Unfair Trade Practices Act, General Statutes § 42-110a, et seq. ("CUTPA").
- 3. Respondent Joseph Bierbaum ("Bierbaum") is an individual residing in Connecticut.
- 4. Respondent Richard Scheinberg ("Scheinberg") is an individual residing in New York.
- 5. Bierbaum and Creative Career Trust are the members of Career Training Specialists, LLC, a Connecticut limited liability company with a business address of 745 Burnside Avenue, East Hartford, CT 06108.

- 6. Career Training Specialists, LLC operated Stone Academy, a for-profit technical school offering a practical nursing program, among others.
- 7. At all relevant times, Stone Academy was advertised and marketed as a nursing school capable of preparing students for examination and licensure as practical nurses.
- 8. The Commissioner of Consumer Protection and the Office of the Attorney General received reports and complaints that for some time Stone Academy misrepresented its capabilities as a nursing school in that, in reality, it: routinely failed to prepare its graduates to pass the NCLEX nursing exam; failed to provide sufficient, or sufficiently qualified, instructors to meet the needs of its students; failed to offer required clinical training that was compliant with state law governing licensed practical nurses; and knowingly and consistently overenrolled students despite its awareness of these problems.
- 9. On or about February 15, 2023, Stone Academy abruptly ceased offering instruction in all of its programs.
- 10. On March 15, 2023, Commissioner of Consumer Protection Michelle Seagull, through the Office of the Attorney General, served Respondent Bierbaum with a Civil Investigative Demand (CID) under the Connecticut Unfair Trade Practices Act (CID attached as **Exhibit A** hereto) by certified mail, return receipt requested ("Bierbaum CID").
- 11. The Bierbaum CID was served by certified mail on Bierbaum at his residence address of 114 Peria Drive, Rocky Hill, CT 06067 on or about March 15, 2023.

- 12. On March 15, 2023, Commissioner of Consumer Protection Michelle Seagull, through the Office of the Attorney General, served Respondent Scheinberg with a Civil Investigative Demand (CID) under the Connecticut Unfair Trade Practices Act (CID attached as **Exhibit B** hereto) by certified mail, return receipt requested ("Scheinberg CID").
- 13. The Scheinberg CID was served by certified mail on Scheinberg at his residence address of 11 Frank Circle, Islip, NY on or about March 15, 2023.
- 14. The CIDs seek information about Respondents' business practices in connection with their ownership and management of Stone Academy.
 - 15. Respondents' responses to the CID were due March 29, 2023.
- 16. As of the date of the filing of this Application, Respondents have failed to comply with or otherwise respond to the CIDs.
- 17. General Statutes § 42-110k provides that, upon failure of any person to comply with a CID, the Court may issue an order "[g]ranting injunctive relief to restrain the person from engaging in the advertising or sale of any commodity or the conduct of any trade or commerce that is involved in the alleged or suspected violation" of CUTPA.
- 18. One or more violations of CUTPA are suspected in connection with the operation, management, advertising, and/or marketing of Stone Academy.
- 19. General Statutes § 42-110k further provides that the Court may issue an order "granting such other relief as may be required" until the person complies with the CID.

Wherefore, pursuant to General Statutes § 42-110k, Petitioner moves for:

- An order that each Respondent comply with their respective CIDs within
 days.
- 2. An injunction restraining each Respondent from participating in the management or operation of any for-profit career training institution in the State of Connecticut;
- 3. An order that said injunctive relief will remain in effect until such Respondent complies with such CID and thereafter obtain this Court's permission to modify the order(s) entered;
- 4. A penalty of five hundred dollars (\$500.00) as against each Respondent per each day after the March 29, 2023 deadline in which such Respondent fails to comply with the CIDs;
 - 5. Such other relief as this Court may deem appropriate; and
 - 6. Costs of this proceeding.

HEREOF FAIL NOT, BUT MAKE DUE SERVICE AND RETURN ACCORDING TO LAW.

tive acts or practices in violation of the provisions of CUTPA. The Respondent is noti-

fied not to destroy, discard, alter in any manner, or transfer from their possession, any

Documentary material requested or identified in any of the Respondent's responses to the

Interrogatories and Document requests herein.

I. <u>DEFINITIONS</u>

This Civil Investigative Demand ("CID") shall be read and interpreted in accord-

ance with the definitions set forth below:

A. "All" means all or any, and "Any" means all or any.

- B. "And," "All," or "Or" shall be construed either conjunctively or disjunctively to bring within the scope of the request any information that might otherwise be construed to be outside its scope.
- C. "Communication" means all meetings, conversations, conferences, discussions, correspondence, emails, text messages, messages, telegrams, telefaxes, mailgrams, and all oral, electronic, and written expressions or other occurrences whereby thoughts, opinions or data are transmitted between two or more individuals.
- D. "Consumer" means and includes any person, a natural person, individual, governmental agency or entity, partnership, corporation, trust, estate, incorporated or unincorporated association, and any other legal or commercial entity however organized.
- E. "Connecticut Consumer" means any Consumer with an address in Connecticut.
 - F. "Contact" means any form of communication.
- G. "Custodian" means the person(s) who is/are most knowledgeable about the information and Documents requested herein, including:
 - The location and method of record keeping for the Documents responsive to this Request; and
 - The organization of the Documents as they are produced to the Commissioner pursuant to this Request.
 - 3. Respondent's process for identifying Documents responsive to this Request. The person(s) shall have the ability to authenticate and identify each Document provided by You pursuant to the standard found in Fed. R. Evid. 902(11).

- H. "Describe" or "Description" means to state with specificity all facts, including but not limited to time, comprising or pertaining to such fact, thing, condition, action or event, and to identify all individuals involved in such fact, thing, action or event.
- M. "Documentary Material" or "Document" shall mean all written or graphic matter or electronically stored information (ESI), whether in final or draft form, however produced, or reproduced, of every kind and description in your actual or constructive possession, custody, care or control, including without limitation, all writings, communications, text messages and e-mails, account documents, calendars or planners, charts, reports, diaries, drafts, drawings, faxes, graphs, travel records, memoranda, minutes, notes, papers, photographs, receipts, reports, scripts, statements, statistical records, studies, presentations, time sheets or logs, vouchers, weigh tickets, working papers, or any other tangible thing.

This Civil Investigative Demand is intended to cover Documents and ESI in every form or source in which such Documents or ESI exists or in which you possess it, including without limitation computer or electronic files stored on file servers, e-mail servers, work stations, desktops, hard drives, personal digital assistants (PDAs), smartphones, tablets (e.g., iPads) and other mobile electronic devices, or other electronic social or industrial/business web-based media (e.g., Facebook®, Twitter®, LinkedIn®) within your control, including personal devices that you have used at any time for work; records, data, reports, and queries derived from or residing in applications and databases, data compilations from which information can be derived, converted or translated into reasonably usable form, magnetic discs, magnetic strips, magnetic tape, recognition characters, microfiche, microfilm, optical characters, punched cards, punched paper tapes, audio

tapes or recordings, or video tapes or recordings. Documents and ESI are in your "constructive possession, custody, care or control" if they reside physically or digitally on your premises, and also if they reside at the facilities of or on the servers or other devices of third parties such as "cloud" providers, Document storage facilities, back up sites, and other entities with whom you contract to maintain or house your Documents and ESI.

- N. "Entity" means without limitation any corporation, company, limited liability company or corporation, partnership, limited partnership, association, or other firm or similar body, or any unit, division, agency, department, or similar subdivision thereof.

 - 3. a person other than a natural person (such as, for example, a firm, association, organization, business, partnership, trust, corporation, or public entity), its name, the address of its principal place of business, as well as, if it has a person other than a natural person

- that ultimately controls it, that other person's name and the address of that person's principal place of business;
- 4. a Document, the title of the Document, the author, the title or position of the author, the addressee, each recipient, the type of Document, the subject matter, the date of preparation, and its number of pages.
- P. "Including" means including but not limited to.
- Q. "Instructors" means instructors, teachers Or faculty at Stone Academy, whether employed, contracted, or otherwise engaged.
- R. "Person" includes a natural person as well as any firm, association, organization, business, partnership, trust, corporation, or public entity.
- S. "Refer" means to make a statement about, embody, discuss, describe, reflect, identify, deal with, consist of, establish, comprise, list, or in any way pertain, in whole or in part, to the subject of the Document request.
- T. "Relating To" or "In Relation To" means relating to, referring to, concerning, describing, pertaining to, evidencing, reflecting, regarding, constituting, involving, or touching upon in any way. Each of these terms may be used interchangeably herein and will be treated as encompassing all these meanings.
- U. "Relevant Period" means the period from January 1, 2017, through the present. Any Interrogatory or Request for Production of Documents framed in the present tense shall be construed to cover the entire Relevant Period or any part of it.
 - V. "Respondent" means Joseph Bierbaum.

- W. "Stone Academy," unless otherwise dictated by context, means Career Training Specialists, LLC and vice-versa.
 - X. "You" and "Your" mean Respondent.
- Y. The singular includes the plural and vice versa, and a verb tense includes all other tenses where the clear meaning is not distorted by the addition of another tense or tenses.

II. <u>INSTRUCTIONS</u>

The response to this CID shall be submitted in the following manner:

- A. <u>Time Period.</u> Except where otherwise explicitly indicated, this CID covers the Relevant Period. Any Interrogatory or Request for Production of Documents framed in the present tense shall be construed to cover the entire Relevant Period or any part of it.
- B. Preservation of Relevant Documents and Information; Spoliation. You are reminded of Your obligations under law to preserve Documents and information relevant or potentially relevant to this CID from destruction or loss, and of the consequences of, and penalties available for, spoliation of evidence. No agreement, written or otherwise, purporting to modify, limit or otherwise vary the terms of this CID shall be construed in any way to narrow, qualify, eliminate or otherwise diminish Your aforementioned preservation obligations. Productions in electronic format shall meet the specifications set out in Attachments 1 and 2, unless otherwise agreed to in writing with an Assistant Attorney General.
- G. Existing Organization of Documents to be Preserved. Regardless of whether a production is in electronic or paper format, each document shall be produced in the same form, sequence, organization or other order or layout in which it was maintained before production, including production of any document or other material indicating filing or other organization. Such production shall include any file folder, file jacket, cover or similar organizational material, as well as any folder bearing any title or legend that contains no document. Likewise, all Documents that are physically attached to each other in Your files shall remain so attached in any production; or if such production is electronic, shall be accompanied by notation or information sufficient to indicate clearly such physical attachment.
- H. Manner of Compliance Custodians/Search Terms/Technology-Assisted Review. As further set forth in Attachment 2, information must also be included in the metadata and load files of each production concerning the identity of each document's custodian, as well as information Identifying the particular document requests or information to which each document is responsive.

Electronic Document Production Specifications

Unless otherwise specified and agreed to by the Office of Attorney General, all responsive Documents must be produced in LexisNexis® Concordance® format in accordance with the following instructions. Any questions regarding electronic document production should be directed to the Assistant Attorney General whose telephone number appears on the CID.

- 1. <u>Concordance Production Components</u>. A Concordance production consists of the following component files, which must be produced in accordance with the specifications set forth below in Section 7.
 - A. *Metadata Load File*. A delimited text file that lists in columnar format the required metadata for each produced document.
 - B. *Extracted or OCR Text Files.* Document-level extracted text for each produced document or document-level optical character recognition ("OCR") text where extracted text is not available.
 - C. **Single-Page Image Files.** Individual petrified page images of the produced Documents in tagged image format ("TIF"), with page-level Bates number endorsements.
 - D. *Opticon Load File.* A delimited text file that lists the single-page TIF files for each produced document and defines (i) the relative location of the TIF files on the production media and (ii) each document break.
 - E. *Native Files.* Native format versions of non-printable or non-print friendly produced Documents.
- 2. <u>Production Folder Structure</u>. The production must be organized according to the following standard folder structure:
 - data\ (contains production load files)
 - images\ (contains single-page TIF files, with subfolder organization) \0001, \0002, \0003...
 - native_files\ (contains native files, with subfolder organization) \0001, \0002, \0003...
 - text\ (contains text files, with subfolder organization) \0001, \0002, \0003...

I. <u>DEFINITIONS</u>

This Civil Investigative Demand ("CID") shall be read and interpreted in accord-

ance with the definitions set forth below:

- A. "All" means all or any, and "Any" means all or any.
- B. "And," "All," or "Or" shall be construed either conjunctively or disjunctively to bring within the scope of the request any information that might otherwise be construed to be outside its scope.
- C. "Communication" means all meetings, conversations, conferences, discussions, correspondence, emails, text messages, messages, telegrams, telefaxes, mailgrams, and all oral, electronic, and written expressions or other occurrences whereby thoughts, opinions or data are transmitted between two or more individuals.
- D. "Consumer" means and includes any person, a natural person, individual, governmental agency or entity, partnership, corporation, trust, estate, incorporated or unincorporated association, and any other legal or commercial entity however organized.
- E. "Connecticut Consumer" means any Consumer with an address in Connecticut.
 - F. "Contact" means any form of communication.
- G. "Custodian" means the person(s) who is/are most knowledgeable about the information and Documents requested herein, including:
 - The location and method of record keeping for the Documents responsive to this Request; and
 - The organization of the Documents as they are produced to the Commissioner pursuant to this Request.
 - Respondent's process for identifying Documents responsive to this Request. The person(s) shall have the ability to authenticate and

identify each Document provided by You pursuant to the standard found in Fed. R. Evid. 902(11).

- H. "Describe" or "Description" means to state with specificity all facts, including but not limited to time, comprising or pertaining to such fact, thing, condition, action or event, and to identify all individuals involved in such fact, thing, action or event.
- M. "Documentary Material" or "Document" shall mean all written or graphic matter or electronically stored information (ESI), whether in final or draft form, however produced, or reproduced, of every kind and description in your actual or constructive possession, custody, care or control, including without limitation, all writings, communications, text messages and e-mails, account documents, calendars or planners, charts, reports, diaries, drafts, drawings, faxes, graphs, travel records, memoranda, minutes, notes, papers, photographs, receipts, reports, scripts, statements, statistical records, studies, presentations, time sheets or logs, vouchers, weigh tickets, working papers, or any other tangible thing.

This Civil Investigative Demand is intended to cover Documents and ESI in every form or source in which such Documents or ESI exists or in which you possess it, including without limitation computer or electronic files stored on file servers, e-mail servers, work stations, desktops, hard drives, personal digital assistants (PDAs), smartphones, tablets (e.g., iPads) and other mobile electronic devices, or other electronic social or industrial/business web-based media (e.g., Facebook®, Twitter®, LinkedIn®) within your control, including personal devices that you have used at any time for work; records, data, reports, and queries derived from or residing in applications and databases, data compilations from which information can be derived, converted or translated into

reasonably usable form, magnetic discs, magnetic strips, magnetic tape, recognition characters, microfiche, microfilm, optical characters, punched cards, punched paper tapes, audio tapes or recordings, or video tapes or recordings. Documents and ESI are in your "constructive possession, custody, care or control" if they reside physically or digitally on your premises, and also if they reside at the facilities of or on the servers or other devices of third parties such as "cloud" providers, Document storage facilities, back up sites, and other entities with whom you contract to maintain or house your Documents and ESI.

- N. "Entity" means without limitation any corporation, company, limited liability company or corporation, partnership, limited partnership, association, or other firm or similar body, or any unit, division, agency, department, or similar subdivision thereof.
- O. "Identify" means to set forth specific and detailed information, including, in the case of:

Such production shall include any file folder, file jacket, cover or similar organizational material, as well as any folder bearing any title or legend that contains no document. Likewise, all Documents that are physically attached to each other in Your files shall remain so attached in any production; or if such production is electronic, shall be accompanied by notation or information sufficient to indicate clearly such physical attachment.

ATTACHMENT 1

Electronic Document Production Specifications

Unless otherwise specified and agreed to by the Office of Attorney General, all responsive Documents must be produced in LexisNexis® Concordance® format in accordance with the following instructions. Any questions regarding electronic document production should be directed to the Assistant Attorney General whose telephone number appears on the CID.

- 1. <u>Concordance Production Components</u>. A Concordance production consists of the following component files, which must be produced in accordance with the specifications set forth below in Section 7.
 - A. *Metadata Load File*. A delimited text file that lists in columnar format the required metadata for each produced document.
 - B. *Extracted or OCR Text Files.* Document-level extracted text for each produced document or document-level optical character recognition ("OCR") text where extracted text is not available.
 - C. **Single-Page Image Files.** Individual petrified page images of the produced Documents in tagged image format ("TIF"), with page-level Bates number endorsements.
 - D. *Opticon Load File.* A delimited text file that lists the single-page TIF files for each produced document and defines (i) the relative location of the TIF files on the production media and (ii) each document break.
 - E. *Native Files.* Native format versions of non-printable or non-print friendly produced Documents.
- 2. <u>Production Folder Structure</u>. The production must be organized according to the following standard folder structure:
 - data\ (contains production load files)
 - images\ (contains single-page TIF files, with subfolder organization) \0001, \0002, \0003...
 - native_files\ (contains native files, with subfolder organization) \0001, \0002, \0003...
 - text\ (contains text files, with subfolder organization) \0001, \0002, \0003...
- 3. <u>De-Duplication</u>. You must perform global de-duplication of stand-alone Documents and email families against any prior productions pursuant to this or previously related CIDs.

- 4. Paper or Scanned Documents. Documents that exist only in paper format must be scanned to single-page TIF files and OCR'd. The resulting electronic files should be pursued in Concordance format pursuant to these instructions. - 5. Each data file must also have an accompanying summary file that provides total row counts for the entire dataset and total row counts.

B. Compression

- 1. If Documents are provided in a compressed archive, only standard lossless compression methods (e.g., gzip, bzip2, and ZIP) shall be used. Media files should be provided in their original file format, with metadata preserved and no additional lossy encoding applied.

Metadata Load File

- Required file format:

 - Windows formatted CR + LF end of line characters, including full CR + LF on last record in file.
 - o .dat file extension
 - o Field delimiter: (ASCII decimal character 20)
 - o Text Qualifier: þ (ASCII decimal character 254). Date and pure numeric value fields do not require qualifiers.
 - o Multiple value field delimiter: ; (ASCII decimal character 59)
- The first line of the metadata load file must list all included fields. All required fields are listed in Attachment 2.
- Fields with no values must be represented by empty columns maintaining delimiters and qualifiers.
- *Note:* All Documents must have page-level Bates numbering (except Documents produced only in native format, which must be assigned a document-level Bates number). The metadata load file must list the beginning and ending Bates numbers (BEGDOC and ENDDOC) for each document. - For Documents produced only in native format, You must assign a single document-level Bates number and provide an image file placeholder that states "Document produced only in native format."
