Re: *Violations of Eventbrite's Community Guidelines prohibiting content that promotes the use and sale of cannabis.*

Dear Ms. Taylor:

Our Office has become aware of cannabis-related events promoted on Eventbrite that violate posted Community Guidelines prohibiting content promoting the use or sale of cannabis on Eventbrite. These posts may also violate Connecticut law. We request that you remove such content immediately and take steps to prohibit such future content.

Eventbrite specifically prohibits “posting events that promote the use or [sale] of cannabis,” including “[c]annabis or cannabis-infused products (including CBD) provided for free, for sale by the Organizer, or as part of the ticket purchase (including free samples, infused food/beverage, gift bags, product discounts, and giveaways), attendee sharing of cannabis, teaching how to grow or extract cannabis (including infused cooking classes), or dispensary tours.”¹ Further, “[t]his policy applies regardless of cannabis’ legality in a jurisdiction.”²

Our Office is aware of several groups posting events that promote the use and sale of cannabis in Connecticut on Eventbrite, including HighBazaar and The High Life. Corresponding photos of such events follow this letter. These events are not legal under Connecticut law and the advertising of such events may violate the Connecticut Unfair Trade Practices Act (“CUTPA”), Conn. Gen. Stat. § 42-110b, et seq, and the Responsible and Equitable Regulation of Adult Use Cannabis (“RERACA”), Conn. Gen. Stat. § 21a-420, et seq.

We request that Eventbrite immediately remove all content related to the use or sale of cannabis and provide our Office with confirmation that it has been removed. In addition, we request that


