### <u>Directions to Chief State's Attorney's Office</u>

300 Corporate Plaza, Rocky Hill

#### From New Haven and points south

- \* Get to I-91 north
- \* Take Exit 23 (West St.).
- \* Turn left at the end of the ramp onto West St.
- \* Cross the highway and take the first right into Corporate Plaza.
- \* Follow this road past the last building on the right; then bear <u>right</u> to go around to the back side of the building.
- \* Park in the parking lot. The building entrance is adjacent to the parking lot.
- \* Note that, from the I-91 exit, you can follow the green directional signs to the Chief State's Attorney's Office.

#### From Hartford and points north

- \* Get to I-91 south.
- \* Take Exit 23 (West St.).
- \* Turn right at the end of the ramp onto West St.
- \* Take the first right into Corporate Plaza.
- \* Follow this road past the last building on the right; then bear <u>right</u> to go around to the back side of the building.
