## Requirements for Spotted Lanternfly Compliance Agreement

- 1. Regulated articles defined by the State of Connecticut, but are not limited to:
  - a. Any living life stage of the spotted lanternfly;
  - b. Outdoor industrial and construction materials and equipment, concrete barriers or structures, stone, quarry material, ornamental stone or concrete, construction, landscaping and remodeling waste;
  - c. Shipping and storage containers. This shall include, but is not limited to, wood crates, pallets, boxes, personal moving containers, and barrels;
  - d. Outdoor household articles including recreational vehicles, lawn tractors and mowers, mower decks, grills, grill and furniture covers, tarps, mobile homes, tile, stone, deck boards, mobile fire pits, any equipment, trucks, or vehicles not stored indoors;
  - e. Conveyances of any type, whether utilized for movement of the materials previously listed or personal use, and any trailers, wagons, or other equipment attached hereto;
  - f. Agricultural equipment including, but not limited to, tractors, harvesting equipment, and rigid containers such as shipping containers, pods, and large bins;
  - g. Any other article, material, or means of conveyance determined by an authorized person to be a "regulated article" that is infested, has the potential to be infested, or present a risk of dissemination of any life stage of spotted lanternfly.
- 2. The State of Connecticut is quarantined and areas with established infestations of spotted lanternfly are designated as regulated areas. In addition, the Director of the Connecticut Agricultural Experiment Station (CAES) or authorized persons may designate as regulated any area where an infestation of spotted lanternfly is confirmed in the future by supplementary notice made available on the CAES website (https://portal.ct.gov/caes). Information on additional regulated areas will be posted on this website. The movement of any regulated article from an area designated as regulated will be subject to guidelines established for the movement of regulated articles. A current printed listing will also be available upon request at The Connecticut Agricultural Experiment Station, 123 Huntington Street, New Haven, CT 06511, or the CAES website at <a href="https://www.portal.ct.gov/caes">www.portal.ct.gov/caes</a>.
- 3. This compliance agreement is for business activities that include work within regulated areas such as landscaping, utilities, construction, services, or transport of goods. Residents traveling from or moving from regulated areas and moving companies should use the spotted lanternfly checklist available on the CAES spotted lanternfly website.
- 4. Movement of the regulated articles from any regulated area to any destination outside the regulated area is prohibited, except under the following conditions:
  - a. No person shall transport any regulated article within the State of Connecticut that is:

- 1. Infested with spotted lanternfly; or
- 2. Originates from a regulated area without determination it is free of spotted lanternfly.
- b. Employees should be trained to recognize all stages of spotted lanternfly. Employee training PowerPoints are available on the CAES and Penn State Extension spotted lanternfly websites.
- c. Regulated articles may be moved outside of the regulated area when they are determined to be free of all viable spotted lanternfly life stages. Determination of freedom will be based upon visual survey and removal or mitigation of spotted lanternfly, if necessary, from the article. Checks for spotted lanternfly are to be accomplished by appropriate employees, trained to look for all stages of spotted lanternfly. Use the business compliance checklist prior to travel or movement of items from regulated areas.
- d. Upon discovery of spotted lanternfly, persons or businesses may cooperate with federal, state, and local officials and survey public and private areas surrounding the initial point of infestation to determine the extent of the insect pest's geographic distribution and establish the regulated areas in the state or any portion thereof. Approved methods of treatment or mitigation of regulated articles will be solely at property owner's expense. Movement of regulated articles in a regulated area is restricted and shall comply with provisions established pursuant to subsections (e-f) of this section and applicable requirements of quarantine orders in other states if article is moved out of state. A business is wholly responsible for meeting applicable spotted lanternfly orders in other states.
- e. Although apparently free of infestation, it is recommended that a thorough inspection either in a holding area or before loading be given by business personnel of all material, means of conveyance, or vehicle before being moved outside of the spotted lanternfly regulated area. All regulated articles destined for movement outside of the regulated area must be checked and safeguarded to prevent infestation. If receiving regulated articles from within a spotted lanternfly regulated area, regulated articles should be thoroughly inspected to establish their freedom from spotted lanternfly infestation.
- f. Movement of any means of conveyance from a regulated area in compliance with a written agreement between the business and the CAES shall include all of the following:
  - 1. The name and address of the business;
  - 2. The type and amount of material that may be moved under the agreement (e.g., number of utility trucks);
  - 3. The names and addresses of the persons to whom, and the locations to which the materials or conveyance may be moved under the agreement;

- 4. The locations from which the material may be moved under the agreement;
- 5. The method by which the material may be moved;
- 6. The time-period covered by the agreement;
- 7. A provision authorizing the CAES to terminate the agreement, without prior notice, for any reason;
- 8. For shipped material, a certificate must accompany each shipment indicating that the product is under a compliance agreement.
- 5. Non-plant related regulated articles from regulated areas may only leave this state under compliance agreement or if they are inspected and found free of spotted lanternfly using the spotted lanternfly checklist. The checklist must state that no spotted lanternfly was found on the regulated articles and the checklist must accompany the regulated article from origin to destination.

## Requirements for all quarantines:

- 1. CAES inspectors retain the right to make spot checks for compliance with the agreement.
- 2. CAES will furnish the service of CAES inspectors without cost. Other than the service of CAES inspectors, CAES will not be responsible for any costs or charges incident to inspections or compliance with this or any other quarantine.
- 3. The establishment will notify CAES of any personnel or other changes which may affect the handling of regulated articles.
- 4. Failure to comply with the spotted lanternfly quarantine and/or the provisions of this compliance agreement may result in the cancellation of this compliance agreement.
- 5. Any other recommendations of CAES inspectors to eliminate the hazard of transporting infested regulated articles will be followed.
