The Connecticut Agricultural Experiment Station is seeking applications for anticipated summer farm worker positions from May through October to assist the Farm Manager with field work and maintenance at the Lockwood Farm, located at 890 Evergreen Avenue, Hamden, CT. This is an excellent opportunity for those interested in a career in agriculture to improve their resume. Applicants must be at least 18 years old. Work hours are Monday through Friday, 8:00 a.m. to 4:00 p.m., 7 hours/day, 35 hours/week, \$17.00/hour.

Suggested duties may include, but are not limited to, equipment and property maintenance, mowing, field preparation, watering, fertilizing, planting, weeding, and irrigating. The candidate must be able to work outdoors and be willing to operate farm and power equipment, including mowers and trimmers.
