### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is executed as of the 234 day of
, 2013, by and between the TOWN OF EAST LYME, acting herein by
its Water and Sewer Commission ("East Lyme") and the TOWN OF MONTVILLE, acting
herein by its ("Montville").

### RECITALS

WHEREAS, East Lyme and the City of New London ("New London") have entered into a Regional Water Interconnection Agreement ("Interconnection Agreement"), whereby East Lyme will transmit and receive potable water to and from the New London Lake Konomoc Water Treatment Facility in the Town of Waterford, located on Connecticut Route 85; and

WHEREAS, pursuant to the Interconnection Agreement East Lyme will construct an underground water main that will run from the present terminus of the East Lyme water main located in Connecticut Route 161 near the East Lyme/Montville town line, thence running in a northeasterly direction in and along Route 161 in Montville to its intersection with Butlertown Road, thence running in a southeasterly direction in and along Butlertown Road to its intersection with Satchatello Drive, thence in a northeasterly direction along said road to its intersection with Connecticut Route 85, thence southeasterly in and along Route 85 past the Waterford town line to its terminus at the Lake Konomoc Water Treatment Plant; and

WHEREAS, a portion of the water main running in and along Route 161, Butlertown Road, Satchatello Drive and Route 85 passes through lands located within Montville; and

WHEREAS, East Lyme will own, operate and maintain the above described water main; and

WHEREAS, East Lyme has agreed to provide fire service connections to certain lots located along Butlertown Road and Satchatello Drive in Montville; and

WHEREAS, East Lyme and Montville desire to execute this MOU setting forth their mutual understanding as to the terms and conditions under which East Lyme will operate and maintain the water main;

NOW, THEREFORE, in consideration of the premises recited above and the undertakings of the respective parties set forth below, East Lyme and Montville hereby agree to the following terms and conditions regarding the operation and maintenance of the water main:

- 1. East Lyme shall provide fire service connections only to the following lots located on Butlertown Road and Satchatello Drive: lots 16, 17, 18, 43, 44, 45, 46, 47, 48, 49 and 50, as set forth on a map entitled "Information Requested by Department of Public Health Drinking Water Section, Montville Industrial Lots," prepared by the Montville Planning Department, a copy of which is attached hereto as Exhibit A and made a part hereof. Provided, however, that lot 17, which is owned by East Lyme and will be used for a water storage tank and related facilities, may also be connected to the water main for the purpose of conveying water to and from said water storage tank.
- Montville shall record on the Montville land records notices that water service from East Lyme for the above identified lots shall be for the purpose of fire suppression systems only, and shall not be provided for domestic purposes or uses.
- 3. Each fire service connection for the lots identified above shall be metered, and East Lyme shall take and record meter readings on a routine basis to ensure that no water is being used for domestic purposes or uses. If domestic water use is suspected, East Lyme shall investigate, remediate, and report same to the Connecticut Department of Health Drinking Water Section ("DWS"). East Lyme shall make such meter readings available to DWS during routine sanitary surveys.
- 4. East Lyme shall not provide fire suppression water supply to the above identified lots until East Lyme has reviewed the proposed domestic water source and plumbing plans for fire protection and domestic water systems for existing or proposed buildings on said lots and has determined that the lot is eligible for fire suppression water supply under Section 1 of this MOU and that the fire connection system is independent of the domestic water supply. The Town of East Lyme shall provide written notification of the review and determination made under this Section on any identified lot in Section 1 of this MOU to the Connecticut Department of Public Health's Drinking Water Section prior to the provision of fire suppression water to that lot. Nothing in this MOU shall be construed to alleviate compliance with applicable laws, regulations, ordinances and/or codes of the Town of Montville, including without limitation building and fire codes. All installations permitted by this MOU shall also be subject to review and inspection by the Town of Montville to ensure compliance with such codes.
- 5. This agreement shall not be construed as prohibiting East Lyme from establishing and collecting connection fees and/or water usage rates for the above identified lots which are served by a fire service connection. East Lyme

- may, in its sole discretion, impose such fees and charges as it deems necessary, consistent with East Lyme's rates for such benefits and services.
- 6. East Lyme reserves the right to establish and collect fees consistent with actual expenses incurred for hydrants used for firefighting purposes in municipalities where the interconnection main is located. No such fees may be charged for hydrants designed and intended solely for flushing and maintenance purposes.
- 7. East Lyme shall indemnify and hold Montville harmless from any losses, damages, claims and/or injuries resulting from any negligent and/or intentional acts and/or omissions of East Lyme in connection with, arising out of and/or relating to this MOU and/or the Interconnection Agreement.
