2.0 CONSULTATION AND COORDINATION

2.1 <u>THE CEPA PROCESS</u>

The format and content of the subject Environmental Impact Evaluation (EIE) are based upon the requirements of the Connecticut Environmental Policy Act (CEPA), Sections 22a-1 through 22a-1h of the Connecticut General Statutes (CGS), and Sections 22a-1 through 22a-1a-12 of the Regulations of Connecticut State Agencies (RCSA). State funds will be used for the design, construction, and/or renovation of the proposed facilities, thus triggering the CEPA process. The sponsoring agency of this project is the University of Connecticut (University).

CEPA recognizes the complex relationship between the natural environment and human actions. The CEPA regulations outline a process whereby, through coordination with local, regional, state, and federal governments as well as public and private entities, a sponsoring state agency can determine and minimize impacts to the resources of the state. A major function of the CEPA process is the determination of whether or not a proposed action will have a "significant effect." Significant effect means substantial adverse impact on the environment (RCSA 22a-1a-1, Definitions). Agencies preparing such CEPA documents must consider direct and indirect effects as well as cumulative impacts. Public input and participation are major components of the CEPA process. Therefore, early scoping and information exchange is essential.

Public participation in the CEPA process is encouraged through contact with interested persons and affected agencies. Public project notices were published in the *Environmental Monitor*, a semimonthly online publication published by the Council on Environmental Quality (CEQ), the state agency responsible for public outreach related to the CEPA process. The overall process for public participation and approval of the EIE is summarized below.

- The sponsoring agency must notify state review agencies and other interested parties with regard to the proposed action via a scoping notice. The following notices were published in the *Environmental Monitor* on the CEQ website in accordance with CEPA regulations:
 - The University distributed a notice for the subject project on June 7, 2011, a copy of which is included in Appendix A.
 - The University later amended the scope of the EIE (adding an alternative for the relocation or replacement of Fenton River Wellfield Well A) and issued a second scoping notice on December 20, 2011 (Appendix A).
 - The University later amended the scope of the EIE a second time (adding an alternative for an interconnection with the Metropolitan District Commission [MDC]) and issued a third scoping notice on June 5, 2012 (Appendix A).
- Reviewers are given a minimum of 30 calendar days to respond to the scoping notice with comments about the nature and extent of environmental impacts that might result. The due date for comments was posted in the *Environmental Monitor* on the CEQ website.



- In the initial case, July 7, 2011 was close of the comment period.
- The close of the public comment period for the first revised scoping notice was January 19, 2012, but it was later revised to February 1, 2012.
- The close of the public comment period for the second revised scoping notice was July 6, 2012.
- Upon the request of 25 or more people, the sponsoring agency must hold a public scoping meeting to further explain the proposed action. Notices of meetings must be published in the *Environmental Monitor* on the CEQ website.
 - Although no such requests were made for the initial project scoping, the University, in collaboration with the Town of Mansfield, voluntarily held a scoping meeting on June 28, 2011. Several residents of Mansfield attended.
 - The University received 56 requests for a public scoping meeting related to the revised scoping notice published on December 20, 2011. The meeting was held on January 24, 2012 and moderated by the University. Approximately 20 people attended, the majority of whom were residents of Mansfield.
 - The University did not receive any requests for a public scoping meeting related to the second revised scoping notice published on June 5, 2012, but a meeting was held on June 21, 2012 and moderated by the University. Approximately 30 people attended, the majority of whom were residents of Mansfield.
- During the preparation of an EIE, the sponsoring agency must consider the issues and comments provided by the reviewers along with other information gathered. Copies of written scoping comments received from all comment periods are included in Appendix B.
- After the EIE is prepared, the sponsoring agency must publish notice of its availability and circulate the EIE for review and comment. Parties to whom the EIE was sent are listed in Section 2.6. Interested parties may provide written comment within 45 days.
- Upon the request of 25 or more people, the sponsoring agency must hold a public hearing in accordance with state statutes and Section 22a-1a-11 of the regulations. A period of no less than 30 days following the date of availability of the EIE must transpire before such public hearing is held.
- The sponsoring agency must review comments, perform any additional environmental study and analysis, and amend the evaluation as appropriate. It is the sponsoring agency's responsibility to respond to all substantive comments received. The agency then finalizes the EIE and prepares its Record of Decision (ROD).
- The sponsoring agency must forward its ROD and the EIE to the Connecticut Office of Policy and Management (OPM) for a determination of the adequacy of the evaluation. The following information is included:



- 1. Public notice documentation
- 2. A transcript of the public hearing if one is held
- 3. Comments received from all interested parties along with responses to the pertinent issues raised by the public and state agencies
- 4. The agency decision relative to proceeding with the proposed action
- 5. Intentions for initiating actions for reducing impacts
- The CEPA process concludes with the review of the EIE and ROD by the OPM and its determination of whether or not regulatory requirements have been satisfied. The EIE and ROD are the basis for the implementation of the eventual project.

2.2 SCOPING

This project included three scoping periods. The initial scoping period considered the evaluation of the potential no action, two potential interconnections, and two categories of potential new wellfield alternatives. The second scoping period included the potential relocation or replacement of Fenton River Wellfield Well A as a potential alternative. The final scoping period included an interconnection with MDC as a potential alternative to be evaluated as part of this EIE.

The initial scoping period opened on June 7, 2011, closed July 7, 2011, and included a public information meeting. Agency comments were received from the Connecticut Department of Energy & Environmental Protection (CT DEEP) and the Connecticut Department of Public Health (DPH). Municipal comments were received from the Town of Mansfield Four Corners Sewer and Water Advisory Committee (MFCSWAC). Public comments were received from The Connecticut Water Company (CWC), the Willimantic River Alliance, and two members of the public. Copies of the comment letters received are included herein as Appendix B. In addition, verbal comments were recorded at the meeting. A summary of the nature of these comments is also included in Appendix B.

The second scoping period opened on December 20, 2011, closed February 1, 2012, and included a public information meeting to present and solicit comments on the inclusion of a potential relocation of Fenton River Well A. Agency comments were received from the CT DEEP and the DPH. Public comments were received from the Connecticut Forest & Park Association and four members of the public. Copies of the comment letters received as a result of the scoping notice are included herein as Appendix B. In addition, verbal comments were recorded on the transcript of the meeting. A summary of the nature of these comments is also included in Appendix B.

The third scoping period opened on June 5, 2012, closed July 6, 2012, and included a public information meeting to present and solicit comments regarding a potential interconnection with MDC. Agency comments were received from CEQ, CT DEEP, and DPH. Public comments were received from CWC, the Farmington River Watershed Association (FRWA), and four members of the public. Copies of the comment letters received as a result of the scoping notice are included herein as Appendix B. In addition, verbal comments were recorded on the transcript of the meeting. A summary of the nature of these comments is also included in Appendix B.
