Address of possible location: The Heroes Tunnel: Wilbur Cross Parkway (Route 15) from Mile Point 46.92 to 47.59

Municipalities where proposed action might be located: Hamden, New Haven, and Woodbridge

Project Description: The purpose of this project is to address structural deterioration and install new fire life safety systems within the Heroes Tunnel to improve the tunnel serviceability and safety along Route 15. The proposed scope includes installing a new ventilation system consisting of jet fans supported by steel structures at the top of the tunnel barrels, replacing the concrete tunnel liner, full depth reconstruction of the Route 15 roadway and groundwater drainage systems within the tunnels, replacing the tunnel lighting electrical system, adding a fire detection system and hydrants, improving emergency egress features and constructing an ancillary building to house new electrical equipment for the fire and life safety system. The project also involves architectural modifications and repairs to the ventilation building.

The Heroes Tunnel is considered eligible for listing on the National Register of Historic Places (NRHP) and coordination with the CT State Historic Preservation Office (CTSHPO) has begun in accordance with Section 106 of the National Historic Preservation Act.

Address of possible location: 18 Christopher Columbus Avenue

Municipality where proposed action might be located: Danbury

Project Description: The City of Danbury (City) owns and operates the Kenosia Well Field and Kenosia Flood Skimming Pump Station. The Kenosia Wells are currently inactive due to trichloroethylene (TCE) and tetrachloroethylene (PCE) contamination, which are both volatile organic compounds (VOCs), and per- and poly fluoroalkyl substances (PFAS) that exceed Connecticut Department of Public Health (DPH) Action Levels.

The City is proposing to construct a new water treatment facility with aeration towers for VOC removal and carbon contactors for PFAS removal; and to rehabilitate the groundwater wells to continue conveying water to the West Lake Reservoir as part of their water supply needs. The proposed 2.5 million gallons per day (mgd) treatment facility will house two (2) granular activated carbon (GAC) contactors, two (2) wet wells, three (3) vertical turbine pumps, and associated piping. Two (2) packed tower aerators will be located adjacent to the proposed building. This project will allow the City to operate the existing Kenosia Flood Skimming Pump Station and the proposed water treatment facility simultaneously, which will be required in the future for the City to achieve their projected long term water supply safe yield.

The project includes modifications to existing yard piping to connect the proposed treatment building to the existing transmission main which conveys water to the West Lake Reservoir. Site work includes new 12-inch and 16-inch ductile iron water main, valves, hydrants, fittings and appurtenances; buried electrical service; concrete walkway and asphalt driveway for building access; and replacement of the site security fencing. Additional site improvements include a stormwater infiltration basin.

As the entire project area is proposed within the one-percent annual chance (aka 100-yr) flood plain, the proposed project could impact flood storage. To mitigate the loss of flood storage, additional excavation (East Basin) is proposed east of the water treatment facility and existing Well No. 2.

Project Description: Due to the presence of per- and polyfluoroalkyl substances (PFAS) in the groundwater supply serving the Indian Springs Water System, Aquarion Water Company (Aquarion) proposes to consolidate the Indian Springs Water System with the Cedar Heights – New Milford Regional Water System. The proposed project includes installation of approximately 3,500 linear feet of new water main along Forty Acre Mountain Road and Stadley Rough Road in Danbury, Connecticut, to create a permanent interconnection between the systems. Miscellaneous improvements will be made at the existing Indian Springs Booster Station to control the feed to the Indian Springs low-service water level. Modifications will also be made at the existing Cedar Heights Booster Station to allow an increase in the hydraulic grade line (HGL) of the Cedar Heights system; these modifications will be limited to interior electrical and mechanical work.

The proposed interconnection and associated improvements are intended to improve drinking water quality, enhance system reliability, provide operational redundancy, and reduce long-term operational costs for the Indian Springs Water System.

Project Description: The MOVE New Haven Bus Rapid Transit (BRT) Project is aimed at improving transit service along the four highest ridership routes (212, 238, 246, 265) in the CTtransit New Haven Division. Building on the recommendations of the [2019 MOVE New Haven Transit Mobility Study](#), the project seeks to enhance the quality, reliability, and speed of bus service through the introduction of limited-stop, on-street BRT service while also improving the safety of all corridor users. This effort is supported by a \$25 million federal RAISE grant and additional state funding, reflecting a commitment to improve bus service, infrastructure, safety, and accessibility. The project includes dedicated bus lanes, as well as transit signal priority (TSP), upgraded signal equipment, and enhanced pedestrian safety measures. Improvements will also include BRT-branded stops with amenities, multimodal accessibility upgrades, and mobility hubs designed to facilitate transfers and accommodate electric bus charging at the end of each BRT line. These elements aim to deliver shorter travel times, improve schedule reliability, and create a safer, more accessible environment for all road users.

The overarching goals of the MOVE New Haven BRT Project include:

- Faster travel times for BRT services along the four highest ridership routes
- Improved customer comfort and experience through upgraded stops and amenities
- Enhanced schedule reliability via TSP and corridor signal coordination
- Greater safety and accessibility for pedestrians and all road users
- Support for economic growth and sustainable development
- Environmental benefits through modernized infrastructure and electric bus integration

The new loop ramp will also allow for the removal of the Pond Lily Avenue on-ramp currently being used to access Route 15 northbound and will eliminate a left turn movement on Route 69 currently used to access Route 15 northbound. Pond Lily Avenue will now allow both left turns and right turns at its intersection with Route 69.

The in-vessel unit will be solar powered. HRRA believes that municipalities can create a closed-loop sustainable composting system to manage food waste locally, reducing the carbon footprint of offsite disposal and contributing to the waste diversion goals of the state. On behalf of Kent, the HRRA is currently in discussions to expand collection with neighboring adjacent, non-HRRA member communities to bring their material for processing therefore expanding the municipalities being served beyond HRRA. In addition, food scraps collected from the satellite metroSTOR containers in the Northern HRRA region will be transported to the Kent transfer station, rather than trucking to more distant processing facilities. This infrastructure will improve, expand, and provide waste reduction for organics management services to this part of the region and beyond. In addition, this will significantly reduce the carbon footprint of food scraps collection and reduce the operating cost to the Town.

The facility will be sized to process food scraps from the municipal collection program as well as other municipal, institutional, residential, retail, wholesale, and commercial sources; it is anticipated that this facility will serve as a regional food waste collection point for municipalities east of the Connecticut River. The Town also proposes the construction of an aerated static pile (ASP) composting facility to compost collected food wastes with leaves and mixed yard wastes. Presently, it is anticipated that the ASP facility could manage up to 2,000 tons per year of food waste but will also be expandable to manage future demand. Finally, the Town proposes the procurement and installation of new equipment to collect and process (i.e., bale) residential plastic film collected at the municipal transfer station as well as from other municipalities in the region.

Record of Decision for Building a Regional Composting Facility for Southeastern Connecticut

Address of Possible Project Location: 132 Military Highway (Route 12), Preston, CT 06365

Municipality where proposed action is to be located: Preston, CT

Project Description: Utilizing a grant award from the State of Connecticut Department of Energy and Environmental Protection (DEEP) through its MMI Grant Program, the Southeastern Connecticut Regional Resources Recovery Authority (SCRRRA) proposes to construct and operate the first large-scale aerobic food waste composting facility in southeastern Connecticut, fulfilling an infrastructure need in an historically underserved region. The facility will utilize an innovative hybrid compost system, combining aerated static pile (ASP) processing with open windrows for curing, resulting in quicker composting times and reduced operational costs. The facility will be situated on approximately six acres of land owned by the Authority at 132 Military Highway (Route 12) in the town of Preston. It is anticipated that the volume of source-separated organics diverted will be approximately 5,500 tons per year, and the anticipated volume of wood waste diverted will be approximately 8,500 tons per year.

Local zoning approval for the facility has been acquired, and the required state-level solid waste permit application is currently under review by DEEP. A robust environmental justice public participation plan has also been developed and approved by DEEP, in consideration of Preston's status as a distressed municipality.
