7. Firefighter Near Miss Report of the Week

Firearm Pulled on Paramedics During Assessment

SUMMARY

Two paramedics were called to a residence by the patient's wife. While they were assessing the patient he told them he did not need an ambulance and he did not want them in his house. He pulled out a handgun to convince them to leave.

EVENT DESCRIPTION

When the ambulance arrived on the scene, a female was standing in the driveway stating that she had called for her husband and he was inside the home. Prior to entering the residence, dispatch informed the paramedics that they had dispatched law enforcement to respond as well. The paramedics entered the residence and made contact with the patient. He was intoxicated and agitated. He stated he did not want the ambulance and he did not want the paramedics in his residence. One of the paramedic's attempted to talk with the patient while his partner stepped into the garage and contacted dispatch to check the estimated time of arrival of law enforcement.

Shortly after this radio transmission the patient reached below his desk and pulled out a large caliber handgun. The paramedics immediately exited the house, convinced the wife to get into the ambulance with them and drove a few houses down the road and waited for law enforcement to arrive. Dispatch was informed that the patient had just pulled a gun out on them. When law enforcement arrived, the patient had exited the residence, still carrying the pistol. Law enforcement had a short standoff and the patient eventually dropped the gun and surrendered himself to the police.

TAKE-AWAYS

Every day in the news we hear about violence committed against individuals. Attacks against law enforcement are on the rise. Fire and EMS personnel are also becoming more frequent targets. It is imperative that we maintain situational awareness on even the most routine and mundane call to ensure the highest degree of safety for crews and our ourselves.

DISCUSSION

- How can your dispatch center alert you enroute to a potential violent incident? Is there a way to view the previous history at that address to see if there were past problems?
- When approaching a suspect location, what is your agency's policy concerning law enforcement notification? Do you stage until the scene is cleared by law enforcement?
- Does your department provide any personal protective gear for potentially violent scenes, and if so, what is your policy for its use?
- Are you able to dedicate one of your members on scene to stand back and maintain situational awareness and overall scene safety? Is everyone on scene empowered to function as a safety officer?

LEADING PRACTICES

We must resist the tendency to become complacent on "Low Risk-High Frequency" "routine" incidents in order to maintain a constant state of vigilance. When looking at risk management models we quickly realize threats against first responders fall into the "High Risk-Low Frequency category, in many cases without the luxury of extended time.

All personnel who find themselves in a threatening situation must maintain a heightened degree of vigilance and work as a team to watch one another's back. Everyone must be comfortable in the role of scene safety officer.

The time to develop relationships with law enforcement is prior to finding ourselves in a compromised position. We should discuss their roles and expectations, as well as our own, so that when situations deteriorate we know how to react. For example, due to an increase in active shooter incidents, we should take the opportunity to train and drill with our local law enforcement whenever possible.
