2. Passing of Earl "Chuck" Glenney

Earl "Chuck" Glenney passed away. He sold fire apparatus all over the state and was well known and loved by many chiefs and departments. Here is his obituary and information on services.

Calling hours will be from 5-8pm, Thursday, November 17th at Center Congregational Church, 11 Center St., Manchester, CT. A memorial service will be held at 10am, Friday, November 18th at the same location. Final burial will be at the discretion of the family. Earl S. Glenney, known to most people as "Chuck", died on November 11th due to complications from a stroke. Chuck was born at Manchester Memorial Hospital to Lillian (Woods) and Earl J Glenney on December 8, 1939. Chuck grew up in Manchester, CT and graduated from Manchester High ('57). His summers were spent at Point O'Woods on the Connecticut shoreline. He was a graduate from the University of Hartford ('61) and attended New York University Graduate School.

Chuck worked as an accountant for Texaco and Harold Hahn Toy Co. (a division of Stop & Shop) prior to starting his own business Connecticut Fire & Safety and later Connecticut Fire Apparatus. Chuck was one of the first seven dealers for fire truck manufacturer, Emergency One (E-One).

Chuck was an acclaimed soccer and baseball player. He was inducted into the University of Hartford Athletic Hall of Fame for Soccer Excellence in 1994. Later in life, his love of sports was evident in his love for the Boston Red Sox, the University of Hartford basketball teams, and all things soccer.

Although Chuck most currently resided in Avon, he spent most of his adult life in Durham, CT. He was predeceased by his wife Linda (Carlson). He is survived by his daughter, Dawn (Glenney) Adams, her husband, George, and their children, Caelyn and Jacob; his son, Scott Glenney, his wife, Kim and her son, Adam; and his sister, Constance Wisse.
