1. IMT-EOC Interface

The purpose of this course is to delineate the roles and responsibilities between the IMT and EOC. There're many examples when these roles are crossed, or blurred between command and control /communication and coordination.

Many communities across New England, have emergency response personnel who are dual hatted. Having the depth and capacity to staff an EOC is difficult at best in some circumstances. Many IMT's have morphed into the role of staffing an EOC during emergencies.

Integrated into the course discussion will be the utilization of the CT. Regional Coordination Centers and the State Emergency Operations Center.

Students will work through activities and exercises that will define the strengths and areas that can be improved in today's emergency response to incidents.

2. Firefighter Near Miss Report of the Week

Responders Almost Collide

SUMMARY

When we respond to an emergency incident, other resources are often responding to the same address. How often do we watch out for each other instead of for just the general public?

EVENT DESCRIPTION

A municipal ALS-equipped engine and a third-service county ALS ambulance were dispatched by the same dispatch, on the same radio channel, to a local park for a trauma patient.

While en route less than two miles from our station, we approached a heavy traffic intersection, which is blind to the south side. On our approach, the signal-preemption system (which both the engine and ambulance are equipped with) was delayed in capturing the light. The driver of the engine began to reduce speed and decelerate toward the intersection.

As we approached the intersection, we captured the light with the signal-preemption system, giving us the green light, but the driver of the engine came to a complete stop at the intersection.

Just then the ambulance blew through the intersection, not stopping for the red light. We didn't hear or see this ambulance until they were in the intersection. Only because of the engine driver's situational awareness and intuition (gut feeling) did we come to a complete stop and avoid a collision.

TAKE-AWAYS

Structural fires, rescue assignments, EMS calls, police standbys and traffic accidents all require multiple emergency vehicles driving toward the same geographic location. Throw limited visibility in with stress and fatigue, and it can be a dangerous situation.

When you respond, make sure you're looking for other emergency vehicles as well as the motoring public. Many times, it can be difficult to hear another siren approaching you over the noise of your own audible warning devices. If you have more than one person in the apparatus, make sure you keep distractions to a minimum and have both people clearing intersections, not just the driver.

In some areas, racing to a call happens more often than we like to admit. Competition between companies and adjacent departments is natural, but it needs to be put aside on an emergency assignment. By the same token, if another company will end up being first due in your primary area, don't race to try to beat them.

DISCUSSION

- Are there intersections in your response area where you routinely encounter other responders on emergency calls? What is your plan?
- Is there a common radio frequency that could be used to increase situational awareness of each other and de-conflict to prevent an accident?
- Can you use a CAD terminal or other mapping solution to see the location of other responders to head off conflicts at intersections?

LEADING PRACTICES

We need to remember that if we don't arrive on scene, we're no help to the incident and will divert more

resources from the original call for service. Make sure you always look for fellow responders when approaching scenes and intersections. Departments can develop procedures to try to instill safe response practices, but it's up to us to make sure we remember that everyone needs to go home after every call.
