1. CFA Strategy & Tactics- Bread and Butter Calls

This two-day course takes the experienced fire fighter through the basics of fire ground decision-making. These are the "room and content", everyday calls that any fire department should be able to control with even limited resources. It teaches the student to formulate an overall strategy, and to then employ the appropriate tactics to support that strategy using time-tested models. In-class scenarios will take place throughout the course to give students opportunities to work a simulated fire incident.

2. CFA Building Construction - Combustible

This National Fire Academy course provides an introduction to basic construction principles and to the specific characteristics of combustible construction as it pertains to the fire service. The primary emphasis of this course is to improve the firefighter's ability to ensure personal safety by recognizing common causes and indicators of failure or other hazards related to building construction. An understanding of the course material, will improve operational effectiveness, as the firefighter will be able to better predict the overall reaction of a building to fire conditions. Participants will receive a Connecticut Fire Academy and National Fire Academy certificate of attendance

3. IMT-EOC Interface

The purpose of this course is to delineate the roles and responsibilities between the IMT and EOC. There're many examples when these roles are crossed, or blurred between command and control /communication and coordination.

Many communities across New England, have emergency response personnel who are dual hatted. Having the depth and capacity to staff an EOC is difficult at best in some circumstances. Many IMT's have morphed into the role of staffing an EOC during emergencies.

Integrated into the course discussion will be the utilization of the CT. Regional Coordination Centers and the State Emergency Operations Center.

Students will work through activities and exercises that will define the strengths and areas that can be improved in today's emergency response to incidents.

4. Voluntary Recall Notice Announced on Medical Device Commonly Used to Deliver Overdose Reversal Medicine

Teleflex Medical has issued a voluntary recall of LMA MAD Intranasal Mucosal Atomization Device. This device is commonly used to deliver naloxone, a life-saving drug used in the event of a suspected drug overdose. The device is also used to administer medication for life-threatening hypoglycemia and epileptic seizures.

The affected devices may not deliver a fully atomized plume of medication and, as a result, possibly impair the efficacy of the product when used in emergency overdose situations. It should be noted that this is a delivery device issue, and not a problem with the drugs that are being administered.

The Department of Consumer Protection, the Department of Public Health, Office of Emergency Medical Services (OEMS) are aware of the recall, and working together to determine if any of the affected products are in circulation with our emergency responders.

This recall may result in a shortage of Naloxone to some basic life support Emergency Medical Services (EMS) organizations. This recall will not affect paramedic level organizations. All patients will continue to receive appropriate pre-hospital emergency medical care in accordance with accepted standards of care. In Connecticut, naloxone is available to customers through certified pharmacists at over 300 participating pharmacies across the state. In addition to certified pharmacists, Connecticut law allows other prescribers, including physicians, surgeons, Physician Assistants (PAs), Advanced Practice Registered Nurses (APRNs), and dentists to prescribe, dispense and/or administer the medication.
