#### 8. Firefighter Near Miss Report of the Week

#### **Aggressive Training Leads to Injury**

#### **SUMMARY**

In this report, an aggressive Denver drill scenario leads to a significant injury to a firefighter. Can training scenarios be too aggressive or competitive?

#### **EVENT DESCRIPTION**

Our training officer decided to perform the Denver drill as a multi-company drill one day. It was also decided to use a live victim for the event. The event was timed for all shifts and each team of people.

Most of the evolution had gone OK, but there were signs that potential injury could occur. I myself had nearly been choked out and my neck nearly twisted past 90 degrees while being the window guy for the lift.

One member of linebacker build and size decided to load the victim on his back: he would press him up on his back and they could pull him out the window. Once up, the guy pushing from behind and the guy in the window became very aggressive with their attempt to remove the victim, and the lifting firefighter received a broken neck and broken back. His head and neck were driven into the wall and corner as the victim was caught on his gear.

His calls to hold on and slow down were not heard due to the confined area, the wearing of SCBA and the amount of noise being produce in trying to move the victim.

#### **TAKE-AWAYS**

When you turn firefighters loose at a hands-on training session, things can get competitive. It's in our nature to work at an aggressive pace, and this can be exacerbated by attempts to make training more competitive or realistic.

When planning a training it's important to balance realism and safety. We can make a training evolution difficult and push firefighters skill levels while still maintaining a margin of safety. This is important, as we need to add in a level of stress while still allowing firefighters to practice skills in a crawl-walk-run progression. This ensures people are learning and not just being tested.

#### **DISCUSSION**

- How do you design a training evolution that balances realism and safety?
- What are the most dangerous evolutions your department trains on? Can you make them safer?
- Is it necessary to push firefighters to the limit to prove they can perform a skill?

#### LEADING PRACTICES

Maintaining a level of realism is important when planning a training. Training evolutions that mimic a real situation will help firefighters react correctly when faced with a stressful situation. These training situations are for firefighters who have mastered a skill and are ready to apply it in a real-world scenario. It allows a firefighter to integrate that skill and the stress of the situation and to become more efficient.

Too often, this type of training is used when teaching a skill. This combined with firefighters whose skill sets are still lacking can be a disaster waiting to happen. The firefighters find themselves trying to apply a skill set they're not proficient at in a stressful situation, possibly without a margin of safety.

There is sometimes a desire to remove safety nets, such as taglines, because of a perception that they make the training less realistic and they wouldn't be present in a real situation. The difference is that in a training environment we owe people a greater level of safety as we have control over the situation; in these situations, we aren't risking ourselves to save someone. This is true for all types of training evolutions, including livefire training.

Make sure firefighters have the opportunity to learn the skill in a progressive fashion. When they've reached a high level of precision, then apply it in a realistic situation with some added stress. This will result in a great learning opportunity, not a test that everyone is destined to fail.

Dear Litchfield County and neighboring firefighters;

The rebuilding of the Burrville Fire School is slated to start in the early spring of 2017. The contract for the design/build team has been awarded to PDS Engineering out of Bloomfield. We are meeting with them on a weekly basis to finalize the design. We plan on presenting the final plans and discussing the future of the fire school at the February meeting of the Litchfield County Fire Chiefs Emergency Plan, Inc. The state recently demolished the old facility. Until the new facility is complete we will be running courses at local host departments.

The class schedules are set the spring of 2017. The fire school will be running a Firefighter I course at the Goshen Fire Station and an Exterior Firefighter at the Woodbury Fire Station. This summer we plan on running a Firefighter I and II course that is designed for college students. The spring Firefighter I certification course will be run on Tuesday and Thursday evenings and some weekends. The course will include certification at the Hazardous Materials Awareness and Operational levels. The cost is \$1,050 which includes all exam fees, student textbook, and student workbook. The application deadline for Firefighter I is February 8, 2017. The course fee will increase to \$1,155 after the deadline. The course schedule is attached.

The Exterior Firefighter course will be running on Tuesday nights and some Saturdays. The cost is \$250. The application deadline for Exterior Firefighter is March 3, 2017. The course fee will increase to \$275 after the deadline. The course schedule is attached.

On behalf of the school committee and the staff of the Burrville State Fire School I would like to take this opportunity to wish everyone a Merry Christmas and a Safe, Healthy and Happy New Year.
