1. Passing of SWFD Ret' Chief William Lanning

It is with profound sadness that we announce the passing of retired Chief William R. LANNING. Chief Lanning passed away February 20th at the age of 80. Chief Lanning served over FIFTY (50) years with the South Windsor Fire Department; Joining in 1962, promoted to Lieutenant March 1965 assigned to Company 3, promoted to Captain December 1966 assigned to Company 3, transferred as Captain February 1967 to the Ladder Company, promoted to Deputy Chief October 1968, prompted to Assistant Chief January 1987 and then Chief of Department July 1987 which he served for fifteen (15) years. Following his retirement as Chief, he remained an active member with Company 6 till his retirement from the Department in 2012 – serving over 50 Years!

Chief Lanning also served as a part-time, then Full-time Fire Marshal for the Town of South Windsor from 1972 till 2006 some thirty plus (30++) years as the Fire Marshal. All those years, he wore both hats very proudly as he loved the Department and the Community.

He leaves behind a large, loving and proud family. His wife, Pat and family honored the FD to be part of the planning process for the services.

3. Employment Opportunity – Fire Chief – Town of Salisbury (MA)

The Town of Salisbury, MA is accepting applications from highly qualified individuals for the position of Fire Chief. The salary range is \$95,000 to \$110,000. The Salisbury Fire Department is a progressive and highly skilled, service-oriented career, part-time and call agency located on the North Shore of Massachusetts along the New Hampshire border. The Department provides fire and rescue services to this community on the Atlantic Ocean coast with a year-round population of approximately 8,300 and summer population of approximately 15,000, occupying almost 18 square miles. This is a working position where the Fire Chief responds to all working fires and several others calls for service, given the small size of the Department, which has 9 full-time personnel, 11 part-time (24 to 28 hours per week) personnel and 12 call personnel. The Fire Department operates out of one Headquarters building and has an operating budget for FY 2017 of \$1.44 million. All members of the Fire Department, with the exception of the Fire Chief, are members of the same collective bargaining unit. In 2016, the Salisbury Fire Department responded to 2,039 calls for service, a majority of which were medical.

Candidates for this position must have at least five years of progressively responsible experience in a management position (officer level) in a full-time or combination municipal fire department of similar size

and composition and have a Bachelor's Degree (Master's Degree preferred) in fire service administration, public administration or a closely related field, supplemented by substantial management training such as that provided by the National Fire Academy's Executive Fire Officer Program or the equivalent. The successful candidate will be highly skilled in labor relations, must have successfully managed within a collective-bargaining environment, have excellent written and oral communication skills, be able to successfully manage people, have good human-relations skills, be adept at budgeting and community relations, and be a proven leader and visionary in the fire service.

7. Firefighter Near Miss Report of the Week

Firefighter Falls During VEIS Training

SUMMARY

During a training scenario, rescue from a second-story window resulted in a firefighter falling from a ground ladder. Several reasons are listed as contributing factors. Injuries that occur during training may reveal more about us than we think.

EVENT DESCRIPTION

During a scheduled training evolution, a firefighter had to rescue a live victim from a division-two window. Using a 24-foot extension ladder, the firefighter had to lower the victim down the rungs to additional

rescuers waiting on the ground. During the descent, the victim was wearing a harness and fall protection was in place. As the pair descended, the firefighter performing the rescue fell about 10 feet to a concrete surface below.

TAKE AWAYS

This specific scenario had been accomplished earlier in the day with the exact same equipment set-up, but the rescued firefighter in this event was heavier than in the previous exercise. The factors contributing to this near miss include a lack of protection for the firefighter performing the rescue and inadequate training for this type of event before performing it at a height above a spotter's reach.

Additionally, the climbing angle of the ladder was reported to be too steep for the evolution and there were no clear departmental guidelines on how to perform the evolution.

Post-incident investigation revealed that the firefighter performing the rescue had no documentation identifying previous training in this type of rescue.

DISCUSSION TOPICS

- 1. What are the best angles for climbing and rescuing on a ground ladder? Discuss why the angle should be shallower for rescuing an unconscious victim.
- 2. Maintaining three points of contact with the ladder at all times is important for preventing a fall. Discuss the ways you would accomplish this task.
- 3. What are some techniques you would use to provide fall protection for both personnel in this drill?4. Completing a hazard analysis could have identified critical skills for this task and formalized the necessary training steps needed to accomplish it. Does your department have formalized training tasks to teach firefighting skills? Which skills have written steps?
- 5. What are some important factors you address when teaching a skill?

LEADING PRACTICES

One recommendation from this report was to have a designated safety officer present during this type of activity. Before the drill began, a safety risk assessment would have identified the necessary skills and steps before attempting a full-scale evolution.

The training documentation for the rescue firefighter was incomplete and didn't identify previous skill training. Utilizing a safety officer may have given the training staff additional resources for course development and accountability for previous employee training.

The goal of training should be to learn new skills. In most cases, this begins with a slower pace, systematic instruction and an overabundance of safety practices in place. These are the lessons that were learned from this near miss. Reducing hazards during instruction lets students focus on task assimilation and encourages safe practices in the field.

Stressing safe practices throughout each drill will reinforce the department's view of what's needed to prevent injuries or worse. It's easy to confuse skill training with skill evaluation. Firefighters' skills should never be evaluated before they're thoroughly trained using the safest techniques. Learning skills while reinforcing safe techniques can help create a culture of safety in our fire service.


