### 6. Rescue Technician – Trench Rocky Hill

August 5, 6, 12, 13, 19, and 20 with Practical Exam on the 27<sup>th</sup>.

This program will train the students to perform technician level trench rescue. The training objectives meet NFPA 1006 and OSHA 1926. Students will evaluate trenches and soil conditions; will learn to shore unprotected straight and intersecting trenches with both community and pneumatic shoring. They will also use supplemental shoring when needed. Students develop an action plan to manage and remove a victim from a trench accident. The PPE requirements are a protective helmet, footwear, gloves, eye protection, and work clothes. Training prerequisites: Rescue Technician Core and Hazardous Materials Operational; proof must be submitted with the application. Certification Examination Prerequisite: Rescue Technician Core and a minimum of EMR certification; proof must be submitted with the application to this level, an additional practical skills examination of one or two days plus a written test is required. Certification testing time: requires additional dates for certification written and practical exam. Class Hours: 48

## NEW HAVEN REGIONAL FIRE TRAINING ACADEMY

Firefighter Tommy Kelly was 33 years old when he fell three stories into an air shaft at a structure fire at 1142 Chapel St on February 26th 1992. Tommy was the tiller man that night on Truck 4, Division 3. He was conducting vertical ventilation on the roof when he turned to retrieve a tool and stepped into the unprotected void. He was unconscious with his face under water until brother firefighters rescued him and was transported in grave condition to St. Raphael's Hospital. The next couple of weeks were touch and go for Tommy.

It has been 25 years since his accident and Tommy, being the fighter he has always been, has prevailed. He suffers from a traumatic brain injury and has battled every day since that night. His injuries, while tragic, serve to remind all of us in this business that life can change forever with one step.

On Saturday, July 15, 2017 at 10:00 a.m. Tommy's devotion and service to the NHFD will be celebrated with the dedication of his tiller bucket that sits outside the main entrance of the New Haven Fire Regional Training Academy, 230 Ella T. Grasso Boulevard, New Haven.

Kelly is a member of Safe Kids Harnett County and recently joined the SKNC Steering Committee. Before joining NFPA staff in 2015, she worked as the Deputy Director of the North Carolina Department of Insurance- Office of State Fire Marshal overseeing the Prevention, Programs and Grants Division for nearly 15 years. In addition, she worked as the State Director of Safe Kids North Carolina which includes 42 coalitions covering 72 counties for 11 years.

Chief Baldwin has been with the Fire Department at Southbury Training School with DDS since 1998 and Fire Chief since 2006. He provides oversight as well as performs day to day functions for many of the fire safety initiatives and problem solving at DDS. He was instrumental in coordinating the standardized fire safety training that was developed through grant funding in collaboration with the Ct Fire Academy.
