7. Firefighter Near Miss Report of the Week

Engine Moved with Personnel Standing on Hose Bed

Summary

During a training evolution, a driver/operator moved an engine without doing a 360 precheck. Another member was standing on top of the hose bed and could have been seriously injured.

Event Description

We had performed a simulated direct-attack pump-and-roll operation and had brought the apparatus to stop so that members could move the attack hose to the other side of the engine. In this instance, this transition involved a member climbing to the top of the truck to facilitate the transfer. This isn't always the practice, and at times the transfer is completed without sending a member to the top.

Once the line had been moved to the opposite side of the apparatus, the drill was reinitiated and the operator began a slow pump-and-roll operation. When the situation was recognized, a "stop safety" was communicated to the driver and the vehicle was quickly brought to a stop.

The crew gathered immediately after the incident to discuss what had occurred and review the lessons learned before continuing with the remainder of the evolution. This event was shared with subsequent companies who performed the evolution in an effort to immediately apply what we had learned and avoid a similar mistake.

Take-Aways

Any time a vehicle is moved, the operator should do a quick 360 precheck to ensure it's safe to proceed. A quick lap around the rig should be sufficient to ensure all compartments are shut and equipment is secured.

Once the operator climbs into his seat, shuts the door and fastens his seatbelt, he must also confirm that all other passengers have done the same. Passengers must also be alert and help the driver by communicating any hazards they notice. No matter what the emergency, this must be done every time, before moving the vehicle.

Discussion

- What policies does your organization have regarding safe driving practices?
- How many of these policies are a result of mistakes someone made in the past?
- Is seatbelt use required in your department, and if not, why?
- What accidents are you aware of within your department that could have been avoided with a quick 360 before proceeding?

Leading Practices

Anyone who has been in the fire service for any period of time can cite accidents that have occurred while moving an apparatus. Many can also cite the subsequent policy that was developed to prevent a similar occurrence!

Every day, station and apparatus doors are torn off, vehicles damaged and personnel injured as a result of not taking a few extra seconds to make sure everything and everyone is secured.

Seat belts are not an option! Everyone on the apparatus is responsible to be vigilant for hazardous conditions. Safe driving practices begin before the ignition is turned on and the vehicle is placed in gear and must continue until safe return to the station.


