We are proud to serve as your host for this year's conference which will be held in Hartford, CT September 9 – 11, 2010. The host hotel for this event will be the Marriott Hartford Downtown, a AAA - 4 Diamond hotel. This facility overlooks the Connecticut River and is interconnected with the Connecticut Convention Center and Connecticut Science Center.

Hartford is the capital city of Connecticut and is located on the Connecticut River in the north central part of the state. Nicknamed the "Insurance Capital of the World", Hartford houses many of the world's insurance company headquarters, and insurance remains the region's major industry. Almost 400 years old, Hartford is among the oldest cities in the United States. In 1868, Mark Twain exclaimed: "Of all the beautiful towns it has been my fortune to see, Hartford is the chief".

For those planning to travel by air the closest airport is Bradley International Airport (BDL) Hartford / Springfield. We will provide complimentary shuttle service from the airport to the hotel. As an option, Amtrak provides direct rail service to Hartford. Also, for those driving, free valet parking will be provided at the hotel during your stay!
