



Directions to the CT Fire Academy, 34 Perimeter Road Windsor Locks, CT:

I 91 North or South to Exit 40 (Route 20, Bradley Connector). Follow Route 20 West 1.7 miles to the exit for Route 75. Take a Right off the exit onto Route 75 North and follow 2.5 miles. Take a Left onto Perimeter Road (see sign for the CT Fire Academy and the New England Air Museum). Continue 1.4 miles to the Academy, which will be on your Right. Parking is available in the rear of the building.

DIRECTIONS

FROM THE NORTH:

Interstate 91 South to "Exit 22N CT N to New Britain" and travel Southwest for 0.5 miles. Continue on CT 9 and go West for 2.6 miles, bear Right on ramp at sign reading "Exit 22 to New Haven and US 5 S, CT 15 S" and go North for 900 feet. Turn Right on Frontage Road and go South for 600 feet, turn Right on Worthington Ridge and go underneath the highway and turn Left onto US 5 S, CT 5 S for 4.0 miles. The CPAT Center is on the Right hand side at the traffic light.

FROM THE SOUTH:

Interstate 191 North towards Hartford. Go Northeast for 18 miles. Bear Right on ramp at sign reading "Exit 17 CT 15 N to Berlin Turnpike and CT 166 / I 1691" and go North for 0.2 miles, continue on CT 15 N and go North for 3.8 miles, turn Left at traffic light and go Northwest for 500 feet.

AERIAL OPERATOR

This six day course meets NFPA 1002 for the driver/operator section which addresses aerial devices. Instruction will be given on: aerial; tower ladders and articulating booms. Course content will prepare the student for the practical and written examinations for Aerial Operator certification.

This course is designed for the driver/operator of aerial equipment. The course begins with road handling and moves on to apparatus placement; mobilization and stabilization; elevation; various aerial operations and apparatus readiness.

Full protective clothing (no SCBA) is required.

This two □day course will cover in detail, the responsibilities of the Aerial Operator and will also explore some of the options available to the Aerial Operator in both emergency and non □ emergency situations. Topics covered include: apparatus placement; stabilization practices; elevation and aerial safety. The second day of this course will include "hands □ on" exercises.

BASIC PUMP OPERATIONS

This basic one day program examines the components and controls in the operation of a fire pump. The internal parts of a fire pump are examined with the goal of having the student fully understand how the fire pump moves water. Pump panel controls are discussed in relation to the specific function and use of each device. The process and specific functions involved in drafting and hydrant operations are explained in detail. The afternoon will be spent having students set up for pumping operations.

PUMP OPERATOR

This six day course is designed to prepare the student for the practical skills and written examinations for Pump Operator certification.

Class work will include: safe driving techniques; preventive maintenance; pump operations; hydraulic calculations; water supply and apparatus systems.

The course begins inside the classroom and ends outside with pumping apparatus. The main emphasis is on "hands□on" exercises using various types of pumps, hose sizes and nozzles.

EMT REFRESHER

This three day course is designed to review and refresh knowledge and skills required for Emergency Medical Technicians who are currently certified according to the latest U.S. DOT EMT Basic National Standard Curriculum. Classroom and "hands on" training will update the EMT on current practices and confirm skill levels. A review and renewal of Healthcare Provider CPR will be conducted in conformance with the latest JAMA standards through an approved program of the American Heart Association.

Refresher topics include: well being of the EMT; airway management; ventilation and oxygen therapy; patient assessment; medical trauma; general pharmacology interventions; altered mental status; automated external defibrillation; infants and children; emergency childbirth; normal and abnormal deliveries; post delivery care; body substance isolation (BSI) and M.A.S.T.

Practical laboratory sessions will include bleeding control and bandaging/splinting. Comfortable clothing is suggested for these sessions.

Additional topics include: Haz Mat recognition; personal protection; patient handling/moving techniques; environmental injuries and the legal, ethical and psychological aspects of EMS.

Written and Practical examinations will be conducted in conformance with the policies established by the State of Connecticut Department of Public Health.

CO EMERGENCIES/CHIMNEY FIRES

The first half of this course will cover the information needed by a fire department when responding to carbon monoxide alarms and to carbon monoxide present at the fire scene.

Topics include: the identification and hazards of carbon monoxide; a description of the techniques for investigating alarms and detecting the presence of this odorless, tasteless gas.

The second half of this course is designed to instruct the proper procedures to be used at a chimney fire. This simple routine fire can become a disaster if not handled properly from the start. The "reading" of a chimney before a fire occurs will be covered in detail.

Topics covered include: construction of chimneys; why fires start; extinguishment; inspection after the fire and firefighter safety.

FIREFIGHTER SAFETY AND SURVIVAL

This is an intensive two □day course on firefighter survival training. Using scenarios based on real □life incidents, this course identifies problems that were encountered and offers possible solutions for the safe and efficient removal of members in distress. Safely removing trapped firefighters from a building is a labor □ intensive operation.

Subjects covered include: self rescue procedures such as low profile ladder egress and personal bail out procedures giving the participant options if caught in a rapidly deteriorating situation.

INTRODUCTION TO THE FIRE SERVICE

This five □day program will focus on introducing ages 14 □ 17 youths to the fire service. This program will be held in a "camp" type atmosphere simulating a firehouse environment. RAPID INTERVENTION TEAMS (RIT)

This is an intensive course on fire behavior and firefighter survival training. Using scenarios based on real life incidents, this class identifies problems that were encountered and offers possible solutions for the safe and efficient removal of members in distress. Safely removing a trapped or unconscious firefighter from a burning building is a labor intensive operation. Methods of searching for a missing firefighter in a large open area will be covered and the participant will be able to conduct this type of search. Additionally self rescue procedures such as low profile ladder egress; team search and personal rope bail out procedures, giving the participant options if caught in a deteriorating situation, will be provided.

Full protective clothing, including SCBA with one spare cylinder, is required.

RECRUIT FIREFIGHTER

This ten week course will focus on developing the skills needed for a recruit firefighter to perform entry level tasks.

One of the first components of the course will be to establish in the recruit a strong desire and will for self discipline; teamwork; company morale; orderliness and precision.

The fire department organizational structure will be defined showing the role and responsibility of the firefighter and officer in the organization.

The training for a recruit firefighter will consist of theory, backed with appropriate skills development which follow as closely as possible to the new information being presented. The theory and practical skills development combination will be addressed on an incremental basis for maximum retention and skill development. This approach will provide competency in the recruit and reduce the risk of injury.

At the conclusion of this course, the recruit firefighter will be tested to the Firefighter II level and will return to his/her fire department. After local orientation, the firefighter will be able to be assigned to a firefighting company.

The course also includes: Hazardous Materials – First Responder Awareness and Operational; Physical Fitness; Confined Space Rescue; Medical Response Technician – Defibrillator (MRT□D); High Angle Rescue; ICS; Night Firefighting and all applicable OSHA standards.

BUILDING CONSTRUCTION: COMBUSTIBLE

The candidate physical ability test (CPAT) consists of eight separate events. The CPAT is a sequence of events requiring you to progress along a predetermined path from event to event in a continuous manner. This test was developed to allow fire departments to obtain pools of trainable candidates who are physically able to perform essential job tasks at fire scenes.

This is a pass/fail test based on a validated maximum total time of 10 minutes and 20 seconds.

In these events you wear a 50 pound vest to simulate the weight of self contained breathing apparatus (SCBA) and firefighter protective clothing. An additional 25 pounds, using two 12.5 pound weights that simulate a high rise pack (hose bundle), is added to your shoulders for the stair climb event only.

Throughout all events, you must wear long pants, a provided hard hat with chin strap, provided work gloves and footwear with no open heel or toe. Watches and loose or restrictive jewelry are not permitted.

All props were designed to obtain the necessary information regarding your physical ability. The tools and equipment were chosen to provide the highest level of consistency, safety and validity in measuring your physical abilities. A schematic drawing of the CPAT is included in the orientation material. The events and distances between events are always the same.

The events are placed in a sequence that best simulates fire scene events while allowing an 85 foot walk between events. To ensure the highest level of safety and to prevent exhaustion, no running is allowed between events. This walk intentionally allows you approximately 20 seconds to recover and regroup before each event.




