### MONDAY JUNE 7

#### Q Endorsement – Train the Trainer

The Connecticut Fire Academy is again offering a Train the Trainer for the Q Endorsement program. This Train the Trainer class will allow compliance with Public Act 13-271, which states: A license of any class that contains the designation "Q" indicates eligibility to operate fire apparatus. A "Q" endorsement shall signify that the holder has been trained to operate fire apparatus in accordance with standards established by the Commission on Fire Prevention and Control. No such endorsement shall be issued to any person until he or she demonstrates personally to the commissioner, or the commissioner's designee, including the Connecticut Fire Academy, any regional fire school or the chief local fire official of any municipality as defined in section 7-323j, by means of testing in a representative vehicle that such person possesses the skills necessary for operation of fire apparatus.

#### Fire Behavior and Flashover Survival

Flashover Survival begins with a classroom presentation followed by a simulation of a pending flashover in the Connecticut Fire Academy flashover simulator. The flashover simulator offers firefighters the opportunity to observe fire behavior and the signs of an impending flashover in a controlled setting. This training is an experience of a lifetime that could save your life. Students should bring a bottle of water or sport drink to re-hydrate throughout the training.

Participants are required to bring full protective clothing, including SCBA with one spare cylinder. **Long pants are required to participate in the flashover live burns. Shorts alone are not acceptable.** The Connecticut Fire Academy will not be responsible for damages to PPE.

Training Prerequisites: Certified Firefighter I; proof must be submitted with the application.

A separate flashover permission slip is required at the time of registration.

### **Company Officer: Back to the Basics**

This course is for future, newly promoted, and/or experienced officers. Line officers have many responsibilities that must be addressed during a tactical emergency. There are many tasks that officers must complete, from prior to an alarm, all the way through terminating an incident. This course will concentrate on the 12 step process that all officers must accomplish to successfully mitigate any tactical emergency by properly determining incident goals and the tasks necessary to achieve them. This program will delve into the importance of a proper size up, initial radio reports, strategy and tactics, and more for all emergencies. Students will benefit from the open discussions and scenarios conducted by Lt Jason Balletto (NHFD) and Capt. Chris Parker (NHFD). Their experience and education will provide the students the ability to take the concepts and techniques discussed in this class and add another tool to their toolbox.

### **Fire Service Instructor III**

This course is designed to meet the third level of instructor as identified in NFPA 1041. Topics include administration, records, policies, supervising instructors, analysis, evaluation and program development. This course is designed for Training Chiefs, and other positions who have responsibility for setting up overall Training programs in their departments.

The course is blended learning, with only one class meeting. Access to a computer with internet is mandatory to complete the course. After all class assignments are completed the student will be able to schedule a written certification exam with the certification division.

### SCOTT Air-Pack Field Maintenance

This one day program is designed to acquaint your personnel with field maintenance of SCOTT Safety SCBA's. Major emphasis is placed upon student participation in a series of hands-on exercises under the supervision of a Scott Health and Safety technician. Topics will include inspecting, cleaning, disinfecting, parts replacement and trouble shooting. This class will not cover the NxG2 SCBA.

Participants will be required to bring their own Scott SCBA. In order for the student to perform field maintenance on their Scott SCBA, there is an extensive necessary tool list. The complete list of the necessary hand tools will be mailed with your class confirmation prior to the date of the class. For this class it is advisable to have the general hand tools, pin punches and lightweight hammer from the list available for the class.

### Forcible Entry

This dynamic program, taught by retired Captain Robert Morris of Rescue 1 FDNY, and Asst. Chief of Stamford FD, consists of both a classroom session and hands-on scenarios. The classroom covers the types of doors and lock hardware that the firefighter is likely to encounter, how to size up the forcible entry situation, and how best to attack the lock. Methods range from the standard method of using a set of irons to through the lock techniques. After the classroom all students will get their opportunity to practice forcing various locks utilizing the methods discussed in the classroom. Captain Morris has presented this program throughout the country. **This class will be held off-site from the Connecticut Fire Academy but is contingent on getting a building to use for the skills.**

This half day course will focus on coaching beyond just the physical training but how to recognize overtraining, refuel and rehydrate properly for optimal results to meet or exceed what it takes to pass the Candidate Physical Ability test. The CPAT is a requirement by nearly every career fire department in the state as part of the application process. The timed test can be difficult for some people to pass so this course was designed to showcase best practices by individuals who have passed the CPAT as well as possess a proven track record of successfully training others to pass.

## Basic Pump Operation

This course examines the components and controls used in the operation of a fire pump. The internal parts of a centrifugal fire pump are examined with the goal of having the student fully understand how the fire pump moves water. Pump panel controls are discussed in relation to the specific function and use of each device. The movement of water from draft, tank, and pressure source are explained in detail. Students will practice their pumping skills from tank, hydrant, and static source.

- Full protective clothing (No SCBA) is required.

### Freedom of Information and the Impact on First Responders

#### Public Education Officer Thomas Hennick

Connecticut's Freedom of Information Act guarantees all citizens the right to have access to public meetings and public documents.

The FOI Commission conducts workshops around the state helping citizens and officials understand their rights and their obligations under the FOI Act. The workshop will feature a review of the basics of the Freedom of Information Act. Some of the topics that are explored include:

- 1) The definitions of public records and meetings.
- 2) How to manage requests for public records.
- 3) What are the rules governing executive sessions?
- 4) Does the public have access to all meetings and documents?
- 5) Are e-mails and other electronic documents available to the public?
- 6) Does the public have a right to speak at public meetings?
- 7) Can an agency talk about business not listed on its meeting agenda?
- 8) Are investigative records subject to disclosure?
- 9) Can FOI requests be rejected because they are burdensome?
- 10) What is the process for filing a complaint with the FOIC?

The workshop will be conducted by Tom Hennick. Tom is the Public Education Officer at the Freedom of Information Commission. In that role, Tom travels around the state, conducting FOI seminars and workshops, educating members of the public as well as public officials about their rights and duties under the Act. Tom spends a great deal of time on the telephone answering questions about the Act raised by the general public.

Students are encouraged to bring any cameras and equipment their agency may already have to use for the day. Students will do filming and some editing to create real content as part of the class.

### **THURSDAY JUNE 10**

#### **First Net – Lessons Learned from Sandy Hook- NEW**

“Unfortunately, Tragedy Can Be a Tremendous Teacher.”

Colonel Stebbins will focus on how emergency communications did not meet the needs of the community at large and specifically those who were responding to the scene. The Emergency 911 system was overburdened with calls, which resulted in poor information exchange between callers and call takers. The presentation exposes limits in the capabilities of the 911 Emergency system as it stands today. The Sandy Hook School Mass Murder is the case study used to demonstrate how the limited system during extreme high use times is very prone to failing those who depend on it most, the emergency responders. Communications directly affect the ability of emergency responders to be effective in their approach to a crisis. FirstNet, a nationwide broadband public safety network that was created in response to the 911 Commission Report will be featured in this presentation as it could have made a difference at Sandy Hook School had it been available at that time.

This physically challenging two-day course was developed to raise the skills for the advanced SCBA user. This course will start with a brief classroom session and then move to the training ground where the emphasis will be on physical fitness and readiness. The Connecticut Fire Academy Mobile Training Maze will be used to increase the firefighter's skills and confidence in the use of SCBA.

Participants are required to bring full protective clothing, including SCBA and one spare cylinder. Students are also encouraged to bring a water bottle, exercise clothing and running shoes and/or sneakers. Students should also bring a large sports drink to assist with adequate hydration.

This two-day class is all “hands on” and uses “rescue playbook” format to achieve learning objectives.

The class has three objectives:

1. Review and application of the six-step process for setup of an Artificial High Directional (Rescue Tripod/Bipod/Monopod).
2. Instruction, implementation, and integration of Multi-use Rope Rescue devices (ex. MPD, Maestro, Clutch) in Twin Tension Rope Systems (TTRS).
3. Use of alternate methods of rope system construction when your Multi-use Rope Rescue Device becomes inoperable or is not available (or, my Multi-use device has fallen and can not get up).

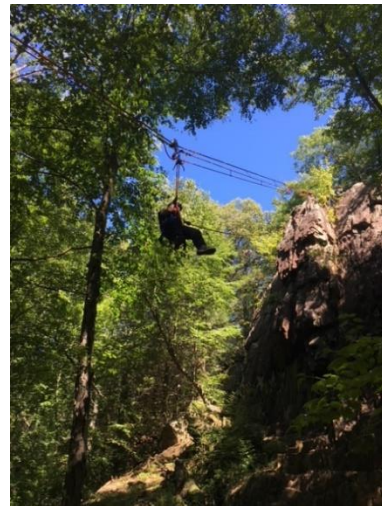

Topics covered in this class will include the many ways to use drones, how to get licensed to fly them, buying the right drone for your department, drone insurance options, running your program in a way that minimizes liability, and FAA regulations governing the pilot, the drone, and the mission. If the weather cooperates, you’ll also get to see real drones in action. Instructors are experienced FAA Certified sUAS pilots.

#### CIRMA Training 3 Sessions -(NEW)

CIRMA is partnering with CFA to offer some of their most popular 2 hour training sessions. The three sessions will run back-to-back but students can sign up for any or all of them. The three sessions are:

**Diversity:** This course will prepare fire officers for their role and responsibility as a leader in the Fire Service and understand diversity in the workplace and how one deal with it. This module will demonstrate how to identify and deal with such situations and the support tools available during your day-to-day operations.

**Root Cause Analysis:** Proper root cause analysis is critical in identifying, controlling, preventing, and mitigating accidents on the fire ground. Analyses need to be performed by trained employees who can maintain an open mind about the causes of an accident throughout the analysis. Additionally, we will explore the important differences in the way an analysis should be conducted when a member of the department as opposed to when a member of the public is involved.

**Defensive Driving:** The course will show the techniques of defensive driving and the regulations surrounding emergency vehicle operation. You will learn to spot the common types of driving errors, review the driving skills and techniques that help prevent collisions and violations, how to make safe and legal turns, how to evaluate and overcome the hazards of passing, and how to avoid a head-on collision. This training program teaches techniques that you can use to maintain control in adverse driving situations.

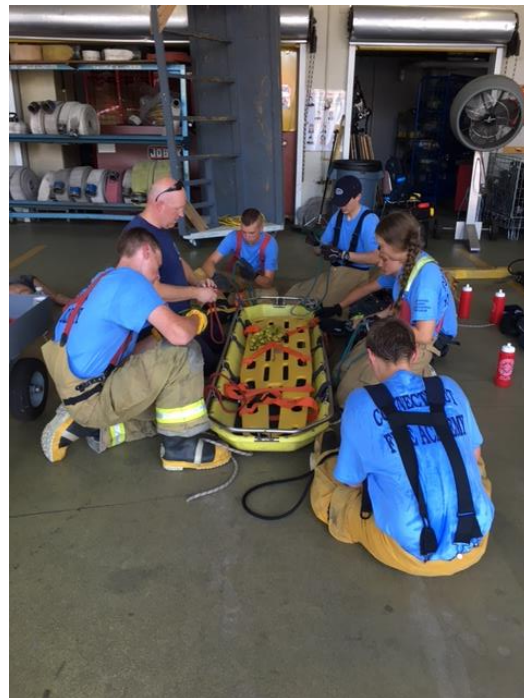
