# <u>I.</u> <u>Chairperson</u>: Gary H. Collins, Presiding

Chairman Collins convened the meeting at 2:00 p.m. He made opening remarks regarding the MLK Commission celebration on January 19, 2015 at which he was the keynote speaker. He stated, "It was an honor and a privilege to participate."

A motion was made by Commissioner Norton to add to the agenda the minutes from the January 14, 2015 regular meeting for review and approval; it was seconded by Commissioner Mambruno. The motion carried unanimously.

#### **II. Secretary:** Edward Mambruno

A motion was made by Commissioner Mambruno to approve the minutes from the January 26, telephonic meeting and the January 14, regular commission meeting minutes. It was seconded by Commissioner Norton. The motion carried unanimously.

#### III. Affirmative Action Recommendations – Vote Required

# 1. Department of Housing

The plan was presented by Alvin Bingham.

Representing the agency were Commissioner Evonne Klein, Dimple Desai,— EEO Designee, Cordula, EEO Designee, and Irena Baj-Wright, HR Specialist. The Affirmative Action plan of the Department of Housing was recommended for approval based on compliance with the following: it contained all elements required; the work force considered as a whole was not at parity with the relevant labor market; there were some calculation errors in half the categories. This was the first filing so there were no goals to meet. Therefore it was deemed in compliance

Commissioner Norton questioned why it was not recommended for a biennial filing. Valerie Kennedy responded that this was the Department of Housing's first filing and approval. After 6 months and another approval they can go to a biennial filing.

A motion was made by Commissioner Norton to accept the recommendation of approval for the Department of Housing and seconded by Commissioner Mambruno. The vote carried unanimously.

Alvin Bingham reported that the contract compliance unit will have trainings for new contractors coming in. A more detailed report will be given in March.

## 1. Request for Exemption:

Department of Mental Health and Addiction Services (DHMAS): Levanta LLC This exemption was presented by Attorney Alix Simonetti.

A motion was made to accept the recommendation for exemption by Commissioner Norton and seconded by Commissioner Mambruno. The vote carried unanimously.

#### V. <u>Division Reports:</u>

#### A. <u>Executive Director's Report</u> Director Tanya Hughes

The executive director reported that MLK Holiday event was successful and well attended by CHRO including Commissioners and staff. We must be mindful of the fact that we stand on the shoulders of unsung heroes, such as the father of Gary Collins whom he spoke of during his address at the MLK celebration.

The Production report showed some really good work done in the Regions even though the weather had some of the staffing down. Our aged inventory is at

an all-time low -4.6 %, whereas in July of 2013, CHRO was at an aged inventory of 12 %. Eastern Region, Jim Flynn, was almost at 50% aged inventory and now is at 6.9%. Welcome to Assistant Attorney General, Emily Melendez. She is taking the role of retired Assistant Attorney General, David Teed.
